## Report of Independent Auditors

## **1. Description of the Plan**

The following description of the Enterprise Rent-A-Car Retirement Savings Plan of Puerto Rico (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan’s provisions.

### ***General***

The Plan is a defined contribution plan covering all eligible employees of PRERAC, Inc. (“PRERAC” or the “Company”). The Company is a wholly-owned subsidiary of Enterprise Holdings, Inc. Enterprise Holdings, Inc. is a wholly-owned subsidiary of The Crawford Group, Inc. (the “Plan Sponsor”). The Plan’s assets are held by Banco Popular de Puerto Rico (“Banco Popular”), the trustee and record-keeper.

The Plan, established under the laws of Puerto Rico, is subject to certain provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). All PRERAC, Inc. employees are eligible to participate upon meeting the eligibility requirements of the Plan.

### ***Employee Participation/Contributions***

Employees of PRERAC are eligible to participate in the Plan on the first day of the month following one month (two months for 2023) of continuous service. Employees covered by the collective bargaining agreement are eligible to participate in the Plan on the first day of the month following one year of continuous service. Participation by eligible employees is voluntary. The total number of employees eligible to participate in the Plan was 241 and 217 at December 31, 2024, and 2023, respectively. Participants can contribute from 1% to 100% of their annual pay, including base salary or wages, overtime, bonuses, and commissions, up to the maximum amount set by the Puerto Rico Treasury Department (the “PR Treasury”). Investments in the Plan are all participant-directed.

Participants can elect to invest their contributions and the employer contributions among the available funds.

Contributions may be split between the available funds in multiples of 1%. Participants, at any time, may elect to reallocate all or any investment option. Any split between investment options must be in 1% increments, and the sum total must equal 100%.

All amounts contributed by employees are fully vested and are nonforfeitable at all times. A participant, age 50 or older, may make catch-up contributions to the Plan up to the annual Puerto Rico Treasury limit.

### ***Employer Matching Contributions***

The Company matches 100% of participants’ contributions, up to 4% (3% for 2023) of eligible compensation each pay period, subject to a maximum annual benefit per participant. For those employees covered by a collective bargaining agreement that allows participation in the Plan, the Company matching formula is based upon provisions contained in the collective bargaining agreement.

### ***Profit Sharing Contributions and Benefits***

In addition to the employer matching contributions, the Plan Sponsor may determine, at its sole discretion, that it will make a profit sharing contribution. Participants are eligible for profit sharing contributions on the first day of the month following one year of continuous service and must have at least 500 hours of service in the plan year in which the first anniversary occurs, or any subsequent year. Employees covered by a collective bargaining agreement are not eligible for profit sharing.

Although past contributions do not guarantee future funding, the Plan Sponsor has historically contributed 5% of the Company’s consolidated earnings before income tax for its most recent fiscal year ended July 31 or the maximum amounts deductible for U.S. federal income tax purposes towards retirement plan contributions. After the Company’s share of the Plan Sponsor’s retirement plan contribution is determined, the employer matching contributions and certain other plan expenses for that fiscal year will be deducted to arrive at the Company’s profit sharing contribution for that plan year.

## **1. Description of the Plan (continued)**

### ***Profit Sharing Contributions and Benefits (continued)***

Profit sharing contributions are allocated to participant accounts based on participants' eligible compensation to the extent the participant meets minimum service requirements and is employed as of the end of the plan year. Contributions are invested into the fund selection elected by the participant for their contributions.

### ***Vesting***

Vesting, as it relates to employer matching and profit-sharing contributions, is based on years of service, with a participant becoming fully vested after four years (six years in 2023) of service. Those participating are subject to a collective bargaining agreement and are immediately vested in Company matching contributions.

Participants terminating before fully vesting who choose to take a distribution (rather than leaving their balance in the Plan) forfeit the non-vested portion of their accounts. However, if a participant who was partially vested at the time of leaving the Company takes a distribution from the Plan and is rehired within five years, that person is reinstated, and the amount previously forfeited is restored provided the participant restores his/her previously vested balance back into the Plan. Participants terminating before fully vesting who opt to leave their balance in the Plan do not forfeit the non-vested portion of their accounts until a five-year break in service has occurred, at which point the forfeited amounts are allocated to remaining participants. Related to the plan years ended December 31, 2024 and 2023, non-vested balances forfeited and allocated to remaining participants totaled \$21,417 and \$52,183, respectively.

Profit sharing contributions and forfeited account balances are allocated to eligible participant accounts based only on participants' eligible compensation to the extent the participant meets minimum service requirements and is employed as of the end of the plan year.

If a participant's employment relationship with the Company ends due to becoming permanently disabled, death or the participant has reached the age of 65 and has at least five years of service, the participant is entitled to the full value of his/her account regardless of his/her vesting service. If the vested portion of a participant's account is less than or equal to \$1,000, he/she must take a full distribution from the Plan. If the vested portion of a participant's account is greater than \$1,000, the participant may choose to receive his/her vested balance in a lump-sum payment or leave the balance in the Plan.

### ***Plan Termination***

Although PRERAC has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of the collective bargaining agreement and/or ERISA. In the event of plan termination, participants will be completely vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are reported on an accrual basis.

### ***Valuation of Investments***

The investments of the Plan are reported at fair value. The fair value of the financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Mutual funds represent investments with various investment managers. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

The short-term investment fund consists of interest-bearing investments. Such amounts are recorded at cost, plus accrued interest. Dividend income is recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of the investments within the Plan are reflected on a trade-date basis.

**2. Summary of Significant Accounting Policies (continued)**

***Payment of Benefits***

Benefits are recorded when paid.

***Plan Expenses***

Investment management fees are paid by the Plan and are netted with investment earnings and losses. Trustee and other costs of administration of the Plan are paid by the Plan Sponsor and are not reflected in the financial statements.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**3. Investments**

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, investment income (consisting of interest and dividends, and administrative expenses for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by Banco Popular.

**4. Fair Value Measurements**

The Plan Sponsor uses a three-level fair value hierarchy that categorizes assets and liabilities measured at fair value based on the observability of the inputs utilized in the valuation. These levels include: Level 1, inputs are quoted prices in active markets for identical assets or liabilities; Level 2, inputs other than quoted prices included in Level 1 that are directly or indirectly observable through market-corroborated inputs; and Level 3, inputs are unobservable, or observable but cannot be market-corroborated, requiring the Plan Sponsor to make assumptions about pricing by market participants. There were no Level 2 or 3 investments in the Plan as of December 31, 2024 and 2023. Transfers between levels, if any, are recorded as of the date the transfer occurred. There were no transfers between levels during 2024 or 2023.

The following tables set forth by level within the fair value hierarchy Plan investment assets at fair value. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

## **5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## **6. Income Taxes**

The Plan has received a determination letter from the Commonwealth of the PR Treasury dated December 29, 2006, stating that the Plan is qualified under Sections 1165(a) and 1165(e) of the Puerto Rico Internal Revenue Code of 1994 (PRIRC-94), and therefore, the related trust is exempt from taxation. The PRIRC-94 was replaced January 31, 2011 by the Internal Revenue Code for a New Puerto Rico (the "Puerto Rico Code"), and the retirement plan rules are now enacted as Puerto Rico Code Section 1081.01. Subsequent to this determination by the PR Treasury, the Plan was amended and restated to convert it into an individually designed plan and submitted a request for a new ruling determination letter as to the Plan's qualified status under the Puerto Rico Code on July 3, 2015. The Plan is required to operate in conformity with the Puerto Rico Code to maintain its qualification. The Plan received the determination letter qualifying the Plan under Section 1081.01 of the Puerto Rico Code on April 6, 2017 and provides an effective date of September 30, 2014. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Puerto Rico Code and therefore believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. Subsequent Events**

In preparing the accompanying financial statements, management has reviewed subsequent events that have occurred after December 31, 2024 through July 18, 2025, the date the financial statements were issued. The Plan noted no reportable subsequent events.
