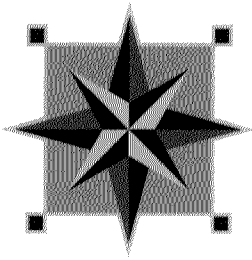

Notes to Financial Statements

December 31, 2024

Note 1 - Description of Plan

The following description of the Environmental Systems, Inc. Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Environmental Systems, Inc. ("the Company") who are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute annual compensation up to the maximum amount allowed by the IRS, as defined in the Plan. Participants may also designate some or all their elective deferrals as after-tax Roth deferrals and contribute amounts representing distributions from other qualified plans, subject to the rules of the Plan. The Company has the option of making discretionary profit-sharing contributions and a discretionary matching contribution. For the years ended December 31, 2024 and 2023, safe harbor contributions were made.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and any safe harbor non-elective or matching contributions made by the Company, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 20% vested after two years of credited service and an additional vesting of 20% each year thereafter until after six years, whereupon the employee is 100% vested. Vesting in the Company's discretionary matching contributions plus actual earnings is 100%.

Forfeited Accounts

Forfeitures only apply to the Company's profit-sharing contributions to the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$141,432 and \$56,416, respectively. Forfeitures may be reallocated to plan participants, used to reduce Company contributions or to pay reasonable Plan expenses. During the year ended December 31, 2024, \$44,458 in forfeitures was added to the profit sharing contribution and allocated to the eligible plan participants.

Notes Receivable from Participants

The Plan does not allow participant loans.

Common/Collective Trusts

The Plan has an investment, the Morley Stable Value Fund, in a common/collective trust. Common collective trust funds are comprised of shares or units in commingled funds that are not publicly traded. The Fund primarily consists of a diversified portfolio of investment contracts issued by insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The fund is valued at NAV, as a practical expedient, that is calculated by the investment manager or sponsor of the fund and has varying liquidity, redemption period notices and other restrictions. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants may receive a lump sum distribution from their rollover accounts at any time.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain (loss) on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company.

Note 3 - Funding Policy

Participating employees may make elective contributions to the Plan, pursuant to Internal Revenue Code Section 401(k). The Company's contribution for the years ended December 31, 2024 and 2023, was \$1,633,570 and \$1,737,242, respectively.

Note 4 - Information Certified by Plan's Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's rules and regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Advisor Trust, Inc. as of December 31, 2024 and 2023, as complete and accurate and was not subjected to any auditing procedures performed by the independent public accountants:

Note 5 - Investments

The Plan's investments are (were) administered by Advisor Trust, Inc. and held in a trust fund.

During 2024, the Plan's investments (including reinvested dividends, interest, and gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$4,690,281.

Note 6 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under US GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlations or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Collective Trust: Reported at fair value using net asset value (“NAV”) of shares held by the Plan at year end and not classified in the fair value hierarchy in accordance with ASC subtopic 820-10. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange Traded Funds: Valued at the closing price reported on the active market in which the individual underlying securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 - Related Party Transactions and Parties – In - Interest

Certain Plan investments are shares of exchange traded funds managed by Brinker Capital. Brinker Capital provides investment consulting services to the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The Company also pays for certain recordkeeping fees for the Plan.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 9 - Tax Status

The Company adopted a Prototype Standardized Profit Sharing 401(k) Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The favorable opinion letter stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or

expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 11 – Subsequent Events

The Plan evaluated subsequent events through the date of the Auditor's Report, which is the date the financial statements were issued.
