December 31, 2024

1. Description of the Plan

The following description of Cellular Sales of Knoxville, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this document are available from Cellular Sales of Knoxville, Inc. (the “Plan Sponsor”).

General

The Plan is a defined contribution plan sponsored by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees, other than nonresident aliens and leased employees, who have completed one year of qualifying service, are eligible to become participants in the Plan. Eligible employees may enter the Plan on the first day of each month after meeting eligibility requirements.

Plan Contributions

Participants may elect to contribute a percentage of their annual compensation or a fixed amount per pay period, on either a pre-tax basis, as a salary deferral, or a post-tax basis. These deferrals are subject to the annual limitations defined in the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the plan year are also eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan Sponsor may make matching contributions equal to a discretionary percentage, determined annually by the Plan Sponsor, of the participant’s salary deferral.

Cash contributions receivable are unsecured.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Plan Sponsor contributions, investment earnings and losses that are allocated based on each participant’s relative account balance within the respective fund, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Excess Contributions Payable

Amounts payable to participants totaling \$121,171 and \$483,638 as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service (IRS), are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Administrative Expenses

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Certain investment related expenses are netted in net realized and unrealized appreciation in the fair value of investments.

Investments

The Plan provides for investments in various mutual funds. Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform and any collateral was insufficient is the recorded amount of such investments.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or his or her beneficiaries) may elect to receive a lump sum amount equal to the vested value of his or her account. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions in accordance with the IRC. In-service hardship withdrawals are also available in certain circumstances.

Vesting for Benefits

Participants are 100% vested in their own contributions, contributions made by the Plan Sponsor and the earnings allocated thereon at all times.

Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Significant Accounting Policies (continued)

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Annual returns filed under applicable provisions of ERISA and the IRC are filed on the modified cash basis of accounting.

Investments

Capital Bank and Trust Company (the “Custodian”), a related company to American Funds, holds the Plan’s investments, which are recorded at fair value based upon quoted prices in an active market. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments is reflected in the statements of changes in net assets available for benefits. This includes all investments bought or sold as well as those held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan’s financial statements. Accordingly, actual results may differ from those estimates.

Subsequent Events

In preparation of the accompanying financial statements, plan management has evaluated subsequent events that have occurred since December 31, 2024 through July 23, 2025, the date the financial statements were available for issuance.

3. Income Tax Status

The Plan Sponsor adopted a prototype plan sponsored by Tennessee Pension Administrators, LLC, which received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC; therefore, the Plan is not subject to income taxes. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

Notes to Financial Statements (continued)

4. Certified Information (Unaudited)

The Custodian holds the Plan's investments assets and executes transactions therein. Financial information relating to those assets disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including mutual fund investments held as of December 31, 2024 and 2023, net realized and unrealized appreciation (depreciation) in the fair value of investments, and investment income, is based upon information provided to the Plan Administrator and agreed to or derived from information certified as complete and accurate by the Custodian.

Of the investments, \$80,988,876 and \$65,039,329 as of December 31, 2024 and 2023, respectively, represent investments in party-in-interest mutual funds. The party-in-interest mutual funds appreciated in fair value by \$7,216,723 in 2024 and by \$8,795,437 in 2023. Also, the party-in-interest mutual funds earned investment income of \$4,227,462 in 2024 and \$2,433,951 in 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820, *Fair Value Measurements*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

5. Fair Value Measurements (continued)

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

6. Other Related Party and Party-In-Interest Transactions

Certain plan investments are held and managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
