As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from Empower Annuity Insurance Company of America, a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **St. Luke Home Care and Hospice Retirement Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **St. Luke Home Care and Hospice Retirement Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the **St. Luke Home Care and Hospice Retirement Plan, (the “Plan”)** is provided for general information purposes only. Participants should refer to the plan document for a more complete description of **the Plan’s** information.

General — The Plan is a defined contribution plan created for substantially all employees who are not covered by other plan, of St. Luke’s Episcopal Church Home Care and Hospice Program (Original Plan Sponsor), which was a division of Iglesia Episcopal Puertorriqueña, Inc. (IEP) until March 31, 2022. Effective April 1, 2022, IEP entered into a corporate reorganization that transferred the Original Plan Sponsor’s assets and liabilities to Programa de Servicios de Salud en el Hogar y Hospicio San Lucas, Inc., (PSHHSL) a newly created Puerto Rico not-for-profit corporation with a new employer identification number.

Also, effective April 1, 2022, **the Plan** was amended and restated to adopt the Pension Administrators Group, Inc. Prototype Defined Contribution Retirement Plan Program and to amend certain options of an earlier Pension Administrators Group, Inc. Salary Deferral Retirement Plan Adoption Agreement of ST. Luke Home Care and Hospice Retirement Plan with Effective Date on November 1, 2019. The new adoption agreement appointed PSHHSL as the new Plan Sponsor. All other Plan’s provisions remained unchanged. According to the Deed of Trust, the adoption of the Plan was effective retrospectively to January 1, 2022. The Board of Directors of the Plan Sponsor has appointed the Pension Plan Committee to control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions — Contributions to **the Plan** include (i) salary reduction contributions authorized by participants, (ii) discretionary matching contributions made by the Plan Sponsor; and (iii) participant rollovers from another plan. There will be no profit sharing and/or additional contributions made by the Plan Sponsor.

Participants may elect to contribute a percentage of their compensation, excluding bonuses and commissions, to **the Plan** each year, subject to the limitations, as defined in **the Plan** document. Such contributions are excluded from the participant’s taxable income for Puerto Rico income tax purposes until received as a withdrawal or distribution from **the Plan**. The minimum elective deferral percentage is 1% of eligible compensation and their contributions invested in a designated balanced fund. Participants who have attained age 50 before the end of **the Plan** year are eligible to make catch-up contributions subject to the limitations of Puerto Rico Internal Revenue Code of 2011 (the PRIRC) Section 1081.01(d)(7)(C).

The Plan Sponsor may make contributions at the discretion of the Plan Sponsor’s Board of Directors. These contributions are totally discretionary, including the discretion to forego a contribution for one or more Plan Years. During the year ended December 31, 2024 contribution to **the Plan** made by the Plan Sponsor amounted to \$85,707.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain PRIRC limitations.

Participant Accounts — Individual accounts are maintained for each participant of **the Plan**. Each participant’s account is credited with the participant’s contribution and related nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by **the Plan**. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. DESCRIPTION OF THE PLAN, Continued

Investments — Participants may direct the investment of their contributions and/or account balances into various investment options offered by **the Plan** and may change investments and transfer amounts between funds daily. **The Plan** offers various registered investment companies and mutual funds.

Vesting — Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Following is a table of vesting interest on Plan Sponsor's contribution portion based on years of continuous service:

Notes Receivable from Participants — Notes receivable from Participants are not permitted.

Payment of Benefits — On termination of service with the Plan Sponsor (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments if his or her vested interest exceed \$5,000.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to **the Plan** for a period of twelve (12) months following the date of the in-service withdrawal.

Forfeited Accounts — When certain terminations of participation in **the Plan** occur, the nonvested portion of the participant's account as defined by **the Plan**, represents a forfeiture. **The Plan** document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for **the Plan** year. However, if a participant is reemployed and fulfills certain requirements, as defined in **the Plan** document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,347 and \$11,412, respectively. During 2024, employer contributions were reduced by \$7,199 from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — **The Plan** provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Continued

Investment Valuation and Income Recognition — **The Plan's** investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes **the Plan's** gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses — Administrative expenses of **the Plan** are paid by the Plan Sponsor as provided in **the Plan** document. All investment management and transaction fees directly related to **the Plan** investments are paid by **the Plan**. Management fees and operating expenses charged to **the Plan** for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits — Benefit payments to participants are recorded upon distribution. FASB ASC 962-205-50-1(i) requires disclosure for amounts allocated to accounts of persons who have elected to withdraw from **the Plan** but have not yet been paid. These amounts shall not be reported as a liability on the statement of net assets available for benefits. Amounts allocated to accounts of persons who have elected to withdraw from **the Plan**, but have not yet been paid, were \$16,452 and \$1,426 at December 31, 2024 and 2023, respectively.

Excess Contributions Payable — **The Plan** is required to return contributions received during **the Plan** year in excess of the PRIRC limits.

Date of Management's Review of Subsequent Events — Subsequent events were evaluated through July 22, 2025, the date the financial statements were available to be issued. Except as disclosed on note 10, no events have occurred after December 31, 2024, but before July 22, 2025, that require consideration as adjustments to or disclosure in the financial statements.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain unaudited information regarding **the Plan** as of December 31, 2024 and 2023 and included in **the Plan's** financial statements and supplemental schedules, was prepared by Empower Annuity Insurance Company of America, custodian of **the Plan's** assets for the years ended December 31, 2024 and 2023. The information was furnished to the trustee of **the Plan** and to the plan administrator. The plan administrator has obtained a certification from the trustee, that such information, disclosed below, is complete and accurate, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA:

- Investments, at fair value, including cash and cash equivalents included in the accompanying Statements of Net Assets Available for Benefits of \$4,957,595 and \$4,628,033 as of December 31, 2024 and 2023, respectively.
- Investments, at contract value, included in the accompanying Statements of Net Assets Available for Benefits of \$159,361 and \$149,743 as of December 31, 2024 and 2023, respectively,
- Net appreciation in fair value of investments (including interest income), as reported in the accompanying Statement of Changes in Net Assets Available for Benefits of \$477,661 for the year ended December 31, 2024.

3. INFORMATION CERTIFIED BY THE CUSTODIAN, Continued

- All investment balances and investment information disclosed in Notes 4, 5 and 6, excluding the classification of investments by level,
- All investments-related information, included in the accompanying Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques — Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds — Valued at the amortized cost which approximate fair value.

Mutual Funds — Valued at the daily closing price as reported by the fund. Mutual funds held by **the Plan** are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by **the Plan** are deemed to be actively traded.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023.

Transfers Between Levels — The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended, December 31, 2024, there were no transfers between levels.

5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2019, **the Plan** entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company (Empower). Empower maintains the contributions in a pooled account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to **the Plan**.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to **the Plan** by Empower, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$159,361 and \$149,742, respectively. The crediting interest rate is based on an agreed-upon formula with the issuer, which may never fall below zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit **the Plan's** ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from **the Plan**, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with **the Plan** and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of **the Plan's** investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. **The Plan** administrator does not believe that the occurrence of any such value event, which would limit **the Plan's** ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. INVESTMENTS

During the year ended December 31, 2024, **the Plan's** investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$208,396.

7. RELATED PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan cash accounts and investments are shares of money market funds managed by Empower Annuity Insurance Company, the custodian and recordkeeper, as defined by **the Plan**. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right under **the Plan** to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that **the Plan** is terminated, participants would become 100% vested in their accounts.

9. INCOME TAX STATUS

Effective November 1, 2019, **the Plan** was amended and restated. On October 14, 2019, **the Plan** requests a determination from the Puerto Rico Treasury Department (PRTD) to determine that **the Plan** and related trust, as adopted, were designed in accordance with the applicable regulations of section 1081.01 of the Puerto Rico Internal Revenue Code of 2011 (PRIRC). **The Plan** received a determination letter on November 21, 2019, from the PRTD that informed no objection to the participation of **the Plan** in the Pension Administration Group, Inc. Prototype Defined Contribution Retirement Plan Program to be effective as of November 1, 2019. As discussed in note 1, effective April 1, 2022, **the Plan** was amended to change the Plan Sponsor. On August 1, 2022, **the Plan** requests a determination from the Puerto Rico Treasury Department (PRTD) to determine that **the Plan** and related trust, as adopted, were designed in accordance with the applicable regulations of the section 1081.01 of the Puerto Rico Internal Revenue Code of 2011 (PRIRC). **The Plan** received a determination letter on January 31, 2023, from the PRTD that informed no objection to amendment. We believe that **the Plan** is currently designed and being operated in compliance with the applicable requirements of the PRIRC. The Plan Sponsor considers that all requirements for the determination are met. Therefore, no provision for income taxes has been included in **the Plan's** financial statements.

GAAP requires Plan management to evaluate tax positions taken by **the Plan** and recognize a tax liability (or asset) if **the Plan** has taken an uncertain position that more likely than not would not be sustained upon examination by the PRTD. **The Plan** is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. **The Plan** administrator believes it is no longer subject to income tax examinations for years prior to 2020.

10. NONEXEMPT PARTY-IN-INTEREST TRANSACTION

During the year ended December 31, 2024, the Plan Sponsor did not remit certain participant contributions to the custodian in a timely fashion as required by the Department of Labor (DOL) Regulation 2510.3-102, as management did not receive the request for the transfer of funds on time from the record-keeper. Total participant contribution not remitted on a timely basis during the year ended December 31, 2024, amounted to \$95. Corrected during 2025. No late contribution was made during the year ended December 31, 2023.
