We have performed audits of the financial statements of Business Office Systems, Inc. Salary Reduction Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Note 1. Plan Description

The following description of the Business Office Systems, Inc. Salary Reduction Plan and Trust (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained by from the Plan Sponsor.

**General:** The Plan is a defined contribution plan covering substantially all employees of BOS of Illinois, Inc., BOS of Florida, Inc. and Affordable Office Interiors, LLC. (collectively, the Company). Employees, who are not subject to a collective bargaining agreement are eligible to participate in the Plan upon attaining age 18 and completing three months of service. Employees who are subject to a collective bargaining agreement are eligible to participate in the Plan upon attaining age 18 and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may elect to contribute a percentage of their annual pre and/or post-tax compensation, as defined by the Plan Agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, make a matching contribution to the Plan. There were no such contributions for the year ended December 31, 2024. Additionally, plan provisions also allow for a discretionary profit-sharing contribution to all eligible participants who are not subject to a collective bargaining agreement. For the year ended December 31, 2024, the Company did not make any profit-sharing contributions.

Employees covered under the collective bargaining agreement with Chicago Regional Council of Carpenters Union shall be subject to the following limitations: (1) enrollment will be allowed no sooner than one year from the initial date of employment, (2) Company matching is not allowed on either the base contributions or the catch-up contributions as defined by the Internal Revenue Service (IRS), and (3) discretionary profit-sharing contributions are not allowed.

Company contributions are invested in a manner consistent with participant contributions.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contribution, if any, and (b) plan earnings and charged an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer-matching and profit-sharing contributions is based on years of continuous vesting service, as defined by the Plan Agreement. A participant is 100% vested after six years of credited service starting with 20% after the second year and an additional 20% each year thereafter.

**Payment of benefits:** Upon termination of employment for any reason, including retirement, the participant may elect to receive a lump-sum payment in an amount equal to the vested value of their account. In addition, participants may make withdrawals upon reaching a normal retirement age of 65, an early retirement age of 59½, or by determination that a financial hardship, as defined by the Plan Agreement, has been incurred.

#### Note 1. Plan Description (Continued)

In the event of a participant's death, 100% of the participant's vested account balance will be used to provide the beneficiary with a death benefit in the form of a single lump-sum payment in cash or installments over a period of not more than the assumed life expectancy of the beneficiary. If the beneficiary is a person (not an estate), then distributions will begin by the end of the year following the year of death "one-year rule". If the beneficiary is a spouse, then under the one-year rule, the start of payments may be delayed until the year in which the participant would have attained the age of 70½.

Generally, if the beneficiary is not a person, the entire death benefit must be paid by the end of the fifth year following the year of death five-year rule.

Benefit payments are recorded when paid.

**Forfeited accounts:** Forfeitures of the Company's contributions will be used for the payment of plan expenses or to reduce future employer-matching contributions. At December 31, 2024 and 2023, the forfeited accounts totaled approximately \$5,900 and \$5,400, respectively. For the year ended December 31, 2024, no forfeitures were used to pay plan expenses.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Participants may borrow from their fund accounts at a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable terms generally range from one to five years, or longer for the purchase of a primary residence, as defined by the Plan Agreement. The notes are collateralized by the balance in the participant's account and will bear interest at a rate commensurate with prevailing rates at the time of the loan as determined by the third-party administrator. Principal and interest are paid ratably through payroll deductions.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and, therefore, are not reflected in the Plan's financial statements.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under an accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the discretionary matching contributions from the employer, when applicable, are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

**Common collective trust:** Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Subsequent events:** The Company has evaluated subsequent events for potential recognition and/or disclosure through July 29, 2025, the date the financial statements were available to be issued.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by Bank of America. Bank of America performs services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Bank of America were \$67,361 for the year ended December 31, 2024.

#### **Note 7. Income Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
