**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of University of Vermont Foundation 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### **(1) Description of Plan**

The following description of the University of Vermont Foundation 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### **(a) General**

The Plan is a tax-exempt, defined contribution retirement plan sponsored by the University of Vermont and State Agricultural College Foundation, Inc. (UVM Foundation). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The purpose of the Plan is to provide eligible employees a measure of financial security upon their retirement.

#### **(b) Eligibility**

All employees over the age of 18 are eligible to make salary deferral contributions and receive the UVM Foundation match immediately.

#### **(c) Contributions**

Contributions to the Plan are made by the participants in the form of salary reduction up to the maximum dollar limit which is set by law on an annual basis. In addition to the limits set each year, if the employee is projected to attain age 50 before the end of the calendar year or they qualify for the 15-years of service catch up, they may elect to defer additional amounts, called “catch up contributions”. Employees may contribute on a pre-tax or after-tax basis.

UVM Foundation’s employer matching contribution are a fixed percentage of compensation equal to 10% of compensation provided the employee’s deferrals equal or exceed 2% of compensation. UVM Foundation made total contributions to the Plan of \$860,008 and \$773,375 for the years ended December 31, 2024 and 2023, respectively.

#### **(d) Participant Accounts**

Each participant’s account is credited with the participant’s contributions, UVM Foundation’s matching contribution, and allocations of investment earnings. Allocations are based on a participant’s eligible compensation relative to total eligible compensation, deferred contributed amounts or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account balances into various investment funds or annuities offered by the Plan.

#### **(e) Vesting**

Participants are immediately vested in all contributions and earnings thereon.

### *(f) Loans*

#### **Participant Loans**

Participants may borrow from the accounts of their choosing a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum aggregate dollar amount of loans outstanding may not exceed \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan. Only two outstanding loans are allowed at a time and no loan will be issued if the participant is currently in default on a loan from this plan. Loans are treated as a transfer from the investment fund to participant loans. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the vendor. Principal and interest are paid by ACH directly to TIAA. Participant loans are valued at amortized cost.

#### **Plan Loans**

Plan loans are issued as separate contracts by TIAA as contemplated under IRC Section 72(p)(5) and do not represent plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms range from one to five years in one-year increments. Principal and interest is paid ratably by the participant to TIAA and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. Plan loan balances outstanding from participants to TIAA were \$3,405 and \$9,977 for the years ended December 31, 2024 and 2023, respectively.

### *(g) Distributions*

On termination of service due to death, disability, retirement, or separation of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a single lump-sum amount, monthly, quarterly, or in annual installments over a period of not more than the participant's assumed life expectancy or an annuity option. For termination of service due to other reasons, a participant will receive the value of the vested interest in their account as a lump-sum distribution.

In-service distributions are allowed after age 59 ½.

Effective October 1, 2022, the Plan implemented a mandatory distribution provision for terminated participants with vested account balances below \$5,000. Beginning January 1, 2024, this threshold was increased to \$7,000. Under this provision, if a participant terminates employment, regardless of age or reason, and their vested account balance (excluding any rollover contributions) does not exceed \$7,000, a distribution will be automatically initiated without requiring the participant's consent. If the vested balance is greater than \$0.01 but does not exceed \$7,000, the distribution will be automatically rolled over into an individual retirement account (IRA) established on the participant's behalf, unless the participant elects an alternative distribution option.

### **(h) Plan Termination**

Although it has not expressed any intent to do so, UVM Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **(i) TIAA Traditional Annuity**

TIAA Traditional Annuity (TIAA Traditional) is an unallocated fixed annuity contract that is fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest, generally 3%, and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the plan and does not represent an obligation of the plan.

TIAA Traditional Annuity holdings within liquid contracts (SRA, GSRA, and RCP) are considered fully benefit-responsive and contract value approximates fair value at December 31, 2024. TIAA Traditional Annuity holdings within illiquid contracts (RA, GRA, and RC) are non-benefit responsive. See Notes 4 and 5 for further discussion of the TIAA Traditional Annuity.

## **(2) Summary of Significant Accounting Policies**

### **(a) Basis of Accounting**

The accompanying financial statements are prepared using the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

### **(b) Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein during the reporting period. Actual results could differ from those estimates.

### **(c) Investment Valuation and Income Recognition**

The Plan’s investments are reported at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **(d) *Payment of Benefits***

Benefits are recorded when paid.

### **(e) *Administrative Expenses***

Expenses of administering the Plan including investment advisory fees, consultant fees, recordkeeping fees, audit and legal fees are paid by the Foundation. There are no administrative expenses paid to TIAA by the Plan. Participants may incur specific fees, such as investment fees, dependent upon their investment elections selected and fees for personalized services such as loans and withdrawals.

### **(3) Information Certified by the Plan's Custodians/Trustees**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, TIAA, the custodian/trustee of the Plan, has certified as being complete and accurate the investments on the statements of net assets available for benefits as of December 31, 2024 and 2023, the investment activity reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the investment information included in the supplemental schedule of assets held as of December 31, 2024. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodian/trustee.

### **(4) Fair Value Measurements**

Accounting principles generally accepted in the United States of America establishes a framework for measuring fair value and a hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment options available to participants include the TIAA Traditional Annuity, TIAA Real Estate, select mutual funds, and money markets.

The following is a description of the valuation methodologies used for assets measured at fair value.

### *Insurance Contracts (Non-fully Benefit Responsive Portion)*

TIAA Traditional Annuity is a guaranteed fixed-rate annuity backed by TIAA's claims paying ability whereby the annuity guarantees principal and a minimum interest rate. TIAA Traditional Annuity holdings within illiquid contracts (RA, GRA, and RC) are non-benefit responsive. The non-fully benefit responsive portion of the TIAA Traditional Annuity provides an opportunity for additional amounts in excess of the guaranteed rate and is reported at fair value, classified within level 3 of the valuation hierarchy. See discussion at Note 1 for further details.

### *Mutual Funds*

TIAA offers several mutual funds. Unlike TIAA Traditional, these accounts do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each account. The accounts invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources, except those held by the TIAA-CREF Money Market Fund, whose holdings are valued at amortized cost. Transfers out of mutual funds into another investment option may be executed on a daily basis.

### *Pooled Separate Accounts*

In addition, TIAA offers the Real Estate Account which is an insurance company separate account of TIAA investing in real estate and real estate-related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments (Level 1). Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated daily. Transfers out of the TIAA Real Estate Account to a TIAA into another investment option can be executed at any time but are limited to once per calendar quarter.

### **(5) Investment Contract with Insurance Company**

As described in Note 1, because a portion of the guaranteed investment contracts with TIAA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract. The fully benefit-responsive portion of the investment contracts is included in the financial statements at contract value, as reported to the Plan by TIAA. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate, generally 3%, that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. The TIAA Board of Trustees may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year that begins each March 1; they are not guaranteed for future years.

Certain events limit the Plan's ability to transact at contract value with TIAA. Examples of such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the TIAA to terminate the agreement prior to the scheduled maturity date.

### **(6) Related-Party Transactions and Party-In-Interest Transactions**

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

### **(7) Income Tax Status**

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) that was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or de-recognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **(9) Subsequent Events**

For purposes of determining the effects of subsequent events on these financial statements, management has evaluated events subsequent to December 31, 2024 and through July 22, 2025, the date on which the financial statements were available to be issued.
