### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of SanMar, LKWP, and Affiliates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SanMar, LKWP, and Affiliates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Note 1 – Description of Plan

The following description of the SanMar, LKWP, and Affiliates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of SanMar Corporation, Arctic Asset Management, LLC and Lake Washington Partners, LLC (collectively, the Company). The Plan was established effective April 1, 1977, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan sponsor and serves as the Plan administrator.

**Contributions** – Eligible participants may elect to defer an amount up to 75% of their compensation, limited to the maximum amount allowed by the Internal Revenue Code (IRC). The Plan is a safe harbor plan in which the Company will make contributions each pay period of 100% of participants' contributions up to 4% of the participants eligible compensation. The safe harbor contribution for the year ended December 31, 2024, was \$6,877,869.

The Company may make a discretionary matching contribution or profit sharing contribution to the Plan in an amount determined annually by the Board of Directors. All eligible participants must be employed as of the last day of the Plan year to qualify for the discretionary contributions. There were no discretionary matching contribution or profit sharing contribution for the year ended December 31, 2024.

Participants may also contribute amounts representing contributions from other defined benefit or defined contribution plans. Participants direct the investment of their contributions into various options offered by the Plan. The Plan offers two collective trust and twenty-one registered investment company funds as investment options for participants.

**Eligibility** – As of January 1, 2024, employees are eligible to participant in the Plan as of the first of the month following 60 days from their hire date. Prior to January 1, 2024, employees who completed 260 hours of service within a 90-day period from their hire date were eligible to participate in the Plan. Employees who did not complete the hours stated above within the specified time period were subject to a one-year service requirement, as defined by the Plan.

## SanMar, LKWP, and Affiliates 401(k) Plan Notes to Financial Statements

---

**Vesting** – Participants are immediately 100% vested in their voluntary contributions and employer safe harbor contributions plus earnings thereon. Vesting in the Company’s discretionary contributions and profit sharing contributions plus earnings thereon is based on years of continuous service. Participants vest in the Company’s non-safe harbor contributions based on the following schedule:

**Participant accounts** – Each participant’s account is credited with the participant’s contribution, the Company’s discretionary matching contribution, the Company’s safe harbor contribution, allocations of the Company’s discretionary profit sharing contribution, and Plan earnings. Participants are also charged with an allocation of administrative expenses. Administrative expenses are allocated to participants based on earnings and participant account balances as defined in the Plan agreement.

**Forfeitures** – Provisions of the Plan provide that upon termination of employment, participants are entitled to receive their vested portion of the net assets of the Plan. The nonvested portion of a terminated participant’s account balance is forfeited. Forfeitures can be used to reduce the discretionary matching contribution immediately following the Plan year in which the forfeiture occurs, or to pay expenses of Plan administration, as determined by the SanMar 401(k) Committee. As of December 31, 2024 and 2023, \$56,146 and \$37,302, respectively, was forfeited from participant accounts and was available for reallocation. For the year ended December 31, 2024, Company matching contributions were reduced by \$151,558 from forfeited nonvested accounts.

**Benefit payments and withdrawals** – Upon termination of service, a participant may elect to receive a lump-sum amount or fixed period installment option, equal to the value of his or her vested account balance. Upon termination of service due to death, disability or retirement, a participant is considered fully vested and may elect to receive a lump-sum amount equal to the value of his or her account balance. The Plan also includes a provision for withdrawals under certain financial hardship circumstances, as defined in the Plan document.

**Notes receivable from participants** – Participants may borrow from their accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. Loans must bear a reasonable rate of interest, as determined by the Plan administrator on the date the loan is originated. Principal and interest payments must be made at least quarterly and are made through payroll deductions. As of December 31, 2024, rates of interest charged on participant loans vary from 4.25% to 9.50% with various maturities through June 2034.

**Administrative expenses** – Recordkeeping and investment fees related to services provided by Principal Trust Company (the Trustee), are funded by the Plan. Costs related to professional services are paid by the Company.

**Plan termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, the obligation of the Company to make contributions to the Plan shall cease and all amounts credited to the participants' accounts shall be fully vested.

#### **Note 2 – Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual basis of accounting.

**Use of estimates** – The preparation of the financial statements in accordance with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Contributions** – Contributions from participants are recorded by the Plan when they are received by the Trustee. Contributions from the Company are recorded by the Plan when they become obligations of the Company.

**Investment valuation** – The investments are reported at fair value and net asset value (NAV) practical expedient. The Plan's Trustee certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded as of their trade-date. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest, and are classified as notes receivable. Delinquent notes receivable from participants are reclassified as a distribution based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassifications** – Certain prior year amounts have been reclassified to be in accordance with current year presentation. These reclassifications had no impact on net assets for either period presented.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before financial statements are issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before financial statements are available to be issued.

The Plan has evaluated subsequent events through July 29, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Fair Value of Investments**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation model are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## SanMar, LKWP, and Affiliates 401(k) Plan Notes to Financial Statements

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds* – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. There are no restrictions to trading the CTs at the NAV practical expedients at December 31, 2024 or 2023.

- Net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

### Note 6 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the 401(k) Committee believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the 401(k) Committee has evaluated the Plan’s tax positions and do not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
