## INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Participants of  
United Surety & Indemnity Company CODA Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of United Surety & Indemnity Company CODA Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. DESCRIPTION OF THE PLAN**

The following brief description of the United Surety & Indemnity Company CODA Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

**Plan Description** – The Plan is a profit-sharing plan with cash or deferred arrangement plan established by United Surety & Indemnity Company, (the “Sponsor”) on January 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility** – All employee above 21 years of age or older are considered eligible. With the exception for the class or classes of Employees (Union employees, Leased Employees and Temporary Employees). Employees are eligible to become a participant of the Plan on the first day of the month by coinciding with or following the date the requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – The Employer may make a Matching Contribution for any Allocation Period equal to a discretionary percentage of the participants’ compensation. Participants may contribute a pre-tax annual contribution up to the maximum amount in accordance with the provisions of the Puerto Rico Income Tax Code (\$15,000 for the years ended December 31, 2024 and 2023). After-Tax contributions may not exceed 10% of the aggregate compensation paid to the participant. The minimum permitted Code Section 1165(e) Elective Deferral percentage is 3%. The permitted Code Section 1165(e) Elective Deferral percentage is 100%. Automatic enrollment is permitted subject to the terms of a written policy or the notice that is provided to Plan participants each Plan Year.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon and become vested in the Sponsor’s contributions, including profit sharing contributions. A participant is 100% vested after three tears of credited service.

The vesting schedule is as follows:

**Forfeited Accounts** – Effective July 1, 2008, forfeited non-vested accounts should be allocated to participants’ accounts during the Plan year in the proportion that a participant’s account

balance bears to the total Plan assets. Prior to such date, forfeited non-vested accounts were used to reduce related Plan expense. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$31,642 and \$20,380, respectively.

**Payment of Benefits** – On retirement, death, disability, or termination of service, a participant (or participant’s beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant’s vested account balance, or a direct rollover to an individual retirement account or to another qualified plan.

The Plan also provides for certain withdrawals during employment, as follows:

- a) **Normal retirement age** – A participant will be fully vested and may retire after the latter of reaching age 60 or the sixty anniversary of the date he or she became a participant.
- b) **Disability retirement** – A participant will be fully vested and may retire prior to normal retirement age upon becoming disable.

If the participant terminates his employment before reaching his normal, becoming disable or dying, the participant shall be allowed to apply for an early distribution of his plan benefits.

**Hardship Withdrawals** – Under the provisions of the Plan, participants are permitted to make hardship withdrawals out from the participant’s pre-tax, catch-up, match and rollover contributions. Such withdrawal is only permitted if: a) financial hardship is demonstrated, b) the withdrawal is approved by the Plan Administrator and c) such withdrawal is allowable under the Puerto Rico Income Tax Code.

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and, (b) Plan investments’ results. Allocation of the Plan investment’s result is based on participant’s account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies used by the Plan follows:

**Basis of Accounting** – The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates in the Preparation of Financial Statements** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the

reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Contributions** – Employees contributions and Plan Sponsors matching contributions are recorded in the plan year period in which the Plan Sponsors make payroll deductions from the Plan participants' earnings.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 to the Financial Statements for additional disclosures related to fair value measurements.

The Plan investment return includes interest income, gains and losses on sales of investments and unrealized appreciation or depreciation of investments. The financial statements reflect the net appreciation or depreciation in the fair value of the Plan's investments. This net appreciation or depreciation consists of realized gains and losses calculated as the difference between proceeds from a sales transaction and cost, and unrealized gains and losses calculated as the change in the fair value between beginning of the year (or purchase date if later) and the end of the year.

The Plan also invests in a EI Fixed Account - Series Class I (GWAQ35) which is a fixed fund fully benefit-responsive investment, offered through a group of fixed and variable deferred annuity contracts issued by Empower, and managed by Empower Capital Management, LLC.

**Benefits Payable** – The Plan accounts for benefits payable in accordance with the guidance provided by the AICPA Audit and Accounting Guide, Audit of Employee Benefits Plans. This guidance requires that benefits payable to person who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan.

**Payment of Benefits** – Benefits payments to participants are recorded upon distribution. There were no withdrawals that were requested but have not yet been paid at December 31, 2024.

**Administrative expenses** – The Plan Sponsor is responsible for the general administration of the Plan and for carrying out the provisions thereof. Plan expenses such as legal, auditing and advisory fees are paid by the Plan Sponsor. Certain transaction charges are deducted from the Participant's accounts.

**3. FAIR VALUE MEASUREMENTS**

The FASB's authoritative guidance on Fair Value Measurement and Disclosures, establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active market that the plan has the ability to access.

*Level 2* - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Model based techniques in which inputs or assumptions to the valuation methodology are unobservable in the market and significant to the fair value measurement. Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumption about risk).

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds*** – Share Prices/Net Assets Values reported on the Plan are generally obtained from a file feed from the National Securities Clearing Corporation, and/or directly from the fund house, or a secondary pricing source, such as Interactive Data

Corporation. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. GROUP ANNUITY CONTRACT**

The Plan has a fully benefit responsive group annuity contract with Empower Annuity Insurance Company of America (“Empower”), and managed by Empower Capital Management, LLC, totaling \$659,941 and \$168,255, as of December 31, 2024 and 2023, respectively.

The group annuity contract invests contributions in a EI Fixed Account - Series Class I (GWAQ35). This GWAQ35 is a general account product where principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of Empower.

This GWAQ35 is a fully benefit-responsive investment contract for participant-initiated transactions for which values are reported at contract value. Contract value is determined as (a) plus (b) minus (c) where:

- (a) Represents the cost of all contributions made under the contract;
- (b) Includes interests credited to the fund;
- (c) Represents transfer-out from participants’ account balance.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions, and it is reset quarterly. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The quarterly credit rate applies to all money deposited in the group contract holder’s GWAQ35 account regardless of when was deposited. The average interest rate for the year ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively.

At December 31, 2024 and 2023, Empower informed that the fair value approximates contract value and as such, no adjustments were necessary to the accompanying statements of net assets available for benefits.

**5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Oriental Bank, the trustee of the Plan, has certified as to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; the investment fair value measurement; and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Each investment is subject to market risk. The degree of market risk varies by investment type based upon the nature of the applicable underlying net assets. The Plan's maximum exposure to accounting loss from such investments is represented by the amounts appearing in the statements of net assets available for benefits.

**6. TAX STATUS**

The Plan is exempt from Puerto Rico income taxes as per the New Puerto Rico Code ("New PR Code"), which was approved effective for taxable years starting after December 31, 2011.

The Plan was officially granted the qualification from the Puerto Rico Treasury Department ("PRTD") to operate under the provisions of former section 1165(e) of the Puerto Rico Income Tax Code. Such qualification provides the tax-deferral and deduction features at the participants' and Plan Sponsors' level and ratifies such treatment since the Plan's inception. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Income Tax Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In Puerto Rico, the tax laws permit examination of the Pan Sponsors' income tax returns for up to four years after the initial return if filed. The tax years of the Plan Sponsors with respect to the Plan that remain open for examination are from 2021 to 2024.

**7. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan to reduce, suspend or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan terminates, the interest of each participating employee in the Plan shall be fully vested and such termination shall not reduce the interest of any participating employee, or their beneficiaries accrued under the Plan up to the date of such termination.

**8. RISK AND UNCERTAINTIES**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and level of uncertainty related to changes in the values of investments, it is possible that changes in market values in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in fund values.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

**9. PARTY-IN-INTEREST TRANSACTION<sup>7</sup>**

The Company as plan sponsor provides certain administrative expenses, Empower Trust Company, LLC, such as recordkeeping services, Oriental Bank – trust division, the Trustee of the Plan and audit services for the Plan at no cost to the Plan's participants.

**10. SUBSEQUENT EVENTS**

The Plan Administrator evaluated subsequent events through July 29, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that would be required in the Plan's financial statements.
