Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of AbilityFirst Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF THE PLAN

(a) GENERAL

The following description of AbilityFirst Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan documents, including the Summary Plan Description, for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan which covers all eligible employees of AbilityFirst Inc. (the Organization). The original Plan was established effective July 1, 1999 by the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan immediately upon hire. After one year of service, employees are eligible to receive discretionary employer matching contributions. Effective May 27, 2024, the Plan was amended to remove the service requirement for discretionary matching contributions.

The Plan was most recently amended effective August 1, 2024 to change the entry date for employer discretionary matching contributions from first day of the month coinciding with or next following the date on which a participant becomes eligible to the date that the participant is eligible.

(b) CONTRIBUTIONS

A participant may elect to contribute a percentage or a fixed dollar amount up to 100% of their annual compensation, subject to IRS limitations, not to exceed \$23,000 for the year ended December 31, 2024. Participants who have attained the age of 50 by the Plan year end may also make catch-up contributions of \$7,500 during the year ended December 31, 2024.

The Organization may elect to make discretionary matching contributions each year. The discretionary matching contribution was \$140,956 for the year ended December 31, 2024.

(c) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's and the Company's contributions, and an allocation of Plan earnings. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account balance.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

(d) VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's discretionary matching contributions, if any, is based on continuous years of service. A year of service is defined as 1,000 hours of service during a plan year. Upon reaching one year of service, participants are 20% vested in employer contributions, and 20% every year thereafter, becoming fully vested after 5 years of service.

(e) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow up to 50% of their vested account balance subject to a minimum amount of \$1,000 and a maximum of \$50,000. Loan terms range from one to five years, or longer for the purchase of a primary residence. Notes receivable from participants bear interest at a rate which is comparable to commercial lending institutions as determined quarterly by the Plan Administrator. The interest rate on outstanding notes receivable from participants at December 31, 2024 ranged from 4.00% to 9.00%. Notes receivable from participants are secured by the participant's vested interest in the Plan.

Voya Life Insurance and Annuity Company (Voya) and American United Life Company (AUL) administer loans secured by participants accounts held at Voya and AUL. These loans are issued from funds accumulated in participants' own accounts and bear interest. The loan balances are included in Plan assets as notes receivable from participants. Principal and interest are paid ratably through payroll deductions.

TIAA and CREF administers loans secured by participant accounts held at TIAA and CREF. Loans are issued directly from TIAA and CREFF assets and loan principal is not advanced from participant accounts. The loans are secured by the balance in the participant's account. Loans are collateralized by the participants' account balances. If defaulted loans are foreclosed on, the foreclosed amount is transferred from the participant's account to an unallocated holding account for defaulted loan collateral until the amounts are reinstated or a distributable event occurs. A total of \$50,663 and \$48,031 in participant account balances served as collateral for loans to participants at December 31, 2024 and 2023, respectively.

(f) PAYMENT OF BENEFITS

On termination of service, a participant may elect to receive a single lump sum payment of the vested value of his or her account or equal installments for a period not exceeding life expectancy. Benefits are recorded when paid. There were no benefit claims for participants who have elected to withdraw from the Plan but have not yet been paid as of December 31, 2024.

(g) FORFEITURES

Forfeitures of terminated participants' non-vested accounts are used to pay administrative expenses, reduce Organization contributions, or are reallocated to participants as additional Organization contributions. For the year ended December 31, 2024, \$64 in forfeitures was used to reduce employer discretionary matching contributions. As of December 31, 2024 and 2023, respectively, there were \$9,490 and \$6,056 remaining forfeitures available for future use.

(h) ADMINISTRATIVE EXPENSES

The Plan incurs fees and administrative costs which are assessed by a third party administrator. Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported amounts of additions to and deductions from net assets during the reporting period. Although management believes its estimates are appropriate, changes in assumptions utilized in preparing such estimates could cause these estimates to change sometime in the future.

(c) RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments including pooled separate accounts and investment contracts. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment instruments, it is reasonably possible that changes in the values of investment instruments will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

(d) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Contract value is the price at which Plan participants would transact in relation to the contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5, respectively, for disclosure of fair value measurements and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

The principal amounts of loans to participants administered by TIAA and CREF are issued directly from TIAA and CREF and not out of Plan assets. Accordingly, loans to participants are not included in plan assets. Repayments are made to TIAA and CREF and not to the Plan. The amount of loans that are secured by the plan assets is disclosed (see Note 1e).

(f) SUBSEQUENT EVENTS

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through July 22, 2025, the date these financial statements were available to be issued. No such material events or transactions were noted to have occurred.

NOTE 3 - INVESTMENTS

The Plan's funds are maintained by American United Life Insurance Company (AUL), a OneAmerica company, Teachers Insurance and Annuity Association of America and College Equities Fund (TIAA), and Voya Retirement Insurance and Annuity Company (VOYA), the custodians of the Plan. The Plan's funds are credited with actual earnings on the underlying investments and charged for Plan withdrawals. The Plan's funds in the financial statements as of December 31, 2024 and 2023 are the values as reported to the Plan by the AUL, TIAA and VOYA.

The following was certified as being complete and accurate by the AUL, TIAA, and VOYA:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Supplementary schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the statements of net assets available for benefits and statement of changes in net assets available for benefits and the supplementary schedule of assets (held at end of year).

Upon enrollment in the Plan, participant may direct contributions to any of the investment options maintained by AUL. Participants may change their investment options at their discretion.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan adopted the fair value accounting standards for those assets that are re-measured and reported at fair value at each reporting period. This standard establishes a single authoritative definition of fair value, sets out a framework for measuring fair value based on inputs used, and requires additional disclosures about fair value measurements. This standard applies to fair value measurements already required or permitted by existing standards.

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(a) In accordance with FASB ASC 820, certain investments that were measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables above are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The following is a description of the valuation methodologies used for assets measured at net asset value:

Investment in Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year-end, which is determined by dividing net assets at fair value by units outstanding. The investment strategy for the pooled separate accounts is to mirror the investment profile of the mutual fund of the same name. Investments in the pooled separate accounts have no unfunded commitments as of December 31, 2024 and 2023. The redemption frequency and redemption notice period for the pooled separate accounts is daily.

Non-benefit-responsive investment contracts: Valued at fair value by discounting the related cash flows by a risk-adjusted discount rate which correlates closely with the investment contract's historical crediting rates. The fair value calculated using the risk-adjusted discount rate does not differ materially from contract value. As such, the investment contracts are reported at contract value, which is considered by plan management to be a reasonable and materially accurate approximation of fair value. Contract value equals the total cash contributions, transfers, and interest credited to the contract, less the total of withdrawals, transfers and administrative expenses deducted from the contract.

AUL and TIAA maintain the contributions in a general account. The AUL account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The TIAA contract is credited with interest at a guaranteed minimum rate of 3% and any additional amounts as declared by the TIAA Board of Trustees. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract does not permit AUL or TIAA to terminate the agreement prior to the scheduled maturity date.

Participant contributions to the contracts with TIAA are made under TIAA's Group Supplemental Retirement Annuity (GSRA). Amounts invested in the contracts under the GSRA are individually owned via certificates and are fully benefit-responsive. Because the TIAA and AUL investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for plan benefits attributable to the fully benefit-responsive investment contracts. Contract value, as reported to the Plan by the Insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Employer contributions to the contracts are made under TIAA's Group Retirement Annuity (GRA). Amounts invested in the contracts under the GRA are also individually owned via certificates, but are non-benefit-responsive. Lump-sum withdrawals are permitted from these contracts within 120 days following termination of employment and are subject to a 2.5% surrender charge. Participant-initiated transfers or withdrawals may only be made in ten annual installments over a period of nine years plus a day. Participant-initiated withdrawals following termination of employment (other than lump-sum withdrawals as described above) are limited to five annual installments.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued)

Additionally, the Plan holds non-benefit-responsive investment contracts with Voya. Voya maintains the contributions in a general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participants may withdraw funds from the contracts without restrictions for death, premium for an annuity, financial hardship, separation from service, and other forms of payments, as defined in the Plan document. Other participant withdrawals are subject to surrender charges as follows:

NOTE 6 - TAX STATUS

The prototype Plan obtained its latest determination letter on November 22, 2017, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain investment instruments are managed by AUL, TIAA, and VOYA, the custodians as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organizations has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in their employer contributions, and the assets will be allocated to each participant in the proportion each account balance bears to the total of all account balances.
