Independent Auditor's Report

To the Plan Administrator of
Greater Boston Legal Services Pension Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Greater Boston Legal Services Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF PLAN

The following description of Greater Boston Legal Services Pension Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a discretionary contribution tax-deferred retirement savings plan designed under the Internal Revenue Code (IRC) Section 403(b), covering substantially all employees of Greater Boston Legal Services, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan Administrator reports to the Plan Sponsor's Board of Directors.

b. Eligibility

Employees are eligible to participate in the Plan and may contribute to the Plan upon hire. The Plan excludes non-resident aliens from all contributions. The Plan excludes employees who normally work less than twenty hours per week, student interns, fellows, and non-permanent employees from receiving discretionary non-elective employer contributions. Employees who have completed two years of service, attained the age of eighteen, and those who are not considered "highly compensated employees", as defined by the plan document, are eligible for discretionary non-elective employer contributions. Discretionary non-elective employer contributions are divided into two tiers:

Tier One: Full-time eligible employees who worked for the Plan Sponsor the entire plan year receive one Tier One credit, which is a notional dollar amount determined by the Plan Sponsor. Part-time eligible employees receive a fraction of a Tier One credit proportionate to the percentage of hours worked compared to a full-time employee. If an eligible employee terminated their employment with the Plan Sponsor during the plan year, they will receive one twelfth of one credit for each month of employment that the employee worked at least sixteen days.

Tier Two: Eligible employees receive one Tier Two credit for each year of employment with the Plan Sponsor and one Tier Two credit for each year of employment with an eligible employer prior to their employment with the Plan Sponsor. Employees who become eligible employees during the plan year will receive an additional Tier Two credit. The total Tier Two non-elective employer contribution fund is a notional dollar amount determined by the Plan Sponsor. An eligible employee's share of the funding available under Tier Two is determined by dividing their Tier Two credits by the aggregate amount of Tier Two credits, including credits earned by highly compensated employees. Unless the cause for termination is death, disability, or normal retirement age, eligible employees must be employed by the Plan Sponsor on the last day of the plan year to receive any Tier Two credits.

c. Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined in the plan document, up to the maximum allowed by the IRC. Participants who have attained age fifty before the end of the plan year are eligible to make annual catch-up contributions.

1. DESCRIPTION OF PLAN (Continued)

c. Contributions (Continued)

Participants may also contribute amounts distributed from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan was amended to allow participants to make post-tax (Roth) contributions.

For the year ended December 31, 2024, the Plan Sponsor made discretionary non-elective contributions totaling \$504,936.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's discretionary non-elective contribution, and an allocation of plan earnings. Participants taking loans and distributions are charged processing and administrative fees. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

e. Vesting

Participants are immediately vested in their contributions and the Plan Sponsor's discretionary non-elective contributions plus earnings thereon.

f. Payment of Benefits

Upon attaining normal retirement age of 65 or termination of services, a participant may elect to receive either a lump-sum equal to the value of the participant's vested account balance, a partial withdrawal, installments, or leave their balance in the Plan if their balance is over \$5,000. There is no option for early retirement. The Plan requires balances up to \$5,000 to be paid out to participants upon termination. Effective January 1, 2024, the involuntary distribution amount was increased to \$7,000 per the SECURE 2.0 Act. There are also retirement benefits available upon disability or death.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant could also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

g. Notes Receivable from Participants

Loans may be made to participants. Notes receivable from participants are secured by the balance in the participants' accounts. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested account balance. The maximum repayment term is five years unless the loan proceeds are used to acquire a principal residence, in which case the term can be no longer than ten years. Participants may only have one outstanding loan at any given time. The interest rate is set at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and qualified institution. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual funds, at fair value, includes realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There was no allowance for credit losses as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded. For the year ended December 31, 2024, there were no defaulted loans.

Contributions

Contributions from plan participants are recorded in the year which the participant contributions are withheld from compensation. Employer discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's investment transaction and asset management fees are allocated to the individual participant accounts as a reduction of investment return in accordance with the plan document. The Plan's administrative fees, which consist primarily of fees paid to the Plan's qualified institution, third-party administrator and audit fees, are reflected as administrative expenses in the accompanying statement of changes in net assets available for benefits. During 2024, revenue sharing income was used to offset administrative expenses (see Note 7).

Subsequent Events

Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

4. FAIR VALUE MEASUREMENT (Continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are measured using Level 1 inputs.

There has been no change in the methodology of determining fair value used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determinate the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated January 2, 2018, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution of the Plan and notes receivable from participants are considered party-in-interest transactions.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to Reliance Trust Company for its administrative services to the Plan. During 2024, the Plan paid the qualified institution, third-party administrator and auditor administrative expenses totaling \$55,732, which is presented net of \$3,659 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
