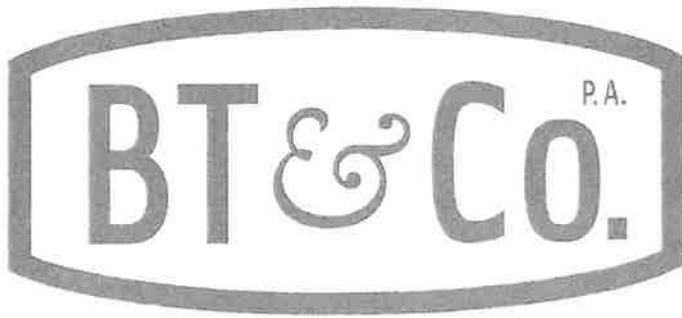

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for Employees of Bethany for Children and Families (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. 1 - Description of the Plan

The following description of the 403(b) Thrift Plan for Employees of Bethany for Children and Families (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan organized under Section 403(b) of the Internal Revenue Code and covers employees of Bethany for Children and Families (the Company). Employees are eligible to make elective deferrals beginning on their hire date. The Plan excludes non-resident aliens and employees who are eligible to make salary reduction contributions to another plan of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Company's Board of Trustees is responsible for oversight of the Plan. Management of the Plan determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute a percentage of their annual compensation, as defined by the Plan. Participants elect to have their salary deferrals as pre-tax contributions, or on an after-tax basis as a Roth deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes an employer base contribution equal to 8% of eligible compensation. Employees are qualified to receive employer base contributions once they have completed one year of service and have reached 21 years of age. Employer base contributions are participant-directed. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Company's base contributions, if applicable, and Plan earnings and is charged for any withdrawals or distributions made by the participant and the participant's share of administrative fees and expenses paid out of the Plan, if any. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's employer base contributions and the earnings thereon is based on years of continuous service. A participant is 100% vested after four years of continuous service. There is no partial vesting for years of service less than one year.

Payment of Benefits

A distribution of a participant's vested interest may be requested upon termination of employment by the employee or in the event of a disability or death. Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Adoption Agreement and permitted by the Internal Revenue Code. Hardship withdrawals are available from employee and vested employer contributions. Participants who have obtained the age of 59½ may also elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment or regularly scheduled monthly withdrawals of at least \$ 100.

Cash and Cash Equivalents

The Plan's cash consists of cash in Mutual of America's Interest Accumulation Account. Cash equivalents represent money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes. At December 31, 2024 and 2023 the balance of cash equivalents in the Plan was \$ 485,430 and \$ 600,761, respectively.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$ 5 and \$ 3,130, respectively. Forfeitures are used to reduce future employer contributions. For the year ended December 31, 2024, employer base contributions were reduced by \$ 65,806 from forfeited nonvested accounts.

Administrative Expenses

Certain Plan administrative expenses are paid out of the Plan as a reduction in each participant's account. The Company pays most administrative expenses on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements. Expenses relating to specific participant transactions (i.e., distribution request, etc.) are charged directly against the appropriate participant's account. Investment related expenses are included in net appreciation of fair value of investments.

2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Plan Management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

Subsequent events have been evaluated by management of the Plan through the date of the independent auditors' report, which is the date the financial statements were available to be issued.

 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at market value less operating expenses accrued and not deducted. All pooled separate accounts are valued daily and the Plan's separate account market value at any given date is equal to the Plan's units of participation multiplied by the unit value which is net asset value (NAV). There are no restrictions on redemptions, and there are no unfunded commitments.

- (a) Seeks to achieve capital appreciation and current income by investing varying portions of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and varying portions of its assets in portfolios that invest primarily in equity securities. This Portfolio is designed for the investor to have a short-, medium-, or long-term investment horizon and seek different levels of high current income and potential growth of capital and accept varying levels of risk. Also, for investors who want instant and broad diversification with exposure to a wide range of asset classes and investment styles, including domestic and international stocks.
- (b) This investment category seeks high levels of current income, maximum real return, and preservation of capital, consistent with prudent investment risk/management. This Fund is for investors who want a portfolio of securities that offers a steady stream of investment income and some protection against stock market volatility.
- (c) This investment category seeks long-term capital appreciation and current income consistent with sound common stock investing, seeks to track the performance of various stock indexes for small, mid, and large-capitalization stocks. This Portfolio is for investors who want long-term growth of capital and can accept the inherent risks of investing in stocks of both domestic and international companies.
- (d) Seeks to achieve a high return through a high level of current income and capital growth by investing varying portions of the portfolio's assets in underlying portfolios that invest primarily in fixed-income securities and varying portions of its assets in portfolios that invest primarily in equity securities and short-term investments. This Portfolio is designed for the investor to have a short-, medium-, or long-term investment horizon and seek different levels of high current income and potential growth of capital and accept varying levels of risk. Also, for investors who want instant and broad diversification with exposure to a wide range of asset classes and investment styles, including domestic and international stocks.
- (e) This investment category seeks to provide a high total return through its target retirement date, with a greater focus on income as the target date approaches by primarily investing its assets in passively managed funds using an allocation strategy designed for investors expected to retire around the years 2020-2065. This Portfolio adjusts over time to ensure a noticeable and steady shift from equities to fixed income in the years leading to retirement. This Portfolio lowers exposure to equities, aims to reduce volatility and preserve assets in the years closest to retirement. The most conservative point—45% equity and 55% fixed income—occurs at the retirement date.
- (f) This Fund seeks a high level of investment income and capital growth. This Fund is for investors who want moderate long-term growth of capital, who can accept the inherent risks of investing real estate investment trusts, and who are seeking to benchmark the performance of the MSCI US Investable Market Real Estate 25/50 Index.

6 - Related Party Transactions

Certain Plan investments are shares of mutual funds and a cash equivalent managed by Mutual of America. Mutual of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Some investment management and administrative fees are paid by the Company. Fees paid by the Plan were \$ 1,806 for the year ended December 31, 2024.

7 - Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions will be made to the Plan, and participants would become 100 percent vested in their employer contributions.

8 - Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator and the Plan's Tax Counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
