## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the accompanying financial statements of Maine Bankers Association Employee Benefit Plan (the Plan), which comprise the statement of benefit obligations and net assets available for benefits as of December 31, 2024, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the 2024 financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of the Plan, and the changes in its benefit obligations and net assets available for benefits for the year ended December 31, 2024, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

### Basis for Opinion

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). ## Notes to Financial Statements

December 31, 2024 and 2023

### 1. Description of the Plan

The Maine Financial Institutions Employee Benefits Trust (the Trust) was formed, effective January 1, 1986, for the purpose of funding and administering the Maine Bankers Association Employee Benefit Plan (the Plan) established and maintained by certain Maine financial institutions and affiliates for their respective employees. The following brief description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan provides benefits covering employees (and their eligible dependents) of participating member employer financial institutions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On June 21, 2013, the Plan entered into an Amendment and Restatement of the Agreement and Declaration of Trust, effective January 1, 2014. Under the terms of the Amendment, a "Member" of the Plan must be a financial institution authorized to do business in the State of Maine and a full voting member of the Maine Bankers Association.

The Plan currently operates under an alternative financing agreement with Elevance Health Plans. Under the terms of the Minimum Premium Plan (MPP), the Plan assumes the risk for health plan claims as incurred, up to a stop-loss limit. The specific stop-loss limit was \$250,000 in 2024 and 2023. The specific stop-loss limit is on any participant and the aggregate stop-loss limit is 125% of expected claims. Both limits will be measured on claims incurred in the 2024 calendar year and paid through June 30, 2025. For the years ended December 31, 2024 and 2023, the Plan had stop-loss recoveries totaling \$1,755,517 and \$1,235,657, respectively, which were netted against claims paid for health benefits. Member banks pay set premiums developed by the Plan's consulting actuary, and the manner in which the banks are billed monthly remains the same as in prior years. Plan reserves at December 31, 2024 and 2023 were \$7,583,159 and \$7,859,114, respectively, and were sufficient to cover the maximum liability under the risk-sharing arrangement.

#### Benefits

The Plan includes health, life, accidental death and dismemberment, hospital, surgical, prescription drug, dental, vision, accident expenses, basic and major medical, and long- and short-term disability coverage.

#### Termination of Plan

The Plan, acting by and through its Board of Trustees, has the right to modify or terminate the Plan in its entirety, or any portion thereof, at any time.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Receivables

The Plan extends unsecured credit in the normal course of business to its member banks. Effective January 1, 2023, the Plan accounts for estimated credit losses on financial assets measured at an amortized cost basis in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 326-20, Financial Instruments - Credit Losses. FASB ASC 326-20 requires the Plan to estimate expected credit losses over the life of its financial assets as of the reporting date based on relevant information about past events, current conditions, and reasonable and supportable forecasts. The Plan records the estimate of expected credit losses as an allowance for credit losses. For financial assets measured at an amortized cost basis, the allowance for credit losses is reported as a valuation account on the statement of benefit obligations and net assets available for benefits that adjusts the asset's amortized cost basis. Changes in the allowance for credit losses are reported as credit loss expense or benefit in the statement of changes in benefit obligations and net assets available for benefits. As of December 31, 2024 and 2023, the Plan did not have an allowance for credit losses. The Plan adopted ASC 326-20 using the modified retrospective method which did not result in any impact to net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

#### Contributions

Participating financial institutions contribute a portion of the contributions to the Plan pursuant to the agreement between the institution and the Plan. The participating employees contribute the remaining contributions.

### **Administrative Income**

Administrative income includes amounts received from various insurance carriers under administrative support agreements.

### **Claims Incurred but Not Reported**

Plan obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's actuary in accordance with the accepted actuarial principles based on claims data provided by the Plan's claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

### **3. Cash, Certificates of Deposit, and U.S. Treasury Securities**

The Plan maintains its cash accounts in various banks located in Maine. Cash and certificates of deposit accounts at each bank are insured by federal agencies up to \$250,000. The Trustees adopted investment objectives and guidelines authorizing investments in certificates of deposit, U.S. Treasury Securities, a business money market deposit account, and one or more collateralized or insured cash sweep arrangements. Deposit balances in financial institutions generally will not exceed the Federal Deposit Insurance Corporation (FDIC) insured limit. However, at times deposit balances may exceed the FDIC insured limit due to accrued interest.

### **4. Fair Value Measurement**

FASB ASC Topic 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Certificates of deposit:* Fair value of certificates of deposit is estimated using a discounted cash flow analysis that applies interest rates currently being offered by a financial institution on certificates to a schedule of aggregated contractual maturities on such time deposits.

*U.S. Treasury Bills:* Fair value of the U.S. Treasury Bills are estimated by reducing the face value by the discount. The discount is amortized over the life of the U.S. Treasury Bills.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Benefit Obligations

Health costs incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan.

### 6. Federal and State Income Taxes

Prior to January 1, 2010, the Trust established to hold the Plan's net assets was considered a taxable trust for federal and state income tax purposes. The tax was based upon the Trust's income during the period on a modified cash basis. Deferred taxes were recorded based on the timing differences between the modified cash basis of accounting for taxable income and the accrual basis of accounting for financial statement income. As of January 1, 2010, the Trust received exempt status under Code Section 501(c)(9), Voluntary Employees' Beneficiary Associations, of the Internal Revenue Code.

Management has determined that the Plan has no uncertain tax positions that require adjustment to the financial statements. The Plan is currently open to examination under the statute of limitations by the Internal Revenue Service for the years ended December 31, 2021 through 2024.

### 7. Approved Use of Reserves

The Trustees voted to use reserves to subsidize the Wellness Program in 2024 and 2023. The total Wellness Program subsidy paid from reserves was \$673,661 and \$720,224 for the years ended December 31, 2024 and 2023, respectively.

In 2023, the Trustees voted to use reserves to subsidize one month of health insurance premiums for the Members. The Member premiums paid from reserves were \$2,468,753 for the year ended December 31, 2023. There were no such subsidies in 2024.

### 8. Related Parties

The Plan and Maine Bankers Association (the Association) are related through common members and the Association is the sponsor of the Plan. The Association and its employees also participate in the Plan. Association Services, Inc. (ASI) and Community Banks Insurance Agency (CBIA) are wholly-owned subsidiaries of the Association. CBIA is a licensed insurance agency and the broker for some of the insurance programs under the Plan. Commissions that are paid to CBIA by insurance carriers are then remitted to the Plan.

Administrative income from CBIA during the year ended December 31, 2024 amounted to \$36,098.

During the year ended December 31, 2024, the Plan recorded income of \$34,251 from Delta Dental Plan of Maine, a party-in-interest, under an administrative support service agreement. This amount is included in administrative income.

The Association provides administrative services to the Plan. Reimbursement expenses of \$843,223 were incurred by the Plan for the year ended December 31, 2024, and were included in administrative fees.

ASI allocates equipment costs to the Plan, including computer and other equipment during the estimated useful life of the equipment. The Plan incurred a total cost of \$12,974 for allocated equipment during the year ended December 31, 2024, which is included in computer expense.

The Plan is charged a usage fee by ASI for equipment that remains in service after the estimated useful life, which is calculated on an allocable share of equipment residual value calculated at 20% of the original cost. The Plan also pays ASI a usage fee for the use of laptops and other equipment during committee meetings, training sessions, and re-enrollment workshops, rather than paying rental fees typically associated with function facilities. Total usage fees paid to ASI amounted to \$5,697 during the year ended December 31, 2024 and is not included in the allocated equipment expense above.

Fees paid to Business Solver, a party-in-interest, for enrollment and billing services amounted to \$104,595 for the year ended December 31, 2024.

Fees paid to WEX, Inc., a party-in-interest, for contract administrative services amounted to \$7,636 for the year ended December 31, 2024.

Fees paid to Wellness Workdays, Inc., a party-in-interest, for wellness program services amounted to \$494,468 for the year ended December 31, 2024.

Fees paid to Hello Heart, Inc., a party-in-interest, for heart wellness program services amounted to \$179,193 for the year ended December 31, 2024.

Fees paid to Berry Dunn McNeil & Parker, LLC, a party-in-interest, for audit, tax, and consulting services amounted to \$52,221 for the year ended December 31, 2024.

Fees paid to Health Axis, a party-in-interest, for consulting services amounted to \$33,444 for the year ended December 31, 2024.

Fees paid to NovaRest, Inc., a party-in-interest, for actuarial consulting services amounted to \$12,500 for the year ended December 31, 2024.

Fees paid to LearnYour WorkLife, Inc., a party-in-interest, for communication services amounted to \$14,110 for the year ended December 31, 2024.

### 9. Subsequent Events

Management has made an evaluation of subsequent events up to April 4, 2025, which was the date the financial statements were available to be issued and determined that any subsequent events that would require recognition or disclosure have been considered in the preparation of the financial statements.
