Our opinion is not modified with respect to this matter.

NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of the OnProcess Technology, Inc. (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was established by the Company on January 1, 2005. The Plan was a defined-contribution plan covering all full-time employees who were age 18 or older and have been employed with the Company for three months, except for those who were leased employees or nonresident aliens. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination: The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Board of Directors of the Company voted to terminate the Plan effective December 27, 2023. Contributions to the plan were frozen at that time. As a result, the Plan has presented the financial statements on the liquidation basis of accounting. Participants became fully vested in their accounts as a result of the termination. All Plan assets were distributed out to participants on December 5, 2024.

Participant Contributions: Each year, participants could contribute up to 100% of their annual compensation up to the maximum dollar amount allowable under the Internal Revenue Code ("IRC"), as defined by the Plan. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers.

Participants could designate a portion, or all, of their deferred contributions as Roth contributions, which were includable in the participant's gross income.

Employer Contributions: Through the date of termination, the Company elected to make Safe Harbor matching contributions in an amount equal to 100% of the first 3% and 50% of the next 2% of eligible compensation for those who were eligible to participate in the Plan during the Plan year. These contributions satisfied certain IRC requirements and eliminated the need for the Plan to perform certain annual non-discrimination tests. Participants were 100% vested in these contributions when made.

The Company could make annual discretionary non-elective employer contributions and additional discretionary matching contributions in an amount to be determined at the Plan year end by the Board of Directors. A participant must complete one year of service to be eligible to receive these discretionary contributions. For the period ended December 5, 2024, the Company did not make any discretionary employer contributions.

Participant Accounts: Each participant's account was credited with the participant's contributions, the Company's contributions, and Plan earnings or losses. Allocations of earnings or losses were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Investment Options: Participants directed the investment of their contributions into various investment options offered by the Plan.

Benefit Payments: For termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or periodic installment distributions. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals from the Plan were available to participants before leaving the Company for special hardship reasons and after attaining the age of 59½. An automatic distribution was made for terminated participants with vested account balances of less than \$5,000.

Notes Receivable from Participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balances, whichever was less. Loan transactions were treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms could not exceed five years unless the proceeds were used for the purchase of a primary residence. Loans were secured by the balances in the participants’ accounts and bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that could be made under similar circumstances and ranged from 3.50% to 9.50% before termination of the Plan. Principal and interest were paid ratably usually through bi-weekly payroll deductions but must be paid on at least a quarterly basis.

Calculation of Vested Benefits: A participant was always 100% vested in their rollover contributions, deferral contributions, Safe Harbor matching contributions, and any earnings thereon.

Prior to the termination of the Plan, company discretionary matching and non-elective contributions and earnings were vested in accordance with the following vesting schedule:

Forfeited Accounts: At December 31, 2023, forfeited non-vested accounts totaled \$261. These accounts could be used to reduce future employer contributions or Plan expenses. During the period January 1, 2024, through December 5, 2024, the Plan Sponsor utilized \$1,768 of forfeitures to pay Plan expenses.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan were prepared under the liquidation basis and accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements were prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value is the price that could be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and other parties involved with the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Benefits were recorded when paid.

Administrative Fees: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participants' account and were included in administrative expenses. Investment related expenses were included in net the appreciation of fair value of investments.

Uncertain Tax Positions: GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 5, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 5, 2024, or December 31, 2023. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following was a description of the valuation methodologies used for assets measured at fair value at December 31, 2023. There were no assets at fair value at December 5, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described could produce a fair value calculation that could not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets held for investment at December 5, 2024.
