Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the Urology Healthcare Group, Inc. 401(k)/Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution multiple employer plan adopted to provide retirement benefits for employees of Urology Healthcare Group, Inc. dba CIMply, (the "Company"). The Plan covers substantially all employees who are age twenty-one or older and have completed six months of employment (as defined in the plan agreement) (participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The controlled affiliate sponsors participating in the Plan are Mississippi Urology Clinic, PLLC; Mississippi Urology Outpatient Surgery Center, LLC; and Urology Associates, PC. The non-controlled affiliate sponsors participating in the Plan include Gainesville Urology, PC; Gainesville Urology, A.S.C., LLC; Unity Urology, PC; Patrick P. Daily, M.D., PLLC; H. Jason Blalock, M.D., PLLC; John D. Adams, Jr., M.D., P.A.; Mark A. Runnels, PLLC; Columbus Urology Group, PLLC; Greenwood Urological, PA; and Allen M. Haraway, M.D., PLLC. The Company, controlled affiliate sponsors, and the non-controlled affiliate sponsors are collectively the "Employers."

The Plan is administered by the Company. To assist in administration of the Plan, the Company has engaged Acuff & Associates to serve as a consultant for the Plan. The Company has engaged Transamerica Retirement Solutions Corporation (TRSC) to provide recordkeeping services for the Plan, and the Plan has engaged State Street Bank and Trust Company ("State Street") and Transamerica Life Insurance Company (TLIC) to serve as trustees and asset custodians for the Plan.

(b) Contributions

Participants may contribute up to 75% of their annual compensation to the Plan, subject to certain Internal Revenue Code (IRC) limitations. Contributions are deductible by the participants for federal income tax purposes under Section 401(k) of the IRC or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Notes to the Financial Statements

December 31, 2024 and 2023

The Company, at its discretion, determines the amount of matching contributions and profit-sharing contributions to be contributed to the Plan by the Employers. During 2024 and 2023, the Employers matched an amount equal to 80% of each participant's contributions up to 4% of eligible Plan compensation. Also, the Plan is a safe harbor plan, and the Employers comply with safe harbor rules by making a minimum contribution equal to 3% of eligible Plan compensation in the form of a safe harbor non-elective (SHNE) contribution to all eligible participants. In addition, the Employers made discretionary profit-sharing contributions in 2024 and 2023 to eligible participants (as defined in the plan agreement). Profit-sharing contributions are made in an amount equal to a certain percentage of each participant's year-to-date compensation, calculated quarterly, less prior profit-sharing contributions made during the year, which varies depending on the group number of each participant. Typically, for most non-highly compensated participants, the profit-sharing contribution equals approximately 5% of the participant's year-to-date eligible Plan compensation.

Employers and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of the Employers' contributions and investment earnings (losses), and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in employee and SHNE contributions and begin to vest in Employers' matching and profit-sharing contributions after two years of service at a rate of 20% annually. A participant is fully vested in the Employers' matching and profit-sharing contributions after six years of service. In the event of death or disability while employed, a participant becomes 100% vested in the Employers' matching and profit-sharing contributions. Participants also become fully vested upon reaching normal retirement age, which is defined by the Plan as age 62.

(e) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balances in the participants' respective accounts and bear interest at a fixed rate between 5.25% and 10.50%, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, disability, termination or retirement, a participant may elect to receive an amount equal to his or her vested account balance. The form of payment is a lump-sum distribution or monthly installments, except for the portion of the account transferred from the Employers' prior Money Purchase Pension Plan, which may be required to be distributed in the form of a single life annuity or a qualified joint and survivor annuity. The installment forms of payment are limited to a fifteen-year period.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Employers matching or profit-sharing contribution portion of their accounts. Such forfeitures may be used to pay plan administrative expenses or to reduce the Employers' contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$133,400 and \$19,400, respectively. During 2024 and 2023, the Employers' contributions were decreased by approximately \$127,900 and \$96,700, respectively, from forfeited nonvested accounts. Administrative fees totaling approximately \$5,600 were paid from forfeited nonvested accounts during 2023.

(h) Hardship withdrawals

A participant may withdraw all or a portion of his or her elective deferrals (including income or gains allocated to the participants account) if he or she can demonstrate a financial hardship, as defined in the plan agreement. All hardship distributions are made in a single lump-sum payment. Hardship distributions cannot exceed the amount required to meet the immediate financial need created by the participant's hardship.

(i) Administrative expenses

Plan administrative expenses may be paid from forfeited accounts and from the expense budget account established by the Plan. The expense budget account contains amounts deposited by the third party-administrators to be utilized for administrative expenses. Administrative expenses not paid by the Plan or from these accounts, if any, are paid by the Company. A portion of fees incurred by the Plan for the investment management services or recordkeeping are included in net appreciation in fair value of investments. All other fees are charged directly to the respective participants' accounts and are included in administrative expenses.

(j) Plan termination

Although they have not expressed any intent to do so, the Employers have the right under the plan agreement to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair value as reported by State Street except for the fully-benefit responsive investment contract, which is reported at contract value by TLIC. Fair value or contract value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employers determine the Plan's valuation policies utilizing information provided by State Street and TLIC. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold, as well as, held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after the reporting date

The Plan's management has evaluated events and transactions that occurred between December 31, 2024, and July 30, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Summary of certified information

The investments, at fair value and contract value, notes receivable from participants held at December 31, 2024 and 2023, the net appreciation of investments, interest and dividend income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, as reported and disclosed in the financial statements and supplemental schedule, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street and TLIC.

(4) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and Level 3 are not applicable to the Plan.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Interest-bearing cash*: Valued at the outstanding balance as reported by State Street.
- (ii) *Mutual funds*: Valued at the net asset value (NAV) of shares held by the Plan at yearend in an active market. Comprise primarily of equities, mutual funds, and cash equivalents.
- (iii) *Self-directed investments*: Consist primarily of equities, mutual funds, and money market funds and are valued at the last reported sales price on the last business day of the plan year reported by the active markets in which the individual investments are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investment contract with insurance company

The Plan has a fully benefit-responsive investment contract with an insurance company, which is certified by TLIC. The insurance company maintains the Plan's contributions in a pooled account which is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$6,535,253 and \$6,456,963 as of December 31, 2024 and 2023, respectively. The average yield and crediting interest rates were 2.55% and 2.18% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(6) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(7) Income tax status

The Plan obtained a favorable determination letter on January 29, 2013, in which the Internal Revenue Service (IRS) stated that the Plan was in compliance with the applicable requirements of the IRC. The Employers believe that the Plan has been designed to comply with and is operating in accordance with the requirements of the IRC, and therefore, believes the Plan is qualified and exempt from taxation. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Related party transactions

Certain plan investments are interest-bearing cash and an investment contract managed by affiliates of TRSC and State Street, therefore, these transactions qualify as party-in-interest transactions. As described in Note 1, The Plan paid expenses to various service providers and holds notes receivables from participants which qualify as party-in-interest transactions.
