Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Atlas Roofing Corporation 401(k) Profit Sharing Plan for Bargaining Unit Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

The following brief description of Atlas Roofing Corporation 401(k) Profit Sharing Plan for Bargaining Unit Employees (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all hourly bargaining unit employees of Atlas Roofing Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participation

Eligibility is dependent upon the location of the employee. Employees are generally eligible to enter the Plan on the first day of the week in which they will complete the probationary period for their location. The probationary period for each location is as follows:

Probationary Location	Period
Meridian, Mississippi	90 days
Ardmore, Oklahoma	90 days
Daingerfield, Texas	90 days
Franklin, Ohio	90 days
Hampton, Georgia	60 days

Participant Contributions, Rollovers and Transfers

Each year, employees elect participation in the Plan by making a compensation deferral not to exceed 70 percent of total annual compensation, subject to regulatory limitations. The Plan allows pre-tax and after-tax ("Roth") contributions into the Plan. An additional catch-up contribution is also allowed for the year if an employee reaches age 50 by the end of the Plan year. Participants direct the investment of their contributions into various investment options offered by the Plan, which they may change daily. Participants may also transfer certain vested account balances to or from other qualified benefit plans, subject to regulatory requirements. Transfers to and from the Plan represent transfers to and from other qualified plans within the controlled group. Rollovers represent transfers from qualified plans not sponsored by entities within the controlled group. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set as 5 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Company Contributions

For participants of the Meridian, Mississippi location, the Company contributions are 100 percent of participant compensation deferrals not to exceed 4.50 percent of compensation.

For participants of the Ardmore, Oklahoma location, the Company contributes 3.50 percent of compensation on all hours worked each pay period. The Company also matches 25 percent of each dollar for the first 2 percent of participant contributions.

For participants of the Daingerfield, Texas location, the Company contributes 4.00 percent of compensation on all hours worked each pay period. The Company also matches 25 percent of each dollar for the first 3 percent of participant contributions.

For participants of the Franklin, Ohio location, the Company contributes 3.75 percent of compensation on all hours worked each pay period. The Company also matches 25 percent of each dollar for the first 4 percent of participant contributions.

For participants of the Hampton, Georgia location, the Company contributes 3.00 percent of compensation on all hours worked each pay period. The Company also matches 25 percent of each dollar for the first 4 percent of participant contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of the Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

At the Meridian, Mississippi location, participants' interests in Company contributions, including allocated earnings or losses thereon, are fully vested after three years of credited service, as defined. At all other locations, participants' interest in Company contributions, including allocated earnings or losses thereon, vest according to the following schedule:

Participant contributions, including allocated earnings or losses thereon, are fully vested at all times.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 (reduced by the highest outstanding loan balance) or (b) the greater of 50 percent of their vested account balances (reduced by any outstanding loan balance) or \$10,000 (reduced by any outstanding loan balance). Note terms range from one to five years, unless used for the purchase of a principal residence, and are collateralized by the participant's account balance.

The notes bear interest at a rate that ranges from 2.25 percent to 7.50 percent for the years ended December 31, 2024 and 2023. Loan interest rates are set to commensurate with the rates available for bank loans of comparable risk with similar terms and durations. Principal and interest payments are made through periodic payroll deductions.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid either by a lump-sum amount equal to the value of the participants' vested interest or periodic payments over an actuarially determined period or rolled over into a qualified plan subject to regulatory requirements. After attaining age 59 ½ a participant may elect to receive an in-service distribution for all or a portion of his or her vested balance. Hardship distributions are also available from participants' elective deferral accounts, excluding income earned on such deferrals as defined by the Plan document, subject to regulatory requirements.

Forfeitures

Forfeitures, which result from participants withdrawing from the Plan prior to vesting in Company contributions, are first applied to reduce Company contributions and then to pay administrative expenses under the Plan which would otherwise be paid by the Company. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$103,272 and \$1,463, respectively. Forfeited amounts applied during 2024 and 2023 were \$59,337 and \$284,017, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded for on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation of investments in the statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan, to the extent that the Company does not pay such expenses, are paid by the Plan. Expenses that are paid by the Company are excluded from the financial statements. Expenses that relate solely to a specific participant are assessed against such participant as provided in the Plan document.

Note 3. Information Certified and Provided by Principal Life Insurance Company and Principal Trust Company

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Pooled separate accounts: Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at NAV per share based on quoted market prices of the underlying investments (Level 2).

Collective investment trusts: The collective investments trusts include the Principal Stable Value Z Fund ("Fund") and Principal LifeTime Hybrid Collective Investment Trusts ("CITs") (Level 2).

Note 4. Continued

The Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The objective of the Fund is to provide preservation of capital with relatively stable returns. The Fund is valued at NAV, as reported by investment managers of the Fund and are supported by unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date resulting in a readily determinable fair value. Participant transactions and redemptions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require twelve month advance written notice. As of December 31, 2024 and 2023, there were no unfunded commitments.

CITs invest in a collective trust fund as well as a variety of separate accounts and mutual funds that seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor with a specific target retirement date. These are valued at NAV per unit held by the Plan at year-end as reported by the custodians, which is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Plan Termination

Although the Company has not expressed any intent to terminate the Plan agreement, it may do so at any time subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants would become fully vested and the assets of the Plan, after payment of expenses, would be distributed to the participants.

Note 7. Income Tax Status

The Plan has adopted a volume submitter plan sponsored by Principal. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Note 8. Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities. Investment securities are exposed to several risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date these financial statements were available to be issued.
