Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have audited the accompanying financial statements of Allen Organ Company Savings and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Allen Organ Company Savings and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF PLAN

The following description of the Allen Organ Company Savings and Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

Allen Organ Company Savings and Profit Sharing Plan was adopted effective November 1, 1994 by the Plan's original sponsor Allen Organ Company (Company).

The Plan is a defined contribution plan maintained by the Company to enable its eligible employees to provide for their future security by deferring a portion of their compensation and sharing in their employer's profits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company shall be eligible to participate in the salary deferral arrangement and Company matching contributions after attaining age 18 or older and completion of three months of services. Employees enter the Plan on the first day of each plan quarter following the completion of the eligibility requirements. Employees shall be eligible to participate in Company profit sharing contributions after attaining age 18 or older and completion of 12 months of consecutive service with a minimum of 1,000 hours worked.

Contributions

Each year, participants may contribute up to the maximum permissible by law, before federal income taxes are applied, provided that the total employee and employer contributions do not exceed 100% of the participants' eligible salary. In addition, participants who are over age 50 are entitled to defer an additional amount to the Plan. The Company, at the discretion of its Board of Directors, may make annual profit sharing and matching contributions. Discretionary profit-sharing contributions made on behalf of eligible participants of the Company are allocated based on gross wages. Total discretionary profit sharing contributions were \$74,254 and \$75,873 for the years ended December 31, 2024 and 2023, respectively. The Company matches employee contributions of 50% up to 4% of eligible compensation. The Company matching contributions were \$93,971 and \$96,214 for the years ended December 31, 2024 and 2023, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Both employee and employer contributions are invested as directed by the participants. The Plan offers various pooled separate accounts.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the employer's contributions, Plan earnings and fees. The allocations are based on participant earnings or account balances as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus related earnings thereon. Vesting in the employer's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of Benefits

On retirement, death, disability, attainment of age 59½ or termination of service, a participant (or participant's beneficiary in the event of death) is eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

Forfeitures

When a participant withdraws from the Plan prior to becoming 100% vested, the participant's unvested portion of their account balances are forfeited and used to reduce employer contributions and plan expenses. There were no amounts forfeited during 2024. During 2023 there were \$1,168 in forfeitures, of which, \$750 were used to reduce fees. The balance of \$418 is reflected as cash in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans receivable from participants are treated as distributions based upon the terms of the plan document.

Participants may borrow from their fund accounts up to the maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed four years except in the case of a loan for the purpose of acquiring a home to be used as a principal residence. The loans are secured by the balance in the participant's account. Interest is charged at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES BASIS OF ACCOUNTING

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investments Held by Custodian

The Plan appointed John Hancock Life Insurance Company as the trustee and custodian of the plan.

Risks and Uncertainties

The Plan has made available several investment funds for participant-directed funds. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Administrative Expenses

The Company pays substantially all the Plan's administrative expenses, excluding contract advisory fees.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through May 22, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments and block discounts are not applied to Level 1 securities. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.

Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3 – Valuation based on inputs that are unobservable and significant to the overall fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued at NAV of units held. NAV is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The objectives of the funds vary based on the nature of the funds, as summarized in the paragraphs following the table below and described more fully in the funds' prospectuses. There are no restrictions on redemptions of the funds and there were no unfunded commitments.

Target Date – Depending on the proximity to its target date, the fund will seek to achieve the following objectives to varying degrees: growth, income and conservation of capital. The fund will increasingly emphasize income and conservation of capital by investing a greater portion of its assets in bond, equity-income and balanced funds as it approaches and passes its target date. In this way, the fund seeks to balance total return and stability over time.

Guaranteed Income – Seeks long term growth of capital while seeking to both manage the volatility of return and limit the magnitude of portfolio losses.

Aggressive Growth – Seeks to achieve long-term growth of capital.

Growth – Seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index.

Growth & Income – Seeks to achieve conservation of capital, current income and long-term growth of capital and income.

Income – Seeks total return consisting of income and capital appreciation.

Conservative – Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, all investment and notes receivable from participants information in the accompanying financial statements and supplemental schedule were obtained or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the trustee.

NOTE 5 INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 RELATED-PARTY TRANSACTION

Certain Plan investments are managed by John Hancock Life Insurance Company, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have audited the accompanying financial statements of Allen Organ Company Savings and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 DESCRIPTION OF PLAN

The following description of the Allen Organ Company Savings and Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

Allen Organ Company Savings and Profit Sharing Plan was adopted effective November 1, 1994 by the Plan's original sponsor Allen Organ Company (Company).

The Plan is a defined contribution plan maintained by the Company to enable its eligible employees to provide for their future security by deferring a portion of their compensation and sharing in their employer's profits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of the Company shall be eligible to participate in the salary deferral arrangement and Company matching contributions after attaining age 18 or older and completion of three months of services. Employees enter the Plan on the first day of each plan quarter following the completion of the eligibility requirements. Employees shall be eligible to participate in Company profit sharing contributions after attaining age 18 or older and completion of 12 months of consecutive service with a minimum of 1,000 hours worked.

Contributions

Each year, participants may contribute up to the maximum permissible by law, before federal income taxes are applied, provided that the total employee and employer contributions do not exceed 100% of the participants' eligible salary. In addition, participants who are over age 50 are entitled to defer an additional amount to the Plan. The Company, at the discretion of its Board of Directors, may make annual profit sharing and matching contributions. Discretionary profit-sharing contributions made on behalf of eligible participants of the Company are allocated based on gross wages. Total discretionary profit sharing contributions were \$74,254 and \$75,873 for the years ended December 31, 2024 and 2023, respectively. The Company matches employee contributions of 50% up to 4% of eligible compensation. The Company matching contributions were \$93,971 and \$96,214 for the years ended December 31, 2024 and 2023, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Both employee and employer contributions are invested as directed by the participants. The Plan offers various pooled separate accounts.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the employer's contributions, Plan earnings and fees. The allocations are based on participant earnings or account balances as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus related earnings thereon. Vesting in the employer's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of Benefits

On retirement, death, disability, attainment of age 59½ or termination of service, a participant (or participant's beneficiary in the event of death) is eligible to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

Forfeitures

When a participant withdraws from the Plan prior to becoming 100% vested, the participant's unvested portion of their account balances are forfeited and used to reduce employer contributions and plan expenses. There were no amounts forfeited during 2024. During 2023 there were \$1,168 in forfeitures, of which, \$750 were used to reduce fees. The balance of \$418 is reflected as cash in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans receivable from participants are treated as distributions based upon the terms of the plan document.

Participants may borrow from their fund accounts up to the maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed four years except in the case of a loan for the purpose of acquiring a home to be used as a principal residence. The loans are secured by the balance in the participant's account. Interest is charged at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES BASIS OF ACCOUNTING

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investments Held by Custodian

The Plan appointed John Hancock Life Insurance Company as the trustee and custodian of the plan.

Risks and Uncertainties

The Plan has made available several investment funds for participant-directed funds. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Administrative Expenses

The Company pays substantially all the Plan's administrative expenses, excluding contract advisory fees.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through May 22, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments and block discounts are not applied to Level 1 securities. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.

Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3 – Valuation based on inputs that are unobservable and significant to the overall fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued at NAV of units held. NAV is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The objectives of the funds vary based on the nature of the funds, as summarized in the paragraphs following the table below and described more fully in the funds' prospectuses. There are no restrictions on redemptions of the funds and there were no unfunded commitments.

Target Date – Depending on the proximity to its target date, the fund will seek to achieve the following objectives to varying degrees: growth, income and conservation of capital. The fund will increasingly emphasize income and conservation of capital by investing a greater portion of its assets in bond, equity-income and balanced funds as it approaches and passes its target date. In this way, the fund seeks to balance total return and stability over time.

Guaranteed Income – Seeks long term growth of capital while seeking to both manage the volatility of return and limit the magnitude of portfolio losses.

Aggressive Growth – Seeks to achieve long-term growth of capital.

Growth – Seeks to achieve the approximate aggregate total return of a broad U.S. domestic equity market index.

Growth & Income – Seeks to achieve conservation of capital, current income and long-term growth of capital and income.

Income – Seeks total return consisting of income and capital appreciation.

Conservative – Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, all investment and notes receivable from participants information in the accompanying financial statements and supplemental schedule were obtained or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the trustee.

NOTE 5 INCOME TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 RELATED-PARTY TRANSACTION

Certain Plan investments are managed by John Hancock Life Insurance Company, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
