Note 1 - Description of the plan

The following description of the Airport Shoppes and Hotel Corp. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2009 as a defined contribution plan, covering all full-time employees, excluding all employees that are covered by a collective bargaining, of Airport Shoppes and Hotel Corp. (the Plan Sponsor), who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security of 1974 (ERISA) and Section 1081.01 of the Puerto Rico Internal Revenue Code (the Code).

Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral specified by local law and those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, subject to the conditions and limitations set forth in the Plan agreement. The initial participant contribution rate will be 3%. The Plan's Sponsor may contribute a discretionary percentage of the amount of the participant's contribution.

Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of: (a) the Plan Sponsor's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested of the Plan Sponsor's contribution after 3 years of credited service. Notwithstanding the above, all participants are 100% vested upon attaining age 65 (not before age 60 and not later than age 65) or, if later, after completing 5 years of participation (not more than 5) in the Plan.

Note 1 - Description of the plan – (continued)

Investment options

The Plan Sponsor and participant's contributions are invested in various investment funds provided by the Trustee, as permitted in the Plan Agreement.

Notes receivable from participants

Notes receivable from participants are not permitted.

Excess participant's contribution payable

Participants may contribute excess contributions which will be reimbursed to the participants. Excess contributions are recorded as a liability in the statements of net asset available for benefits and as a reduction of participant-directed contributions for the year.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon a participant's termination from the employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan Sponsor's contributions on behalf of the participants not then vested are forfeited and used first to reduce the Plan's administrative expenses and then to reduce future Plan Sponsor's contributions. At December 31, 2024 and 2023, the forfeitures account balance amounted to \$13,908 and \$13,179, respectively.

Administrative expenses

Administrative expenses, unless paid directly by the Plan Sponsor, will be paid from the trust fund and will be charged against participant's accounts.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting and presentation

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) and under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Note 2 - Summary of significant accounting policies – (continued)

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the *AICPA Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. At December 31, 2024 and 2023, there were benefits payable owed to the participants of \$169 and \$2,585, respectively.

Note 3 - Information certified by the trustee (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Plan, BPA Trust Company of PR (the Trustee), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the related notes to the financial statements, and the supplemental schedule H, Part IV line 4i - Schedule of Assets (held at end of year) as of December 31, 2024. The Trustee maintains all records, executes investment transactions, and holds all the assets of the Plan.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$175,197.

Note 4 - Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework, for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds are valued at the net asset value of shares held by the Plan at year end. Mutual funds are classified as Level 1.

Collective investment trust is valued based on the relative interest of each participating investor in the fair value of the underlying assets of each of the respective common collective trusts. Collective investment trusts are classified as Level 2.

Insurance contract is valued at fair value by the insurance company. Insurance contracts are classified as Level 3.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Delinquent participant contributions

During the year ended December 31, 2024, the Plan Sponsor did not remit certain participants contributions to the Plan in a timely manner, as defined by ERISA, amounting to \$7,345. As of December 31, 2024, participant accounts were pending to be credited by the estimated investment income that would have been earned had these participant contributions been remitted on a timely basis.

Note 6 - Non-Discrimination Test and excess contributions

During the year ended December 31, 2024, the Plan did not complied with the discrimination (ADP) test. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01 of the Code. Since the participant reached the age of 50, is eligible to defer money in excess of the limits of the Plan. These monies are referred to as “Catchup Contributions”. Such limits include, but are not limited to, the 402(g) maximum deferral limit and a plan-imposed maximum deferral limit. Also eligible for reclassifications as “Catchup Contribution” are corrective distributions to HCEs due to failure of the ADP test. The Plan Sponsor elected the option mentioned above and reclassified the excess contribution of \$311 as a catch-up contribution for the year ended on December 31, 2024.

Note 7 - Tax status

The Plan constitutes a qualified plan exempt from income taxes under the provision of Section 1081.01 of the Code, as amended.

The Plan obtained its latest determination letter on April 19, 2018, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Management has evaluated the Plan tax position and concluded that the Plan has maintain its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements.

Note 8 - Subsequent events

The Plan has evaluated subsequent events through July 17, 2025, which is the date these financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date and to the date the financial statements were available to be issued, that would require additional adjustment to, or disclosure in the financial statements.
