Basis for Opinion

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to the prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Doll Distributing LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Doll Distributing, LLC (the Company) who have completed 90 days of service. The entrance date is the first day of the calendar month after the completion of 90 days of service. The employees are eligible for matching contributions beginning the January 1 and July 1 after reaching one year of employment and completing 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions - Each year, participants may contribute up to 100 percent of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective January 1, 2024, the Plan added a provision that automatically enrolled participants will have the deferral percentage automatically escalated by 1 percent each year up to a maximum of 10 percent of compensation. For the years ended December 31, 2024 and 2023, the Company's discretionary matching percentage was 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. The matching Company contribution is invested as directed by the participant. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of service, or after reaching normal retirement age of 60.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is commensurate with local prevailing rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

NOTE A - DESCRIPTION OF PLAN - Continued

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. There were no unpaid distributions that have been requested as of December 31, 2024 and 2023.

Forfeited Accounts - At December 31, 2024 and 2023, the balances of forfeited non-vested accounts were \$402 and \$309, respectively. These accounts will be used to pay administrative expenses or to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$23,101 and \$20,504, respectively, from forfeited non-vested accounts. In addition, no administrative expenses were paid from forfeited non-vested accounts during 2024 and 2023.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Certified Investments - Information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company).

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). All investments held by the Plan are valued using unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has ability to access (Level 1).

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE D - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian for the Plan, and, therefore, these transactions qualify as party in interest transactions.

Fees incurred and paid directly by the Plan for the investment management services were \$94,607 and \$88,862 for the years ended December 31, 2024 and 2023, respectively. Fees related to contract administrative services were \$20,323 and \$21,584, for the years ended December 31, 2024 and 2023, respectively.

Effective June 1, 2014, Principal Trust Company provides certain administrative services to the Plan pursuant to a Service and Expense Agreement between the Company and Principal Trust Company. Principal Trust Company receives revenue from mutual fund service providers for services Principal Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Principal Trust Company for its administrative services to the Plan. Total revenue sharing credit offsetting administrative fees were \$24,124 and \$38,541 for the years ended December 31, 2024 and 2023, respectively. In addition, Principal Trust Company has a program that incentivizes the Plan's contract administrator to hold funds with Principal Trust Company. Through this program, the Plan's investment manager received \$21,240 and \$20,824 of funds from Principal Trust Company in 2024 and 2023, respectively, which was used to offset the Plan's administrative expenses.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE F - TAX STATUS

The Plan has adopted a non-standardized form of a prototype plan sponsored by Goldleaf Partners, the Plan Administrator. The Internal Revenue Service has determined and informed the prototype plan by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H - AMOUNTS OWED TO FORMER PARTICIPANTS

At December 31, 2024 and 2023, \$4,804 and \$10,712, respectively, were due to participants who had withdrawn from the Plan.

NOTE I - PLAN AMENDMENTS

Effective January 1, 2024, the Plan was formally amended to implement the Setting Every Community Up for Retirement Enhancement Act (SECURE Act). The SECURE Act allows employees who work at least 500 hours in three consecutive years eligibility status to participate in the Plan; however, employer contributions for such employees are not required. These employees may be eligible to enter in Plan year 2024. In addition, effective January 1, 2020, the SECURE Act increases the required minimum distribution age to 72 and will allow qualified birth and adoption withdrawals.

On December 29, 2022, the SECURE Act 2.0 was enacted into law. As of December 31, 2024, no formal amendments have been adopted by the Plan. The Plan is required to formally amend the Plan document by December 31, 2026, but must operate within the provisions within the effective date of each new provision. Effective January 1, 2023, the SECURE Act 2.0 increased the required minimum distribution age to 73. Effective January 1, 2024, the SECURE Act 2.0 increased the mandatory distribution threshold from \$5,000 to \$7,000. For the 2025 plan year and forward, long-term part-time (LTPT) employees who have two consecutive years with greater than 500 hours and less than 1,000 hours in each year (2023 – 2024 plan years) and are at least age 18 are eligible to make deferral contributions to the Plan beginning January 1, 2025. Plans may exclude LTPT employees from eligibility for employer contributions.

Effective January 1, 2024, the Plan was amended to include an auto-escalation feature, which results in automatic enrollment of 3% of eligible compensation, and the automatic deferral amount will increase by 1% of compensation up to a maximum of 10% of compensation. The increase is applied as of the first period that begins after the period in which the initial deferral amount was withheld and will occur at the beginning of each subsequent plan year.
