Independent Auditors' Report

To the Managers of Creare LLC:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Creare 401(k) Savings and Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Creare 401(k) Savings and Retirement Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Creare 401(k) Savings and Retirement Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Creare 401(k) Savings and Retirement Plan and Trust's ability to continue as a going concern for a reasonable period of time.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan:

The following brief description of the Creare (“Company”) 401(k) Savings and Retirement Plan and Trust (“Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of Creare, LLC and Edare, LLC other than those subject to a collective bargaining agreement, non-resident aliens, leased employees, temporary employees or on-call employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions – Participants are allowed to elect to defer up to one hundred percent (100%) of pre-tax annual compensation. The Plan also allows participants to defer funds as a Roth 401(k) deferral. These deferrals are subject to federal and state income taxes. Pre-tax and Roth deferrals are subject to annual dollar limitations established by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover), and participants that are 50 years old or older can make additional “catch-up” contributions. The Plan includes an automatic enrollment feature, under which newly hired employees are automatically enrolled in the Plan with a 1% deferral election. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, a money market, and a common collective trust as investment options for participants. The Plan is designed as a safe harbor plan. Unless specifically excluded, the Company will make a non-elective safe harbor contribution of 3% of eligible compensation, as defined in the plan document, to participant accounts. The Plan also contains provisions for an additional discretionary employer contribution. No discretionary contributions were made during the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s voluntary contribution, an employer non-elective safe harbor 3% contribution, an allocation of the Company’s discretionary contribution, if any, and investment income. Allocations of the Company’s discretionary contribution are made pro-rata, based on a uniform percentage of plan compensation. Allocations of investment income are based on participant earnings on their respective account balances.

Vesting – All contributions, and related investment income, are fully vested at all times.

Payment of Benefits – A participant may not make withdrawals from their Participant’s Elective Account except for:

- (1) Normal retirement - age 65;
- (2) Total and permanent disability;
- (3) Death;
- (4) Termination of employment;
- (5) Attainment of age 59½; or
- (6) Financial hardship

Participants may take in-service distributions from rollover contribution source funds at any time. Distributions may be paid as soon as possible following termination date but are paid upon request, except for financial hardship withdrawals which are payable immediately. Distributions are paid to participants in a lump sum.

Investment Options – Capital Bank and Trust Company became the investment provider for the Plan in April 1996. At December 31, 2024 and 2023, participants could direct their contributions to eighteen (18) investment options/funds offered by American Funds, five (5) options/funds offered by Vanguard and one (1) common collective trust offered by Reliance Trust.

1. Description of Plan (continued):

Notes Receivable from Participants – Participants who are not an officer or director of the Company may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are generally repaid through payroll deductions in five years or less. The interest rate on participant loans shall bear interest at a rate reasonable at the time of application, based on the prime interest rate plus three percentage points. The Plan had no outstanding notes receivable from participants as of December 31, 2024 and 2023.

Forfeited Accounts – No amounts are forfeited as all contributions are fully vested.

2. Summary of Accounting Policies:

The following are the significant accounting policies followed by the Plan:

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the Company's non-elective safe harbor 3% contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to quarterly administration of the Plan are charged directly to the participant's account and are included in administrative expenses, as are withdrawal fees. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

3. **Investments:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Capital Bank and Trust Company serves as the Plan's trustee. They have provided the Plan administrator with certifications as to the completeness and accuracy of investment balances, the supplemental schedule, interest, and dividend income, realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) of investments in accordance with the Department of Labor Regulations.

4. **Plan Amendment:**

The Company changed its name from Creare Incorporated to Creare, LLC in February 2014. The name of the Plan also changed from Creare Incorporated 401(k) Savings and Retirement Plan and Trust to Creare 401(k) Savings and Retirement Plan and Trust in February 2014.

Effective April 1, 2014, the Plan was amended to allow rollover contributions and to allow participant loans for hardship reasons only.

Effective October 1, 2020, the Plan was amended to automatically enroll new employees with a 1% deferral, to allow for discretionary employer contributions and to remove the minimum service requirement.

Effective December 1, 2020, the Plan was amended to remove the requirement to submit a separate deferral form for bonus payments.

Effective January 1, 2022, the members of the Company adopted a restated plan document which supersedes all prior plan documents and related amendments. The newly adopted plan document is designed to comply with the Cycle 3 restatement by incorporating, among other items, the 2017 IRS Cumulative List (IRS Notice 2017-37), the American Taxpayer Relief Act of 2012 and the Tax Cuts and Jobs Act of 2017.

5. **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are at all times fully vested in their accounts and would be entitled to the full value of their account in the event of Plan termination.

6. **Tax Status:**

The Plan is a Pre-Approved Profit Sharing Plan with CODA that was notified by an IRS opinion letter dated June 30, 2020, that the Plan, as then designed, was in accordance with the applicable section of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission (SEC). This fund is required to publish their daily net asset value (NAV) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

8. Fair Value Measurements (continued):

Collective trust fund: Value based on the NAV of units of the collective trust fund. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As December 31, 2024 and 2023 the collective trust fund had no unfunded commitments. The collective trust fund allows fund unit transactions on a daily basis with no prior redemption notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Related Party and Party-In-Interest Transactions:

The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The employees that provide these services are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions.

Certain Plan investments are managed by Capital Group. Capital Bank and Trust Company is a wholly owned subsidiary of Capital Group. Capital Bank and Trust Company is the trustee and recordkeeper for the Plan and, therefore, transactions with Capital Bank and Trust Company qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of the ERISA, these transactions meet the criteria for exemption, are not considered prohibited transactions and do not need to be reported in the supplementary schedules of Form 5500.
