Opinion

We have audited the accompanying financial statements of Paulo Products Company Employees' Benefit Trust (the "Trust"), an employee benefit plan subject to the Employment Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above presently fairly, in all material respects, the net assets available for benefits and benefit obligations of the Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. Description of the Trust

The following description of the Paulo Products Company (the "Company") Employees' Benefit Trust (the "Trust") is provided for financial reporting purposes only. Participants should refer to the Trust documents for a more complete description of the Trust's provisions.

General

The Trust plan document was restated as of January 1, 2021, and is a medical benefit trust that provides medical benefits to its covered eligible employees of the Company. The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Eligibility requirements include full-time employment (not less than 30 hours per week) and an introductory waiting period. Employees hired before June 1, 2022, and union employees, are subject to a 90 day waiting period from the first day of employment before they are eligible for health coverage. Employees hired after June 1, 2022, certain hourly employees, and administrative employees are subject to a 30 day waiting period from the first day of employment before they are eligible for health coverage.

Benefits

The Trust provides funding for benefits to full-time employees of the Company and their covered dependents. The Trust also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Insured Benefits

The Trust fully insures the life insurance benefits, accidental death and dismemberment benefits, and long term disability benefits for the participants. The Trust purchases annual insurance contracts for these insured benefits. In addition, the Trust purchases stop loss insurance to actively manage catastrophic medical claims. The premiums for all insured benefits are paid from the assets of the Trust.

Self-Funded Benefits

Medical, dental, and prescription drug benefits are self-funded. The claims for these benefits are processed by the Trust's third-party claims processor under administrative service only ("ASO") arrangements. The claims processor pays claims directly to or on behalf of the participants and is then reimbursed by the Trust. The responsibility for payments of allowable claims to providers and participants resides with the Trust. The Trust uses a pharmacy benefit manager ("PBM"), which periodically makes refunds to the Trust based on the Trust's actual utilization pattern of specific drugs.

Contributions

Contributions by the Company vary depending on the value of the benefits paid. The Company contributes the maximum amounts allowed as a tax deduction by the Internal Revenue Service. Under present law, the Company is not permitted to deduct amounts for future benefits to current employees.

Employees are required to contribute toward the cost of medical coverage for themselves and their dependents. The Company funds the remainder of Trust expenses.

The Company has the right under the Trust to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Trust subject to the provisions set forth in ERISA.

The following were funded by the Trust for the years ended December 31, 2024 and 2023:

1. Paulo Products Company Medical Plan
2. Paulo Products Company Dental Plan
3. Employee Assistance Program
4. Insurance premiums for other benefits

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Trust have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Trust follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Estimated Future Benefits

Benefit obligations at December 31, 2024 and 2023, for claims incurred but not reported are determined in accordance with accepted actuarial principles based on claims data provided by the Trust's third-party claims processor. These amounts are paid by the Trust only if claims are submitted and approved for payment.

Forfeitures Payable

Unused funds of the Paulo Products Company Employees' Flexible Benefits Plan (the "Plan") are forfeited to the Trust, 90 days after the Plan year, if unspent. At December 31, 2024 and 2023, there were \$12,220 and \$16,997, respectively, of unused funds.

Employer Deferred Contributions

Employer deferred contributions represent the amount due to the Company as of December 31, 2024 and 2023, based on benefit claims payable, an actuarially determined estimate of future benefits, and the amount of employer contributions already paid to the Trust during the year.

Payment of Benefits and Premiums

Premiums paid are recorded as insurance premiums paid in the statements of changes in benefit obligations and net assets available for benefits. Claim payments are recorded when submitted to the Trust by the third-party claims processors for reimbursement and are shown net of recoveries and insurance reimbursements. Claims paid by the claims processor prior to year-end or claim payments submitted to the third-party claims processor that are not yet paid are recorded as an amount currently payable in the statements of benefit obligations and net assets available for benefits.

Stop Loss Coverage

Claims already paid from the Trust which exceeded the stop loss coverage and are due to the Trust at year-end, are recorded as a receivable. The stop loss arrangement covers individual participant claims up to a maximum limit of \$125,000 per covered person for the years ended December 31, 2024 and 2023, once the Trust's minimum aggregate attachment point is met under the arrangement for all claims. The stop loss reimbursements received during the years ended December 31, 2024 and 2023, totaled to \$1,171,313 and \$336, respectively and is netted against benefit claims paid.

Prescription Rebate

Prescription rebates due from the PBM are recorded when earned. Rebates due at year-end are recorded as receivable in the statement of benefit obligations and net assets available for benefits, with the rebate income being netted against benefit claims paid. Pharmacy rebates totaled \$86,976 and \$92,345 for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

The Trust pays administrative expenses that consist primarily of administrative service fees paid to third-party claims processors and consultants. These expenses are recorded when incurred and reported on the statement of changes in benefit obligations and net assets available for benefits as administrative expenses. All other expenses are paid by the Company. The Company also provides to the Trust certain accounting services for which no allocation of costs has been made to the Trust.

Subsequent Events

The Trust's management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical instruments in active markets.
Level 2	Inputs to the valuation methodology to include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for instruments measured at fair value.

Level 2 instruments consist of estimated future benefits. Estimated future benefits are valued based on an actuarial calculation of historical claim payments and the time of payment adjusted for the time value of money (through discounts for interest), and the probability of payment between the valuation date and the expected date of payment.

4. Plan Amendments

Effective January 1, 2023, the Trust has been amended to revise coverage for hearing services.

Effective May 12, 2023, the Trust has been amended to add coverage for Telehealth.

Effective October 1, 2024, the Trust was amended to expand the definition of a full mouth x-ray that is covered under the dental plan.

Effective January 1, 2025, the Trust was amended to add nutritional counseling for preventative services.

5. Termination of the Trust

Although it has not expressed any intent to do so, the Company has the right under the Trust to modify the benefits provided to and contributions required of participants, and to discontinue its contributions at any time and to terminate the Trust subject to provisions of ERISA.

6. Tax Status of Trust

The Trust was established to meet the requirements of Internal Revenue Code ("IRC") Section 501(c)(9), and accordingly, is intended to be exempt from federal income taxes. The Trust has obtained a favorable determination letter from the Internal Revenue Service. The Trust has been amended since receiving the determination letter. However, the Trust's administrator and the Trust's tax counsel believe that the Trust is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the Trust is tax-exempt.

In accordance with GAAP, the Trust's management is required to evaluate tax positions taken by the Trust and recognize a tax liability if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Trust's management has analyzed the tax positions taken by the Trust and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Trust's management believes the Trust is no longer subject to income tax examinations for the years prior to 2021. The Trust is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

7. Risks and Uncertainties

Financial instruments that potentially subject the Trust to concentrations of credit risk consist of cash, receivables and estimated future benefits. Cash for Trust operations is deposited in a Federal Deposit Insurance Corporation ("FDIC") member bank where cash is insured up to \$250,000. At December 31, 2024, there were cash balances of \$514,819 in excess of federally insured limits. Receivables are primarily due from the stop loss insurance providers and PBM and are collected in a timely manner with limited risk.

The estimated future benefits are reported based on certain actuarial assumptions and are determined by an independent actuary. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

8. Commitments

The Trust has signed an agreement with a consultant, with a monthly fee of \$12,500 that extends through June 1, 2025.
