Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TForce Holdings USA, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following is a brief description of the TForce Holdings USA, Inc. 401(k) Plan (the Plan) and is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan established July 1, 2003. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last restated August 31, 2021, and most recently amended January 1, 2025. The Plan covers all employees of TForce Holdings USA, Inc. and participating affiliates as defined in the Plan (collectively referred to as the Company) and excludes employees covered under a collective bargaining agreement, leased employees, nonresident aliens, consultants, offshore employees and driver-employees of Unity Courier Services, Inc. Employees who have attained age of 21 and completed three months of service are eligible to participate. Eligible employees enter immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401k of the Internal Revenue Code (IRC). Eligible participants may contribute up to 75% of their eligible compensation to the Plan as pre-tax contributions, after-tax Roth and regular after-tax contributions. The Plan allows participants age 50 and over to make catch up contributions. The Company may, at its discretion, elect to make a matching contribution or profit sharing contribution to the Plan. For the year ended December 31, 2024, the Company matched 50% of the participants' pretax contributions up to a maximum of 6% of the participants' eligible compensation. There was no Company discretionary profit sharing contribution for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Company's contributions, and an allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Vesting

The participants are always 100% vested in their own contributions and related earnings. Upon death, attainment of normal retirement age of 65, or permanent disability, a participant will be 100% vested in the Company's contributions. Otherwise, a participant is fully vested upon completion of four years of qualifying service, as defined, on a graded-vesting schedule. Employees that merged into the Plan may be subject to a different vesting schedule as defined by the Plan.

Notes Receivable from Participants

Participants are entitled to borrow up to 50% of their vested account balances, subject to a \$1,000 minimum and \$50,000 maximum note for specified purposes. Notes are repayable over periods of not more than five years (or longer period for purchase of a principal residence) and bear interest at the prime rate plus 1% at the time of borrowing. Principal and interest are repaid ratably through payroll deductions.

Benefit Payments

Upon termination of service, death, disability, or retirement, the participant may receive the value of vested interest in their account in the form of a lump sum distribution, partial withdrawals or installment payment. If a participant terminates employment and the participant's account balance was never greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. Effective July 1, 2024, if the participant's account balance is between \$1,000 and \$5,000, the Plan administrator may authorize that the balance be transferred into an individual retirement account in the participant's name. The Plan also allows for in-service withdrawals at age 59½ and financial hardship, subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested accounts are used to pay Plan administrative expenses or used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$305,987 and \$456,808, respectively. There were \$191,595 of forfeitures used to pay administrative expenses for the year ended December 31, 2024. There were \$567,198 of forfeitures used to reduce Company contributions for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced and a benefit payment will be recorded at the time the participant incurs a distributable event.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of investment management, investment advisory, benefits paid, notes receivable from participants, and other administration of accounts are charged directly to the participant accounts and are included in the administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a deduction for corrective distributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in accordance with IRS regulations.

Benefit Payments

Benefits are recorded when paid.

NOTE 4 FAIR VALUE OF INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Funds: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participants may transact (purchases and sales) on a daily basis.

NOTE 5 TAX STATUS

The Plan is placing reliance on a volume submitter opinion letter indicating that the volume submitter prototype plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under present income tax law. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

NOTE 5 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Fidelity Management Trust Company, the trustee of the Plan, provides investment management and advisory services for the Plan. Therefore, these investment transactions qualify as party-in-interest transactions.

NOTE 8 PLAN MERGERS

The Board of Directors of TForce Holdings Inc. resolved to merge the following Plans and their related assets into the TForce Holdings USA, Inc. 401(k) Plan during 2024:
