## **NOTES A - DESCRIPTION OF PLAN**

The following description of the Axis Power LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all full-time employees of the Company, except for non-resident aliens who received no earned income, which constitutes income from services performed within the United States, as defined, and its wholly owned subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

### Contributions

Each year, participants may make pretax and Roth contributions to the Plan up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute a matching contribution at the option of the Company's Board of Directors up to 100% of employee deferrals; however, employees are not eligible for the match unless they have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. The Company also contributes an amount necessary to meet the Company's requirements under applicable collective bargaining agreements and prevailing wage statutes. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit-sharing contribution (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions and employer collective bargaining agreement and prevailing wage contributions plus actual earnings thereon. Vesting in the Company's employer match contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service for profit sharing and matching and after two years for qualified automatic contribution arrangement contributions.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amounts equal to the value of the participant's vested interest in his or her account or a direct rollover to an individual retirement account or another employer plan. The Plan also allows employees to withdraw vested balances at the age of 59½. A financial hardship withdrawal provision is available, enabling a participant to withdraw an amount to cover an immediate and heavy financial need.

### Forfeited Accounts

Forfeited non-vested accounts are used to reduce future Company contributions. During 2024 \$51,570 of forfeited accounts were used to reduce the Company's contributions. At December 31, 2024, forfeited nonvested accounts totaled \$70,197. These accounts will be used to reduce future employer contributions.

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025 the date the financial statements were available to be issued.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
  
If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Pooled separate accounts* – Valued at the NAV per unit at the close of each business day as reported by each fund, which is then adjusted for dividends and separate account fees.

- a) Funds in this category invest in a diversified portfolio of domestic and foreign stocks to achieve a long-term rate of return.
- b) Funds in this category invest in various types of debt securities to achieve a long-term rate of return while preserving capital. These funds invest heavily in U.S. Government bonds.

**NOTE E – ROLLOVER CONTRIBUTIONS**

An aggregate of \$12,331 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

**NOTE F –PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee for the plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE G - PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company has no current plans to terminate the plan.

**NOTE H - TAX STATUS**

The Company adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service. The letter states that the volume submitter plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The

volume submitter sponsor, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
