We have performed an audit of the financial statements of C.N. Brown Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

#### **1. Description of Plan**

The following description of the C.N. Brown Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan adoption agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by C.N. Brown Company (the Company). All employees of the Company who have completed one year of service are eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may contribute up to the maximum permitted of their pre-tax annual compensation to the Plan, subject to certain limitations. Each participant may direct the contributions into their account to any one or more of the investment funds offered by the Plan. The Company matches up to 100% of the first 2% of plan compensation and 25% of the next 4% that a participant contributes to the Plan.

#### **2. Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fixed income contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Payments to participants are recorded when paid.

#### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan.

#### **Subsequent Events**

Management has considered transactions or events occurring through July 29, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Investment Fixed Income Contract with Insurance Company**

The Plan invests in a Great-West Life & Annuity Insurance Company (Great-West) Guaranteed Interest Fund. Great-West maintains the contributions in a general account. The Guaranteed Interest Fund provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. Under the terms of the contract, participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the contract, credited for earnings on the underlying investments and charged for participant withdrawals and reduced for administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The actual average yield earned by the Plan for the Guaranteed Interest Fund was 1.66% and 1.48% in 2024 and 2023, respectively.

Termination of the Plan may limit the ability of the Plan to transact at contract value with the issuer. The Company has not expressed any intent to terminate the Plan.

### **4. Fair Value Measurement**

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodology used to measure mutual funds at fair value is based on quoted market prices of shares held by the Plan at year-end. There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. **Parties-In-Interest**

Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan. As the custodians, they hold and manage the Plan's assets and make distributions. In addition, certain distributions made by the custodians are in the form of loans to the Plan's participants. These distributions are considered to be party-in-interest transactions.

The Plan paid investment advisory fees to Merrill Lynch Pierce Fenner & Smith in the amount of \$27,195 for the year ended December 31, 2024. The Plan paid recordkeeping fees to Empower Annuity Insurance Company of America in the amount of \$47,722 for the year ended December 31, 2024. The Plan paid investment management fees to Empower Advisory Group, LLC in the amount of \$6,711 for the year ended December 31, 2024.

#### 6. Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

#### 8. Information Prepared and Certified by the Custodians

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from the information certified by the custodians as complete and accurate. This information is included in the following:
