### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Dierbergs Collectively-Bargained Employees' 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023**

### **1. Description Of The Plan**

The following description of the Dierbergs Collectively-Bargained Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan with a 401(k) feature established by Dierbergs Markets, Inc. (the Company) under Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Charles Schwab Trust Bank is the Plan's trustee and EPIC Retirement Plan Services is the Plan's recordkeeper.

#### **Eligibility**

Employees are eligible to participate in the Plan upon reaching age 21 and completing 12 consecutive months of employment. Participation is voluntary.

#### **Contributions**

Participants may make contributions up to 75% of their annual compensation, not to exceed IRC limits, in pre-tax and/or Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants age 50 or older, who are contributing to the Plan, are allowed to make catch-up contributions, as defined in the Plan Document.

The Company can make discretionary contributions on behalf of certain employees. No such contributions were made for the years ended December 31, 2024 or 2023.

The Company contributes on behalf of the Bakery, Confectionary, Tobacco Workers' and Grain Millers International Union (BCTGM Local No. 4). These contributions are calculated on a per day basis for full time employees with the maximum of 20 days per month. The contribution amounts per day were \$6.50 for the years ended December 31, 2024 and 2023. Total contributions under this agreement for the years ended December 31, 2024 and 2023 totaled \$14,490 and \$63,143, respectively.

### Notes To Financial Statements (*Continued*)

The Company also contributes on behalf of the Service Employees' International Union AFL-CIO-CLC (CTW Local No. 1). These contributions are calculated on a per hour basis for straight time hours worked up to a maximum of 40 hours per week. The contribution amount per hour is \$0.20. Total contributions under this agreement for the years ended December 31, 2024 and 2023 totaled \$32,006 and \$34,622, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The number of outstanding loans for any participant at any one time is limited to one. Only one loan may be made to any participant during any 12-month period. Loans may not extend beyond a term of five years except for a loan for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and Company contributions plus actual earnings thereon.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct elective contributions, rollovers, and Company contributions in any of the investment options available. The investment options consist of registered investment companies (mutual funds) and collective trust funds.

### **Benefits**

Amounts in a participant's account, including the vested portion of a participant's Company contributions and earnings thereon, are distributed upon retirement, death, disability, or other termination of employment. The normal form of retirement benefit is a lump-sum payment or a series of equal payments over a period of time until fully distributed.

### **In-Service Withdrawals**

Active participants who reach age 59-1/2 or experience a qualifying financial hardship may withdraw all or part of their salary deferral contributions account. Hardship withdrawals will be approved only if they conform to the Plan provisions and established IRC provisions.

### **Administrative Expenses**

Participants are charged a fixed annual fee as well as other administrative expenses, including recordkeeping fees, professional fees and trust fees, which are paid from participant accounts.

## **2. Summary Of Significant Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Financial Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

#### 4. Fair Value Measurements

The Plan follows accounting rules, which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies**

Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

#### **Collective Trust Funds**

Valued at the NAV of units of the collective trusts. The NAV, as provided the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The collective trust funds file annual reports on Form 5500 as direct filing entities.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Income Tax Status**

The Plan was amended and restated effective January 1, 2022 through the adoption of a pre-approved plan document sponsored by EPIC Retirement Plan Services (EPIC). EPIC obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document is in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter. The Plan has been amended since the date of the pre-approved plan document. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Party In Interest Transactions**

The Plan pays fees to various service providers related to operations of the Plan and invests in collective trust funds managed by the Trustee. In addition, certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These are considered party in interest transactions that are allowable under ERISA.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

**8. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
