#### **(1) Plan Description**

The following description of the 2024 Brock and Company, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering all employees of Brock and Company, Inc. (the "Company") over the age of 21, effective in the first monthly entry date after the completion of two consecutive months working and 200 hours of service. Starting in November 2020 the Company amended the Plan in order to incorporate an autoenrollment provision for employees who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Basis of Accounting*

The financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles (GAAP). Under the modified cash basis of accounting investments are recorded at fair value (or contract value) but all other transactions are recorded when received or paid. Under GAAP transactions would be recorded when earned or become payable. Consequently, the financial statements do not include receivables for contributions and accrued interest and dividends, or liabilities for accrued expenses. Accordingly, the accompanying financial statements are not intended to present the net assets and changes in net assets in conformity with generally accepted accounting principles.

##### *Contributions*

Each year, participants may contribute up to the maximum amount allowed by law. The law restricts the actual amount that may be contributed (including employer matching contributions and any allocation of forfeitures) to 100% of pretax annual compensation as defined in the Plan, subject to 100% of pretax annual compensation as defined in the Plan, subject to a cost-of-living-adjustable cap which for the 2024 Plan year is \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to a cost-of-living-adjustable cap which is \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans. The Company contributes 25% of the first 6% of base compensation that a participant contributes to the Plan. Contributions are initially paid by the electronic funds transfer, and the authorization given to the Plan record-keeper to execute investment transactions in allocating the contributions between various mutual funds and the stable value fund according to the direction of the participants.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of continuous service.

#### *Investment Options*

Upon enrollment in the Plan, a participant may direct employee contributions in any of a diversified range of investment options, including mutual funds from several different fund families and a stable value fund in the form of a common collective trust. For more comprehensive descriptions of the classes of investments objectives represented by these funds, the prospectuses of the respective funds should be consulted. Participants may change their perspective investment allocation options or make transfers between funds in their accounts at any time by using the plan's available telephone or internet access services.

#### *Notes Receivable - Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can range up to five years only, unless for a home loan. The loans are secured by the balance in the participant's account and bear interest at 4.25-9.5% on all outstanding loans. Interest, which is determined by the Plan administrator, is charged at one percent above the prime rate at inception of the loan. Principal and interest is paid ratably through payroll deductions. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### *Payment of Benefits*

On reaching the age of 59 ½ or upon termination of service, a participant may elect to receive either a lump-sum payment of their vested interest in the Plan, or substantially equal installments as specified in the Plan. Hardship withdrawals are also permitted under certain circumstances. Normal retirement age is 62 under the Plan.

#### *Forfeited Accounts*

As of December 31, 2024 and 2023, forfeited accounts totaled \$1,536 and \$11,348, respectively. In accordance with the adoption agreement these accounts are to be used to pay plan administrative expenses. For the year ended December 31, 2024, \$24,132 of forfeitures were used to pay plan expenses.

## **(2) Summary of Significant Accounting Policies**

#### *Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments, other than fully benefit responsive investment contracts, are stated at fair value as described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Fully benefit-responsive investment contracts are stated at contract value as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document.

#### *Payment of Benefits*

Benefit payments are recorded when paid.

#### *Administrative Expenses*

The Company generally pays all significant administrative expenses of the Plan. Investment related expenses are included in net appreciation of fair value of investments.

#### *Cash and Cash Equivalents*

Any Plan assets invested in money market funds are considered as equivalent to cash and are not discussed in ensuing fair value measurement disclosure. These assets are not federally insured.

#### *Subsequent Events*

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

### **(3) Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits. Accounting standards provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for the identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the framework are described as follows:

#### *Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### *Level 2*

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### *Registered Investment Companies and Mutual Funds*

Valued at daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### (4) Fully Benefit-Responsive Investment Contracts

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract and a portfolio of synthetic investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the "IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

#### **(6) Related Party Transactions**

Ascensus Trust Company is a trustee of the Plan, as defined by the Plan, and therefore, the services provided to the Plan qualify as party-in-interest transactions.

The Company absorbs a portion of administrative costs related to the Plan. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Participants have loans outstanding in the amount of \$38,645 and \$22,259 as of December 31, 2024 and 2023, respectively.

#### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has a right under the Plan Document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **(8) Tax Status**

The Company adopted a volume submitter profit-sharing plan. The volume submitter plan obtained its determination letter dated June 30, 2020, in which Internal Revenue Service has determined and informed the volume submitter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan has been amended since the effective date of the determination letter to comply with all subsequent regulatory changes required. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. No provisions for income taxes have been included in the Plan's financial statements.

#### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' balances and the amounts reported in the statements of net assets available for benefits.
