1. Description of Plan:

The following description of the US Assure Insurance Services of Florida, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions. Principal Trust Company is the custodian of the Plan’s assets.

General

The Plan is a defined contribution plan covering all employees of US Assure Insurance Services of Florida, Inc., (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan qualifies as a qualified automatic contribution arrangement (“QACA”) in accordance with IRS Code Section 401(k)(13) and includes a matching employer contribution.

Effective August 29, 2024 the Plan was terminated (Note 3).

Contributions

Upon employment with the Company, employees are eligible to contribute to elective deferrals. As a QACA, a participant is automatically enrolled in the Plan at a 3% deferral contribution with increases of 1% annually on the first day of the Plan year until reaching a maximum of 6% whereby employees must elect out of the Plan if they do not wish to participate. Each year, participants may elect to contribute up to the IRS determined maximum of their pretax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

The Company makes matching contributions to participants' accounts. The Company has elected safe harbor provisions. Safe harbor matching contributions are 100% of a participant's contribution (not in excess of two percent of eligible compensation), and 50% of the participant's contributions (in excess of two percent but not in excess of six percent of eligible compensation), subject to certain Plan limitations. Additional Company profit sharing amounts may be contributed at the option of the Company and are invested in the portfolio of investments as directed by the participants of the Plan. During 2024, the Company did not make an additional profit sharing contribution to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, the Company’s discretionary profit-sharing contribution, if any, and participant earnings. Participant earnings are based on an allocation of plan earnings respective to each participant’s account balances and investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a selection of mutual funds, pooled separate accounts, a stable value fund, and a guaranteed investment contract as investment options for participants.

1. Description of Plan (Continued):

Participant Loans Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to an amount not to exceed the lesser of one-half of the participant's non-forfeitable interest under the Plan or \$50,000. The loans are collateralized by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution or annual installments equal to the value of the participant's vested interest in his or her account, in accordance with Plan provisions. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without consent of the participant.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay administrative expenses, reduce employer contributions, or be allocated to eligible participants in the same manner as profit-sharing contributions. At December 5, 2024, and December 31, 2023, forfeited nonvested accounts totaled \$0, respectively. The Plan used forfeited nonvested accounts totaling \$1,914 to reduce employer contributions during the Plan year 2024.

1. Description of Plan (Continued):

Plan Expenses

Plan expenses, except for recordkeeping and other administrative services expenses, are paid directly by the Plan sponsor. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account. Participant forfeitures may be used to pay administrative expenses or reduce employer contributions.

Management fees and operating expenses charged to the Plan for investments in mutual funds and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

2. Summary of Accounting Policies:

Basis of Accounting

On July 31, 2024, a decision was made to terminate the Plan. As a result, the 2024 and 2023 financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan’s investments are presented at fair value. Shares of registered investment companies are presented at published market prices which represent the net asset value (“NAV”) of shares held by the Plan at the reporting date. Non-registered pooled separate accounts managed by Principal Trust Company are valued daily based on the market value of the underlying assets in each separate account. The group annuity contract is presented at contract value which is the aggregation of contributions, plus interest, less withdrawals, if any. Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

2. Summary of Accounting Policies (Continued):

Participant Loans Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as a distribution to the participant based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

3. Plan Termination:

On July 31, 2024, the Plan Sponsor entered into a Securities Purchase Agreement pursuant to which the Sponsor was acquired by Ryan Specialty, LLC. In connection with the acquisition, the Plan Sponsor elected to terminate the Plan effective August 29, 2024. In accordance with the terms of the Plan document and applicable law, all participants became fully vested in their account balances as a result of the Plan termination.

Following the termination, no additional contributions were made to the Plan. All Plan assets were liquidated, and participant account balances were fully distributed in accordance with the provisions of the Plan document and applicable requirements under the ERISA and the Internal Revenue Code ("IRC"). Final distributions to participants were completed on December 5, 2024.

4. Fair Value Measurements:

The Financial Accounting Standards Board, Accounting Standards Codification Topic 820 ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

4. Fair Value Measurements (Continued):

(a) These funds were measured at net asset value per share in accordance with ASC Subtopic 820-10 and have not been classified in the fair value hierarchy. The fair value amounts presented permit reconciliation of the fair value hierarchy to the line items presented in the Statement of Net Assets Available for Benefits.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: Valued at the daily closing NAV price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. Investments in mutual funds generally may be redeemed daily. These securities are classified as Level 1.

Pooled Separate Accounts: The value of the units held in pooled separate accounts is based on the net asset value (“NAV”) of the units, determined by the security prices of the underlying investments. Many of the security prices are obtained from a pricing service, Interactive Data Corporation. While the underlying security prices are quoted prices, the NAV of a separate account is not publicly quoted.

Common Collective Trust: The Plan invests in a common collective trust which owns investment contracts that may invest in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The common collective trust is valued at NAV based on the fair value of the underlying securities within the investment in accordance with ASC Subtopic 820-10. There are no participant redemption restrictions for these investments; the redemption notice period is applicable to only the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Principal Life Insurance Company:

The Plan held a fully benefit-responsive investment contract with Principal Life Insurance Company (“Principal”), which qualified for accounting at contract value in accordance with Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*. The investment was structured as a single group annuity contract that provided a fixed rate of interest over specified periods. The contract was designed to provide for the payment of participant-initiated withdrawals and transfers at contract value, which represents contributions made to the fund, plus earnings at the contractually specified rate, less participant withdrawals and administrative expenses.

Effective December 5, 2024, the Plan Sponsor elected to terminate the group annuity contract with Principal. Rather than initiating a plan-level transfer or waiting the standard 12-month period for contract value distribution, participants were given the opportunity to make individual distribution elections. As a result, no plan-level transaction occurred, and the standard surrender charge did not apply. The contract was terminated without incurring a surrender fee.

Prior to termination, the contract allowed for participant-initiated withdrawals and transfers at contract value. However, certain events could have limited the Plan’s ability to transact at contract value, including but not limited to: (1) Plan termination, (2) Plan Sponsor bankruptcy or insolvency, (3) significant layoffs or workforce restructuring, or (4) changes in the investment structure or allocation by the Plan Sponsor. The Plan Administrator did not believe any such events were probable to occur before termination.

Principal was not permitted to unilaterally terminate the contract or settle amounts at anything other than contract value, except in the event of a Plan default or other nonparticipant-directed events, none of which occurred.

6. Tax Status:

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Management evaluated the Plan’s tax positions and concluded that as of December 5, 2024 the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021

7. Information Certified by the Plan's Custodian:

The following investments included in the statements of net assets available for benefits as of December 5, 2024 and December 31, 2023 and the interest and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the period January 1, 2024 to December 5, 2024 have been derived from information certified as complete and accurate by Principal Trust Company, custodian of the Plan, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

8. Parties-in-Interest Transactions:

The Principal Financial Group ("PFG") is the recordkeeper for the Plan and Principal Trust Company, a subsidiary of PFG, is the is the custodian. PLIC, a member of PFG, manages the pooled separate accounts and the single annuity contract, therefore, transactions involving these investments qualify as party-in-interest transactions permitted under provisions of ERISA. Fees paid to PFG by the Plan for administrative expenses amounted to \$27,215 during 2024.

Included in the Plan assets are notes receivable from participants. At December 5, 2024 and December 31, 2023, notes receivable from participants amounted to \$0 and \$209,179, respectively. During 2024, interest income related to notes receivable from participants amounted to \$17,603. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

9. Subsequent Events:

Management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be filed and has determined that there were no material events requiring recognition or disclosure.
