Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dakota Community Bank & Trust 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Dakota Community Bank & Trust 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering all employees of Dakota Community Bank & Trust (the Company) who are age 21 or older and have completed three months of service. Employees are eligible to receive matching contributions from the Company if they have completed one year of service and are 21 years of age. Additionally, employees are eligible to receive discretionary contributions from the Company if they have completed one year of service, are 21 years of age, and are employed by the Company on the last day of the Plan year. A year of service, for purposes of eligibility, is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Enrollment in Plan participation and employer contributions is quarterly, on the first day of the quarter coinciding with or following the date on which the employee meets the respective eligibility requirements. The Plan is a single-employer plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Contributions Participants may contribute up to 100% of their annual qualified compensation, as defined in the Plan, up to the maximum amount allowable by law. Individuals who will be age 50 by the end of the calendar year may make additional catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. The Company may also make a discretionary profit sharing contribution that is determined annually by the Board of Directors. The Company did not make discretionary profit sharing contributions in 2024 or 2023.

Participant Accounts Each participant's account is credited with the participant's contributions, the Company's matching contribution, allocations of the Company's discretionary profit sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately vested in their contributions and earnings thereon. Discretionary non-safe harbor matching contributions and discretionary profit sharing contributions are subject to vesting. A participant is 100% vested after six years of credited service. Participants are credited with one year of service for each plan year in which they worked at least 1,000 hours.

Notes Receivable From Participants Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made over the outstanding balance of the Plan notes receivable on the date the loan is made. Notes receivable are secured by the balance in the participant's account. A participant may not have more than two notes receivable outstanding.

The term of the note receivable shall not exceed five years, except in the case of a loan for the purpose of acquiring a primary residence. The notes receivable bear interest at prime rate at the time the funds are borrowed plus 1%. Interest income is recorded on the accrual basis. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their vested account or annual installments over their life expectancy. On attainment of normal retirement age, a participant may withdraw all or any portion of his or her vested account balance.

At the discretion of the Plan administrator, terminated participants with vested account balances of less than \$5,000 may be automatically paid out by the Plan. Terminated participants with a vested balance between \$1,000 and \$5,000 may have their account rolled over, without participant request, into an Individual Retirement Account designated by the Plan administrator. Participants with vested account balances over \$5,000 may choose to leave vested benefits in the Plan until the April 1 of the year succeeding the year in which age 72 is attained, at which time participants are required to take annual minimum distributions.

There were no amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment prior to December 31, 2024 and 2023, but not yet paid as of that date.

Forfeitures A forfeiture occurs when a participant terminates employment and all or part of the participant's Company matching and discretionary profit sharing contributions are not vested. The nonvested portion is forfeited immediately, if the participant either has no vested interest or receives a distribution of the entire vested interest. At December 31, 2024 and 2023, forfeited nonvested account balances totaled \$183 and \$244, respectively.

Forfeitures may be used to reduce Company contributions or to pay reasonable Plan expenses. During the Plan years ended December 31, 2024 and 2023, forfeitures of \$3,161 and \$8,285 were used to reduce Company matching contributions, respectively.

Plan Termination Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the value of their accounts.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year and any resulting investment fees.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Assets are valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments as of December 31, 2024 and 2023.

Self-Directed Brokerage Accounts: Valued at the NAV of units held by the Plan as provided through secondary providers. Self-directed brokerage accounts are allowed to invest in stocks; exchange-traded funds; mutual funds; options; CDs; treasuries; and corporate, municipal, and government agency bonds.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. During the Plan year ended December 31, 2024, certain participant loans were not repaid in accordance with the terms of the Plan's loan policy. As of December 31, 2024 and 2023, the total outstanding balance of delinquent loans was \$57,010 and \$-0-, respectively. Delinquent participant notes receivable are recorded as distributions in accordance with the terms of the Plan agreement.

Payment of Benefits Benefits are recorded when paid.

Expenses Plan expenses chargeable to Plan assets include individual transactions fees for loan origination and distributions, as well as a quarterly loan maintenance fee. These costs are deducted from the individual participant's account. The Plan custodian also assesses an asset-based fee for investment advisory services to the Plan, which is deducted on a prorata basis from participants' accounts. All other fees associated with the Plan are paid by the Company and are not reimbursed by the Plan.

Reclassifications Certain amounts in the December 31, 2023, financial statements have been reclassified for comparative purposes to conform to the presentation in the December 31, 2024, financial statements.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments and notes receivable from participants included in the statements of net assets available for benefits, and the investment income and interest income on notes receivable from participants included in the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by Hand Benefits & Trust Company. Hand Benefits & Trust Company is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan administrator is an employee of the Company. There are no transactions between these parties other than contributions to the Plan and normal benefit payments. Certain Plan investments are in shares of investment funds managed by Hand Benefits & Trust Company, the custodian, and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid investment, custodial, loan, and distribution fees to Hand Benefits & Trust Company of \$91,102 and \$78,800 during the years ended December 31, 2024 and 2023, respectively.

6. TAX STATUS

The volume submitter profit sharing prototype plan document adopted by the Plan received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, indicating that the Plan and related trust, as then designed, are in accordance with the applicable sections of the *Internal Revenue Code* (IRC). Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PLAN AMENDMENTS

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Securing a Strong Retirement Act of 2022 (SECURE 2.0). SECURE 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements. Generally, plans have until December 31, 2026, to formally amend the plan document to address these provisions.
