INDEPENDENT AUDITORS' REPORT

Opinion

We have audited the financial statements of CLEAT Benefit Trust (the Trust), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits - modified cash basis for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years ended December 31, 2024 and 2023, in accordance with the modified cash basis of accounting described in Note B.

Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTE A - PLAN DESCRIPTION

The following description of the CLEAT Benefit Trust (the Trust) provides only general information. Participants should refer to the CLEAT Benefit Plan (the Plan) documents, including the summary plan description, for a more complete description of the Plan's provisions.

1. General

The Plan and related Trust originally were established in December 1984. A revised plan document was adopted January 1, 1998, and the Trust became known as the CLEAT Benefit Trust. Prior to August 1, 1998, only one plan was funded through the Trust. A new Life Benefit Plan (Life Plan) was added in August 1998.

The plans are considered collectively-bargained plans for Internal Revenue Service purposes and are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan Administrator and Sponsor anticipate that the plans funded by the Trust will continue indefinitely. However, the Plan Administrator may at any time terminate one or all of the plans without consent of any plan participants. In such case, any funds held by the Trust in relation to a plan will be utilized for benefits due and any balance will be paid to members on a fair and equitable basis for health care benefits described in §213(c) of the Internal Revenue Code. De minimis accounts may nevertheless be distributed according to any method deemed practical.

The Plan Administrator is Combined Law Enforcement Associations of Texas, Inc. (CLEAT). All claims processing, including the payment of claims, is performed by Ameritas Life Insurance Corporation and Bay Bridge Administrators, both of whom are Third-Party Administrators.

2. CLEAT Benefit Plan

This plan was the original plan established to provide dental, vision, and accidental death and dismemberment benefits to employees (and their dependents) of political subdivisions of the State of Texas whose bargaining unit or employer has elected to participate in the Plan.

The Plan provides benefits to the participants and covered dependents as follows: Dental benefits, to include cleaning, x-rays, fillings, extractions, inlays, crowns, and certain orthodontic procedures. Deductibles, co-pay percentages, and maximum benefits are described in the plan documents.

Vision benefits include examinations, frames, and lenses. Deductibles, co-pay percentages, maximum benefits, and other provisions are set forth in the plan documents.

Blood benefits include 100% of blood processing fees, and blood non-replacement fees with no deductible, subject to plan provisions.

2. CLEAT Benefit Plan - continued

Accidental death and dismemberment benefits are provided by the Chubb Group of Insurance Companies. The Plan pays up to a maximum of \$17,500 (\$35,000 if due to felonious assault) to participants and covered dependents.

Written notice of claim must be given to the Plan Administrator within 30 days from the date of the loss covered by the Plan (e.g., the date of the assault, the injury, or, if simultaneous, the death of the participant). Written proof of loss must be furnished within 90 days after the date of such loss.

In accordance with the provision of COBRA, participants may continue their coverage for up to 18 months (36 months if certain conditions are met) upon termination of employment.

The Trust's membership conditions allow the Plan to include full-time employees of a political subdivision of the State of Texas, which has agreed with the Plan Administrator to participate in the Plan, as well as any spouse, dependent child of the Participant who has not reached the last day of the month in which he attains the age of twenty-six (26) (at which point all rights hereunder shall cease), and who is not covered under another group health plan providing similar benefits. Vision benefits are through a preferred provider network with discounted fee schedules for vision exams, frames, and lenses.

3. Contributions

Participating employers and employees contribute to the Plan in accordance with the terms of their respective collective bargaining agreements between the employers and the unions.

4. CLEAT Life Benefit Plan

This plan was established August 1, 1998, to provide accidental death and dismemberment benefits to the beneficiaries of all members of CLEAT, so long as the member is current in payment of CLEAT dues at the time of death. The individual benefit, provided through insurance coverage by Chubb Group of Insurance Companies, is in the amount of \$15,000.

CLEAT is committed to make any necessary contributions to fund the Life Plan. The annual premiums for insurance coverage for 2024 and 2023 were \$105,926 and \$103,000, respectively. All claims during the years were paid from insurance proceeds.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting. That basis differs from generally accepted accounting principles primarily because the Trust has not recognized contributions receivable from member employers and employees and claims received but not yet paid or claims incurred but not yet reported and their related effects on net assets and changes in net assets. The Trust's Third-Party Administrators invoice the Trust for claims, AD&D premiums, and administrative fees 30 to 45 days after the claim and fee occurred.

2. Cash and Cash Equivalents

Cash equivalents include interest bearing money market funds.

3. Fair Value of Assets and Liabilities

The Trust records its investments at fair value in accordance with Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Trust has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value of Assets and Liabilities - continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Exchange-traded and Mutual funds: Valued at the net asset value (NAV) of shares held at the end of year.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

5. Subsequent Events

Management of the Trust has evaluated subsequent events for disclosure through the date of the Independent Auditors' Report, the date the financial statements were available to be issued.

NOTE C - CONCENTRATION OF CREDIT RISK

Financial instruments, which potentially subject the Trust to credit risk, consist of highly liquid cash and cash equivalents. The Trust's cash equivalents are placed with high-credit, quality financial institutions federally insured by the Federal Deposit Insurance Corporation (FDIC) which ensures non-interest bearing cash balances up to \$250,000. As of December 31, 2024, there were \$818,762 in excess of FDIC coverage.

NOTE E - TAX STATUS

The Trust established to hold plan assets is a qualified trust pursuant to section 501(c)(9) of the Internal Revenue Code. Accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan Sponsor believes that the Trust, as amended, continues to qualify and to operate as designed. Therefore, no provision for income taxes has been included in the Trust's financial statements.

The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management of the Trust believe it is no longer subject to income tax examinations for years ending December 31, 2021, and after.

NOTE F - RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Trust has an agreement with CLEAT to provide certain administrative services including recording and maintaining cash receipts and disbursements, managing plan assets, filing plan documents, and preparing and maintaining the Trust's records. The fees for these services are equal to 3% of the Plan's annual employer contributions. Such fees totaled \$112,416 and \$121,928 for the years ended December 31, 2024 and 2023, respectively. The Trust owed CLEAT \$150,730 and \$30,285 as of December 31, 2024 and 2023, respectively. CLEAT reimbursed the Trust for insurance premium in the amount of \$105,927 and \$103,000 in 2024 and 2023, respectively. Payments to other parties-in-interest totaled \$317,520 and \$307,928 for the years ended December 31, 2024 and 2023, respectively. The parties believe that such activities are not in violation of ERISA.
