Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of LECO Corporation 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the LECO Corporation 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan available to substantially all employees of LECO Corporation (the Corporation or Employer). For employee contributions, matching contributions, safe harbor contributions, and after-tax contributions, an employee participates on the first entry date after completing 90 days of service. The Plan does not have minimum age requirements. Employees covered by a collective-bargaining agreement, leased employees, independent contractors, nonresident aliens, and certain other classifications, as defined by the Plan, are not eligible to participate in the Plan.

The Plan has given Voya Institutional Trust Company and Voya Retirement Insurance and Annuity Company (collectively, Voya), the trustee and contract holder, respectively, of the Plan, the authority to hold the assets of the Plan and to invest, control, and disburse all assets of the Plan in accordance with the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may make elective salary reduction contributions in amounts not to exceed the maximum allowable under the Internal Revenue Code (IRC). The Corporation will contribute an additional matching contribution of 40% of deferrals up to 5% of the participant's compensation.

The Plan includes a safe harbor contribution provision of 3% of an employee's eligible compensation, as defined in the Plan agreement. Each participant who is eligible to make a 401(k) contribution at any time during the Plan year will receive a safe harbor nonelective employer contribution for the Plan year. For the years ended December 31, 2024 and 2023, the annual employer safe harbor contributions were approximately \$1,899,100 and \$1,788,200, respectively.

Vesting

Participants having an hour of service on or after January 1, 2020 are 100% vested in their accounts.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions, as well as allocations of Plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers various mutual funds and a stable value option as investment options for participants.

Notes Receivable from Participants

Notes receivable from participants are not allowed under the Plan.

Payment of Benefits

On termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions, upon attainment of age 59½, are allowed from both non-tax deferred contributions and employer contributions. Hardship withdrawals, as defined by the Plan, are allowed from participants' elective accounts only.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$3,000 and \$12,000, respectively. For the years ended December 31, 2024 and 2023, forfeitures used to offset employer matching contributions were \$12,000 and \$55,000, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Certain administrative expenses are paid by the Plan in accordance with Plan provisions. Party-in-interest transactions are discussed in Note 5.

Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values could occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Reclassifications

Certain amounts in prior year's financial statements have been reclassified to conform to the current year presentation.

Subsequent Events

Subsequent events have been evaluated by management through July 17, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and

Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account (PSA) - PSAs are valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Voya, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are units of mutual funds and a stable value option managed by Voya. Therefore, these transactions qualify as party-in-interest transactions.

The Plan sponsor entered into an agreement with Voya to use a Recordkeeping Expense Account (REA). The REA is set up to receive a portion of the investment income retained by Voya from the Plan and can be used by the Plan sponsor to pay Plan expenses. Any remaining funds after Plan expenses have been paid are allocated to participants' accounts.

For the years ended December 31, 2024 and 2023, the REA paid investment advisory fees of approximately \$68,000 and \$63,000, respectively, for Plan expenses.

For the years ended December 31, 2024 and 2023, the Plan paid the trustee approximately \$224,000 and \$146,500, respectively, for Plan expenses.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

7. Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Corporation by a letter dated May 16, 2022, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has since been amended; however, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.
