We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user base on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

1. Exercise professional judgment and maintain professional skepticism throughout the audit.
2. Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
3. Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
4. Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
5. Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion -

1. The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
2. The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 Description of Plan

The following description of the Bihler of America, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary of Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under the provision of Section 401(k) of the Internal Revenue Code ("IRC") covering the eligible employees of Bihler of America, Inc. and its subsidiaries Bihlerflex, LLC and Bihler 4Slide NC, Inc. (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA"), as amended.

All employees of the Company are eligible to participate on the first day of any month following the completion of three months of service, provided they are at least 21 years of age. The Plan excludes employees covered by a collective bargaining agreement, leased employees, nonresident aliens with no U.S. source income, and temporary employees. However, temporary employees who have attained age 21 and completed 1,000 hours of service during a plan year are eligible to participate.

The Plan's Trustees and Administrator are responsible for oversight, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan was amended as follows:

November 2023: To allow participants to make Roth 401(k) contributions.

January 2024: To prohibit rollovers of after-tax employee contributions, while permitting rollovers of designated Roth contributions.

February 2024: To expand eligibility to include temporary employees.

August 23, 2024: A one-time re-solicitation was conducted to automatically enroll eligible participants who had previously elected a 0% deferral rate, enrolling them at a 3% deferral rate unless they opted out.

Plan Contributions

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing pre-tax distributions from other qualified defined benefit or defined contribution plans ("rollover"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic enrollment feature whereby newly eligible employees are automatically entered into the Plan with a deferral rate of 3%.

Plan Contributions (Continued)

Effective September 1, 2016, the deferral rate will automatically increase by 2% on an annual basis up to a maximum of 15% of eligible compensation. For participants hired or rehired prior to September 1, 2016 that have a deferral rate greater than zero and are still automatically enrolled, the deferral rate will automatically increase by 1% on an annual basis up to a maximum of 15% of eligible compensation. Participants have the ability to opt out of the automatic enrollment and/or the escalation of their deferral percentages at any time. Individuals who enrolled in the plan proactively, because they enrolled before the automatic enrollment feature was added, are not subject to the automatic deferral increase each year.

The Company may make a discretionary matching contribution equal to a discretionary percentage of the employee's salary deferrals, of which the percentage is determined each year. To be eligible for these matching contributions, participants must be employed on the last day of the Plan year. For the year ended December 31, 2024, the Company matched 20% of the employee deferrals, up to 7% of eligible compensation, as defined by the Plan document. The Company may also provide for discretionary, nonelective contribution. Participants must be employed on the last day of the Plan year to be eligible, and the nonelective contributions are allocated based on the ratio of each participant's eligible compensation to the total eligible compensation paid to all participants for the contribution period. For the year ended December 31, 2024, the Company did not provide for a discretionary, nonelective contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. The participant's account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the earnings thereon. Vesting in employer matching contributions and the earnings thereon is based on years of continuous service.

A participant vests according to the following schedule:

Any participant who attains normal retirement age, becomes disabled, or dies, becomes fully vested regardless of length of service.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or as deemed reasonable by the administrator for loans taken to purchase a primary residence, which have a repayment period of up to ten years. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved. At December 31, 2024 interest rates on the outstanding loans ranged from 4.25% - 9.50%. Principal and interest are paid ratably, generally through payroll deductions. Processing fees are charged against participant accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Benefits

The Plan allows for "hardship withdrawals" of employee benefits from participant's pre-tax elective deferral accounts based the provisions of the Plan document.

Forfeitures

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$10,427 and \$12,062, respectively. These accounts will be available to reduce future employer matching contributions. Forfeitures used to reduce employer matching contributions during the year ended December 31, 2024 totaled \$6,974.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Expenses related to the administration of the Plan are primarily paid by the Company. Investment related expenses, other than those paid directly by the Plan, are integrated with investment performance.

Subsequent Events

Management has evaluated subsequent events and transactions for potential recognition or disclosure through the date of the auditors' report, which is the date the financial statements were available to be issued.

Subsequent Events (Continued)

Subsequent to the Plan's year end, beginning in April 2025, the Plan Sponsor began implementing a significant workforce reduction that will occur in three phases through October 2025. The Plan Sponsor anticipates that the reduction will result in the involuntary termination of greater than 20% of the Plan's active participants. Based on the percentage of affected participants, the Plan Sponsor has determined that it is likely that a partial plan termination under IRC 411(d)(3) will occur. As a result, all affected participants being terminated who have not yet vested in their employer-contributed account balances will become 100% vested in those amounts as of the date of their termination. The Plan Sponsor is in the process of identifying all impacted participants and will ensure the appropriate vesting adjustments are applied.

The financial impact of this event will be reflected in the Plan's financial statements for the year ending December 31, 2025. Management has evaluated this event and concluded that it does not affect the financial statements for the year ended December 31, 2024.

Note 3 Certified Investments

The information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 4 Fair Value Measurements

Pursuant to the requirements of FASB ASC 820, *Fair Value Measurements*, the Plan has provided fair value disclosure information for relevant assets and liabilities in these financial statements. ASC 820 defines fair value, establishes a framework for measuring fair value in U.S. generally accepted accounting principles, and expands disclosures about fair value measurements. Fair value refers to the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. ASC 820 clarifies that fair value should be based on assumptions market participants would use when pricing an asset or liability and establishes a fair value hierarchy that prioritizes the information used to develop the assumptions. The fair value hierarchy gives the highest priority to quoted prices in active markets and the lowest priority to unobservable data.

The following table presents information about the Plan's financial assets and liabilities that are measured at fair value on a recurring basis at December 31, 2024 and 2023. The hierarchy is broken down into three levels.

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. Level 2 inputs include data points that are observable such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, and inputs (other than quoted prices) such as interest rates and yield curves that are observable for the asset or liability, either directly or indirectly. Level 3 inputs are unobservable data points and significant to the fair value measurement for the asset or liability, and include situations where there is little, if any, market activity for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Investments in mutual funds are valued at the fund’s net asset value (NAV) per share as reported by the fund on the valuation date. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust

Stable value collective trusts are stated at fair value based on the NAV of the underlying investments, as reported to the Plan by the contract issuer. The NAV, as provided by Fidelity Management Trust Company, is used as a practical expedient to estimate fair value.

Withdrawals and transfers can be made by participants on any business day. However, transfers cannot be made to competing funds for a period of 90 days. The issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Common/Collective Trust’s objective is to protect principal while providing a higher rate of return than shorter maturity investments, such as money market funds or certificates of deposit. To achieve this, the trust invests in instruments which are not expected to experience significant price fluctuations in most economic or interest rate environments. However, there is no assurance that this objective can be achieved.

Note 5 Related Party and Party-In-Interest Transactions

Certain Plan investments are units of mutual funds and common collective trusts managed by Fidelity Investments (“Fidelity”). Fidelity is an affiliate of Fidelity Management Trust Company, the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. OneDigital Investment Advisors, LLC is the Plan’s investment advisor and these transactions also qualify as part-in-interest transactions. Fees paid by the Plan for the investment management and investment advisory services amounted to \$51,812 for the year ended December 31, 2024.

Effective September 1, 2024, Fidelity provides certain administrative services to the Plan pursuant to a Plan Service Agreement between the Plan Sponsor and Fidelity. Fidelity receives revenue generated by certain Plan investment funds. The agreement provides that excess amounts in the Plan revenue account at the end of each calendar quarter may be applied towards allowable administrative expenses or allocated at the direction of the Plan Sponsor. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. During 2024, excess amounts of \$9,919 were remitted to the Plan and net against Plan administrative expenses.

Certain expenses of the Plan are paid directly by the Company and are therefore not included in the accompanying financial statements. Investment fund operating expenses are deducted from the fund’s assets and are reflected in share/unit prices.

Notes receivable from Plan participants qualify as party-in-interest transactions.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants will become fully vested, and net assets will be distributed to participants and beneficiaries in proportion to their respective account balances.

Note 7 Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

Participants in the Plan have the ability of selecting various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across a variety of participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

At December 31, 2024, one investment option accounted for more than 10% of the Plan's total net assets:

We have audited the financial statements of Bihler of America, Inc. Retirement Savings Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit") for the year ended December 31, 2024 and we will issue our report thereon dated July 31, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audits. We have communicated such information in our letter to you dated March 7, 2025.

Professional standards also require that we provide you with certain information related to our audit. Part I of this letter relays this required information. Part II details our comments and recommendations, all of which have been discussed with appropriate members of management, that are intended to improve the internal control or result in other operating efficiencies. We will be pleased to discuss this letter as well as the comments in further detail at your convenience, perform any additional study of these matters, or assist you in implementing the recommendations. We will review the status of these comments during our next audit engagement.

This letter does not affect our report on the above referenced financial statements of the Plan.

PART I COMMUNICATION OF INFORMATION AS REQUIRED BY PROFESSIONAL STANDARDS

A. Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Notes 3 and 4 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive estimates affecting the financial statements were:

Your estimate of the fair value of financial instruments is based upon the following:

Mutual Funds: unadjusted quoted prices in active markets for identical assets.

Common/Collective Trust: net asset value based upon quoted market prices of the underlying assets.

We evaluated the key factors and assumptions used to develop the fair value of financial instruments in determining that it is reasonable in relation to the financial statements taken as a whole.

There were no sensitive disclosures affecting the financial statements in the current year.

The financial statement disclosures are neutral, consistent, and clear.

B. Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

C. Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

D. Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

E. Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audits.

F. Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

G. Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

PART II COMMENTS AND RECOMMENDATIONS**A. Cyber Attacks and Responding to Breaches**

Plan fiduciaries have a responsibility to protect Plan information from cyber-attacks and respond to breaches promptly. According to the Department of Labor (DOL), Plan Sponsors should have a plan in place to address a breach.

We recommend an approach such as the following:

- Establishing procedures for how the Plan Sponsor and service providers will communicate with participants in the event of a breach and how they can protect their data.
- Creating a process for determining how a breach will be remedied.
- Documenting a process for how cybersecurity breaches are responded to and the steps that are taken to correct an actual breach, to demonstrate prompt action.
- Evaluate service providers and negotiate contract provisions to lower or mitigate the costs of correcting a possible cyberattack.

A. Cyber Attacks and Responding to Breaches (Continued)

- Review and understand the business insurance coverage limitations.
- Additionally, Plan administrators and fiduciaries should consult with their ERISA counsel.

Developing a plan will ensure that Plan Fiduciaries are ready to respond to a breach in a timely and effective manner.

B. Hardship Distribution Request

The IRS defines a hardship withdrawal as one that can only be made due to an immediate and heavy financial need. During our audit, we noted that one participant received a hardship distribution for the purchase of their principal residence. Although the purchase of a principal residence is listed as a qualifying event for a hardship distribution in the Plan documents, the new SECURE Act 2.0 adds additional eligibility requirements to receive this hardship distribution. We recommend management review the hardship distribution approval process with Fidelity to ensure that participants are adhering to the new eligibility requirements under SECURE Act 2.0.

PART III NEW AUDITING STANDARDS AND LAW CHANGES FOR YOUR INFORMATION

A. The SECURE 2.0 Act of 2022

The SECURE Act 2.0 (Setting Every Community Up for Retirement Enhancement Act) ("Act 2.0") became law on December 29, 2022, and builds upon the SECURE Act of 2019. Plan amendments will be required for the Plan to be in compliance with the Act and must be made by December 31, 2025. However, the Plan must be operating in accordance with the effective date of each new provision provided by the Act, regardless of the date Plan amendments are adopted. Some of the key provisions currently impacting Plan are:

- Required minimum distributions age increase,
- Option for employer matching contributions on employee student loan payments,
- Withdrawals for certain emergency expenses without penalty, and
- Increased dollar threshold for mandatory distributions.

We recommend the Plan Sponsor work with the TPA to identify all related provisions, effective dates, Plan amendments required, and impact on Plan administration to ensure compliance with the Act.
