Report on the Financial Statements

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of Ruvilla Solutions, LLC Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan and Trust were established on August 1, 2015 to provide health and other benefits to eligible employees of Ruvilla Solutions, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes monthly contributions for participating employees covered under the Plan. For employees covered under contracts issued by Federal, State, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents. The provision of benefits that are funded from contributions by the employee, other than for separated participants, is not readily available information supplied to the third party administrator and therefore, such employee contributions are included in Employer Contributions in the Statement of Changes in Net Assets Available for Benefits.

Benefits

The Plan provides medical, dental, vision, life, accidental death and dismemberment benefits and prescription drug and employee assistance program coverage for eligible participants and their beneficiaries. The Plan provides vision, life, and accidental death and dismemberment benefits through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan. The Plan provides short-term disability through a self-insured arrangement. The Plan provides medical, dental, and prescription drug coverage benefits on both a level-funded basis and through contracts with insurance companies, depending upon participant classification. The Plan carries a stop-loss insurance policy which covers aggregate claims in excess of the funding factor as specified in the contract.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan's cash balances are held at four financial institutions located in California. Accounts at these institutions are insured by a government agency up to \$250,000. At times the balance in these accounts may exceed the insured limit.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

Contributions Receivable

Employer contributions due but not paid at year end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

Prepaid Contributions

Employer contributions paid but not yet obligated at year end are recorded as Prepaid Contributions. The Plan sponsor may use the pre-funding upon Plan termination or may choose to use the balance to offset required funding.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying Statement of Changes in Net Assets Available for Benefits. Benefits are recorded when paid. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as Benefit Claims Payable and Incurred, But Not Reported to claims administrators in the accompanying Statements of Plan's Benefit Obligations.

Insurance Premiums Payable

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year end.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefit Claims Incurred But Not Reported

The obligation for benefit claims incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported to and paid by the Plan after year end. The estimates were calculated based on the funding factor as noted in the insurance contract, with a maximum exposure limit. The funding factor contains certain assumptions pertaining to claims lag and historical claims data.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, trustee fees, accounting fees, and other miscellaneous expenses.

Health Reimbursement Arrangement

The Plan has a health reimbursement arrangement (HRA) that was funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer. Included in the accompanying statements of net assets are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling \$53,509 and \$28,916, respectively.

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan had no investment income during the Plan year ended December 31, 2024.

Subsequent Events

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENT OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at cost, which approximates fair value.

NOTE 4 TAX STATUS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 PLAN TERMINATION

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan Management or Plan Administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6 RE-INSURANCE LOSS COVERAGE

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained an insurance policy with Fidelity Security Life Insurance Company during the years ended December 31, 2024 and 2023. The policy provides reimbursement to the Plan for claim amounts paid in excess of the monthly funding factor for each participant. There is no limit on the maximum eligible claim expense per covered person under the policy. The insurance company is responsible for paying claims incurred in excess of the funding factor account balance, which was \$218,834 and \$246,659 as of December 31, 2024 and 2023, respectively.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants from Plan assets and the Plan is subsequently reimbursed by the insurance company if the funding factor is exceeded. During the year ended December 31, 2024, there were \$0 of stop loss recoveries netted against medical and other benefit claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits. There are no reimbursements due from the insurance company as of December 31, 2024 and 2023.

NOTE 7 RISKS AND UNCERTAINTIES

The estimate for claims incurred but not reported is based on certain assumptions pertaining to claims lag and historical claims data. The liability recorded is the Plan's maximum exposure to the claims incurred but not reported. Should the Plan's claims be lower than the amount deposited into the funding factor account, the Plan may be entitled to the residual balance in the funding factor account. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
