Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF THE PLAN

The following description of Maruho Hatsujyo Innovations Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of Maruho Hatsujyo Innovations Inc. (the Plan Sponsor) excluding union employees, non-resident aliens and leased employees. The Plan includes the employees of Maruho Hatsujyo Innovations Inc., Maruho Plastics Solutions Inc., Maruho Medical Inc. and Maruho Reluctant Inc. (collectively, the Company). During March 2024, Maruho Medical, Inc. closed, and thirty employees were terminated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee and Plan Administrator are responsible for the oversight of the Plan, monitoring investment performance and determining the appropriateness of the Plan's investment offerings.

b. Eligibility

The employees of the aforementioned companies are eligible to participate in the Plan and receive the Plan Sponsor's matching contributions immediately upon hire, as long as they have attained 21 years of age. Employees must be 21 years of age, have completed one year of service (1,000 hours), and be employed on the last day of the plan year to be eligible to receive the discretionary profit-sharing contribution.

c. Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who are the age of 50 or older are also permitted to make catch-up contributions into the Plan. The Plan provides for participants to contribute post-tax (Roth) contributions. Participants may also contribute amounts distributed from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor contributes 100% of the base compensation that a participant contributes to the Plan, up to 3%. During 2024, the Plan Sponsor made matching contributions of \$124,830. The Plan Sponsor may also make discretionary profit-sharing contributions, although during 2024, no discretionary profit-sharing contributions were made.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions and an allocation of plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan, if any. Allocations are based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. The following represents the vesting schedule of the Plan Sponsor's matching contributions:

Participants become fully vested in the Plan Sponsor's matching and discretionary profit-sharing contributions upon death or disability.

f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$1,000, and participants may only have a maximum of one outstanding loan at one time. The loans are secured by the balance in the participant's account. Loans must be repaid within five years, unless the loan is for the purchase of the participant's primary residence, in which case the term may be up to fifteen years. Interest is due on the outstanding principal balance at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

g. Payments of Benefits

Upon normal retirement at age 65 or termination of service, a participant may elect to receive either a lump-sum, installment payments or an annuity payment equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance is over \$5,000. There are also retirement benefits available upon disability or death. There is no option for early retirement. The Plan allows in-service withdrawals upon attainment of age 59 ½. The Plan requires balances up to \$5,000 be paid out to participants upon termination or rolled over to an Individual Retirement Account (IRA). Effective January 1, 2024, the limit of involuntary distributions increased from \$5,000 to \$7,000 under the provisions of SECURE Act 2.0.

h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeited non-vested amounts are used to reduce Plan Sponsor contributions or pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited non-vested amounts totaled \$68,310 and \$42,528, respectively. During 2024, there were \$43,148 of forfeitures used to pay for plan administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan's interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$6,500 of defaulted loans that were deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

Contributions

Contributions from plan participants and the matching contributions from the Plan Sponsor are recorded in the year which the contributions are withheld from compensation. Discretionary profit-sharing contributions from the Plan Sponsor are recorded when such contributions are authorized by the Plan Sponsor.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. The Plan Sponsor charges each participating organization an administrative fee based on eligible employee compensation and uses these funds to pay the majority of the costs of administering the Plan. Administrative expenses include fees related to the administration of notes receivable that are charged directly to participant's accounts. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a common collective trust (CCT). The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the CCT will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the CCT at an amount different from NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. COMMON COLLECTIVE TRUST

The Plan's investment in the CCT is represented by the CCT's underlying investment in the Reliance MetLife GAC Series 25053 CL 0, as of December 31, 2024 and 2023, which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered a fully benefit-responsive investment contract and is reported at fair value (see Note 4).

6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. PARTIAL PLAN TERMINATION

During 2024, the Plan was subject to a partial plan termination when plan participation decreased by greater than 20%. All benefits for participants affected by the partial plan termination became 100% vested.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their Plan Sponsor contributions and all accrued benefits shall be paid to participants in accordance with plan provisions.

9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution, expenses paid to the Plan's qualified institution out of plan assets, and notes receivable from participants are considered party-in-interest transactions. The Plan has a service agreement with the American Funds Service Company (American Funds), who has retained Capital Bank and Trust Company as a subcontractor to provide recordkeeping and trust services for investments in the Plan. Both American Funds and Capital Bank and Trust Company are considered parties-in-interest. During 2024, the Plan paid administrative expenses of \$49,003.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect participant account balances, and the amounts reported in the accompanying statements of net assets available for benefits.
