## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator  
The Pingree School, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Pingree School, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Pingree School, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Pingree School, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. DESCRIPTION OF PLAN**

The following description of The Pingree School, Inc. 401(k) Plan, (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General –**

The Plan is a defined contribution plan covering substantially all employees of The Pingree School, Inc., (the Employer) who are at least age 21. Leased employees, part-time, seasonal and temporary employees scheduled to work less than 1,000 hours during the year are excluded from participating. Effective January 1, 2024, pursuant to the Setting Every Community Up for Retirement Enhancement (SECURE) Act 1.0, long-term, part-time (LTPT) employees who work at least 500 hours during three consecutive 12-month periods became eligible to make elective deferrals in the Plan. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Advisor determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Retirement Plan Committee.

**Contributions –**

Each year, participants may contribute to the Plan a percentage of their eligible compensation, on a pre-tax or after-tax Roth basis, up to the maximum amount allowed by the Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a safe harbor non-elective contribution equal to 4% of each participant's eligible compensation. For the years ended December 31, 2024 and 2023, the Employer made safe harbor non-elective contributions totaling \$365,516 and \$343,858, respectively.

In addition, the Employer may make discretionary matching and profit sharing contributions to participants who have completed one year of service. Discretionary profit sharing contributions are allocated based on an integrated allocation, in accordance with the Plan agreement. The maximum allowable discretionary match is 4% of compensation. For the years ended December 31, 2024 and 2023, the Employer made discretionary matching contributions totaling \$358,203 and \$342,401, respectively. For the Plan years ended December 31, 2024 and 2023, the Employer did not make any discretionary profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts –**

Each participant's account is credited with the participant's contribution, the Employer's safe harbor non-elective contribution, an allocation of the Employer's discretionary matching and profit sharing contributions, if any, and actual earnings thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF PLAN (Continued)**

**Vesting –**

Participants are vested immediately in their contributions, the Employer's safe harbor non-elective contributions, and the Employer's discretionary matching and profit sharing contribution, plus actual earnings thereon.

**Notes Receivable from Participants –**

The Plan does not provide for loans to participants.

**Payment of Benefits –**

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account either as a distribution or a rollover. Partial withdrawals or installments are permitted for participants receiving minimum required distributions. A participant may withdraw from their rollover account at any time. A participant may also request an in-service withdrawal of all or any portion of their vested account balance upon attainment of age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$7,000 (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act), the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from the participant's rollover account and elective deferral account to meet a participant's immediate and heavy financial need, as defined in the Plan document.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates –**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition –**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits –**

Benefits are recorded when paid.

**Administrative Expenses –**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Date of Management's Review –**

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:*

Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The Plan’s investments at fair value as of December 31, 2024 and 2023 are made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The Plan has no assets as of December 31, 2024 and 2023 that are classified in the fair value hierarchy.

There were no transfers to or from Levels 1, 2, and 3 during the Plan years ended December 31, 2024 and 2023.

**Investments Measured Using the Net Asset Value per Share Practical Expedient –**

Accounting standards require disclosure of investment strategies for investments valued using net asset value as a practical expedient to estimate fair value if the investment does not file a Form 5500 with the DOL as a direct filing entity (“DFE”). The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**4. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the trustee of the Plan).

**5. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**6. TAX STATUS**

The Plan has adopted a prototype non-standardized profit-sharing plan and relies on the prototype plan's opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would remain 100% vested in their accounts.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by affiliates of John Hancock Life Insurance Company, the trustee of the Plan, which qualify as party-in-interest transactions.
