Notes to Financial Statements

1. **Description of the Plan** The following description of the Zimmerman Associates, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Zimmerman Associates, Inc. (the "Company") who are at least 18 years old, except for temporary, part-time, and casual employees, residents of Puerto Rico, and employees covered by a collective bargaining agreement. If temporary, part-time, or casual employees reach age 21 and complete 1,000 hours of service during an eligibility computation period they will be eligible for Plan purposes and may enroll at the next entry date. The Plan provides for multiple classes of employees. Class C employees are Service Contract Act employees hired on or after August 1, 2008, who do not exhaust their wage determination amounts by purchasing the mandated benefits required by the Company. Class B employees are all other Service Contract Act employees. Class A employees are all other employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for discretionary matching contributions. During 2024, the Company contributed 100 percent of the first three percent of compensation that a participant contributed to the Plan. Profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. There were no such contributions during 2024. The Plan provides for Company prevailing wage contributions on behalf of certain Class C participants. The amount of the contribution shall be equal to the balance of the fringe benefit payment for the Class C participant based on the employment classification hourly contribution rate reduced by the amount of the benefits provided by the Company. The Company designates employees who work certain contracts as a subset of Class C participants. For these participants, the balance of the fringe obligation is not contributed to the Plan. Additionally, any matching contribution for these participants is limited to the lesser of 100 percent up to three percent of compensation deferred or any remaining fringe obligation. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary profit sharing contribution, if any, Company prevailing wage contributions, as applicable, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions and prevailing wage contributions plus actual earnings thereon. Class A participant vesting in the Company matching and profit sharing contributions is based on years of continuous service. Class A participants are 25 percent vested after two years of service is completed, and vest an additional 25 percent per year until full vesting after five years. Class B and Class C participants vest immediately in all Company contributions.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 55 with five years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollovers are permitted at any time. Benefits are payable in lump sum, partial or installment payments.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,065 and \$33,282, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, \$92,126 of forfeited nonvested accounts were used to reduce Company contributions and no forfeited accounts were used to pay Plan expenses.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest as determined by the Plan administrator based upon prevailing rates. Principal and interest are paid through payroll deductions.

2. Significant accounting policies

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan administration fees, are charged directly to the participant's account and are included in administrative expenses.

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and Company discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit sharing contributions, if any, are recognized in the period the related eligible compensation is paid to the participant. Company prevailing wage contributions, if any, are recognized in the period the hours were worked.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through July 31, 2025, which is the date the financial statements were available to be issued.

3. Certified information Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

Investments in all collective trust funds can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. Full redemption by the Plan Sponsor may require a twelve month written notice to Fidelity Management Trust Company. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for this investment as of December 31, 2024 and 2023.

5. Risks and uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

6. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

During 2024, the Company had layoffs which resulted in a partial plan termination. The affected terminated participants became 100 percent vested in all accounts.

- 7. Tax status** The Plan is a pre-approved plan of FMR, LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper as defined by the Plan. Fees paid to Fidelity Management Trust Company for these services amounted to \$8,159 for the year ended December 31, 2024. The Plan is a party to a plan expense agreement with Fidelity Management Trust Company. Under this agreement, the Plan receives quarterly revenue credits, which are available to pay Plan expenses or to be allocated to participants. The Plan received revenue credits totaling \$26,543 which is reported as other income in the Statement of Changes in Net Assets Available for Benefits. During the Plan year ended December 31, 2024, the Plan paid its audit firm a total of \$15,225 for audit services from the revenue credits received under this agreement. There were no amounts allocated to participant accounts for the year ended December 31, 2024. At December 31, 2024 and 2023, the balance in the Plan expense account totaled \$34,777 and \$22,148, respectively. These transactions qualify as exempt party-in-interest transactions.
