Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fujimi Corporation Profit Sharing & Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fujimi Corporation Profit Sharing & Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. Plan Description

The following description of the Fujimi Corporation Profit Sharing & Pension Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Fujimi Corporation (the Company) who are age 19 or older and have completed six months of continuous employment, except for union employees, nonresident aliens, residents of Puerto Rico, and employees who are foreign nationals benefiting under the parent company's plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective January 1, 2022.

Contributions

Participants may elect annually to contribute, on a pre-tax or after-tax Roth basis, up to 100 percent of their annual compensation, limited to the amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional pre-tax or after-tax Roth "catch-up" contributions. The Company makes a 5 percent fixed matching contribution and 5 percent fixed employer contribution in accordance with restated plan provisions. The Company may also make a discretionary profit sharing contribution. For the years ended December 31, 2024 and 2023, the Company elected to make a discretionary secondary profit sharing contribution of 5 percent.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, and Plan earnings and expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts between several investment alternatives available within the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100 percent vested in Company contributions and earnings thereon after completing 5 years of vesting service (defined as one calendar year in which a participant has at least 1,000 hours of service) according to the following schedule:

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their accounts or up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Principal and interest installments are paid monthly over a period up to 5 years, unless the loan is for the purchase of a principal residence, in which case the loan may be repaid over a period up to 10 years. Only one loan may be outstanding at a time unless one is a loan for a principal residence amortized for a period greater than 5 years. The loans are secured by the balance in the participant's account and will bear a reasonable rate of interest.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant (or their designated beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, regular periodic payments, or life annuity. In-service withdrawals are permitted from employee deferrals upon attainment of 59½ years of age or from rollover accounts at any time. Withdrawals from a participants' deferral balance, may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

Forfeited Accounts

The non-vested account of a participant shall be forfeited if a participant is terminated. These accounts are allocated to participant accounts based on the ratio of a participant's eligible compensation to total eligible compensation of active participants. During the years ended December 31, 2024 and 2023, \$72,670 and \$38,937, respectively, was forfeited from participant accounts. During the years ended December 31, 2024 and 2023, forfeitures of \$39,656 and \$38,484, respectively, were allocated to participant accounts. At December 31, 2024 and 2023, unused forfeited accounts were \$72,670 and \$39,656, respectively, all of which was allocated to participant accounts in the subsequent year, in accordance with the Plan document.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Summary of Accounting Policies, continued

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement. The Plan's guaranteed interest account is carried at contract value which represents deposits, plus interest, less withdrawals.

Investment transactions are accounted for on the trade date (date the investment securities are purchased or sold). Both the average cost and specific identification methods are used in determining the cost of investment securities sold. Interest income is accounted for on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are valued at their outstanding balances plus accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Certain administrative expenses are paid directly by the Company and are therefore excluded from these financial statements. Certain participant transaction fees are paid by the Plan from assets in that participant's account. Investment related expenses are included in net change in fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Prepared and Certified by Custodian

4. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Standard Insurance Company (The Standard), included in the statements of net assets available for benefits as a guaranteed interest fund. The Standard maintains the contributions in a pooled account (Stable Asset Fund), which is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. All assets in the guaranteed interest fund are credited with interest using a declared quarterly rate determined by The Standard and stated in advance of the coming quarter. There is no specific portfolio of assets in which the guaranteed interest fund invests. The credited interest rate is backed by the income received from assets held in The Standard's general account. The rate will never be below 1 percent and has no maximum interest rate for the Stable Asset Fund. Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with The Standard. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. Based on these factors, The Standard has certified that the fair value of the insurance contracts is equal to the current contract value.

5. Related Party and Party in Interest Transactions

Certain Plan investments are managed by Standard Insurance Company or an affiliate. Standard Insurance Company is the custodian as defined by the Plan and therefore these transactions qualify as party in interest transactions. Administrative fees and other direct compensation paid to StanCorp Financial Group from Plan assets were \$51,226 and \$43,261 for the years ended December 31, 2024 and 2023, respectively, of which a portion is netted against investment earnings. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

7. Tax Status

The Internal Revenue Service (IRS) issued an opinion letter on June 30, 2020, stating that the Volume Submitter Profit Sharing Plan with Standard Retirement Services, Inc. qualifies under Section 401(a) of the IRC and the related trust is therefore not subject to tax under present income tax law.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under professional standards are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

9. Fair Value Measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate pooled account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
