Notes to the Financial Statements

Note 1 - Plan Description

The following description of John Bowman, Inc. Employee 401(k) Plan Employee 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualifying employees of John Bowman, Inc. Employee 401(k) Plan (the "Company"). Employees are eligible to begin participating on their date of hire. An employee must complete at least 1,000 hours of service during the year and be employed on the last day of the plan year to be eligible to receive the Company's discretionary non-elective contribution. There is no eligibility requirement for prevailing wage contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The trustees of the Plan, who are officers of the Company, and the Company as the plan administrator, are responsible for the oversight of the Plan. The 401(k) Plan Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On December 29, 2022, the Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act introduces numerous provisions intended to improve retirement savings opportunities and administration for retirement plans. There are both optional and required provisions as a result of the Act which become effective at various dates through 2028. As of December 31, 2024, the Plan Sponsor has evaluated the provisions of the SECURE 2.0 Act and has adopted or intends to adopt certain provisions as outlined below:

Required Minimum Distributions - Effective January 1, 2023, the Plan adopted the required minimum distribution age of 73

Mandatory Distribution Threshold - Effective January 1, 2024, the Plan increased the mandatory distribution threshold to \$7,000.

Catch-Up Contributions - Effective January 1, 2025, participants aged 60 to 63 may be eligible to make higher catch-up contributions.

The Plan Sponsor is working with its Plan partners and advisors to ensure timely compliance with relevant SECURE 2.0 Act provisions as they become effective. The impact on the Plan's financial position, changes in net assets, and plan operations is not expected to be material as of the date of this report.

Note 1 - Plan Description (continued)

Contributions

Each year, participants may contribute up to the amount allowed by law of annual compensation, as defined in the Plan, on a pretax or after-tax basis. Deferral and after-tax Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, the Company may make contributions to the Plan for employees, subject to prevailing wage laws, which are determined by the employer based on rates that satisfy the wage determination issued by the governmental agency responsible for the contract. Contributions may also be made for employees who are not subject to such prevailing wage rates, at rates determined by the employer. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company may, at its discretion, make a nonelective contribution in an amount to be determined each plan year, and allocated according to the Plan. For the year ended December 31, 2024, the Company made no contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, the Company's prevailing wage contributions (if applicable), and allocations of plan earnings (losses). Participant accounts may also be charged with an allocation of certain administrative fees that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a various mutual funds as investment options for participants. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their contributions and Company discretionary nonelective contributions, plus actual earnings thereon. A participant is 100% vested in Company contributions made in accordance with prevailing wage provisions.

Note 1 - Plan Description (continued)

Payment of Benefits

Upon termination of service due to death, disability retirement, or other reasons a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for in-service distributions upon attaining age 59 1/2. Hardship withdrawals are available if the participant meets certain criteria.

Forfeited Accounts

Forfeitures are used to pay administrative expenses for the Plan and/or reduce future Company contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. For the year ended December 31, 2024, no forfeitures were used.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, and the asset custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Excess Participant's Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$0 and \$-, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding decrease to participant contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through July 21, 2025, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure, except as discussed in Note 1.

Note 3 - Information Prepared and Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and non-interest bearing cash, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest and dividend income and net change in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- The schedule of assets held at end of year included as supplemental information.

Note 4 - Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Party in Interest Transactions

Matrix Trust Company is the asset custodian and TPP Retirement Plan Specialists, LLC is the recordkeeper of the Plan. CPTPA Services, LLC provides third party administration services to the Plan, and Olson, Reyes and Sauerwein, LLC performs the audit for the Plan. Transactions with these companies qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2024, the Plan made direct payments of \$72,700 to parties in interest which were not covered by revenue sharing.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Plan has adopted a non-standardized prototype plan, which obtained a favorable advisory letter from the United States Treasury Department dated June 30, 2020, stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code (IRC), and is therefore exempt from Federal income taxes. The plan administrator and Company management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
