## INDEPENDENT AUDITORS' REPORT

To the Retirement Committee of

**Commodore Homes, LLC 401(k) Retirement Plan and Trust**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of **Commodore Homes, LLC 401(k) Retirement Plan and Trust** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023 and for the period ended October 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of delinquent participant contributions for the period ended October 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### (1) Description of the Plan

The following description of the **Commodore Homes, LLC 401(k) Retirement Plan and Trust** (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

- A. **General** – The Plan was established on January 1, 2022 and was a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provided for employee pre-tax, Roth and after-tax contributions, and discretionary matching employer contributions in accordance with Sections 401(k) and 401(m) of the Internal Revenue Code (“IRC”). Employees of Commodore Homes, LLC (the “Company” or the “Plan sponsor”) were eligible to participate in the Plan upon attaining the age of 18 and satisfying the service requirement of 60 days. Employees could enter the Plan on the first day of the month following the date they satisfy the Plan’s eligibility requirements.

Beginning in March 2024, the employees of Commodore Homes, LLC were merged into the Cavco Industries, Inc. 401(k) Plan. As a result, assets totaling \$21,292,783 were transferred from the Commodore Homes, LLC 401(k) Retirement Plan and Trust to the Cavco Industries, Inc. 401(k) Plan. Effective April 1, 2024, employees previously participating in the Plan became eligible to participate in the Cavco Industries, Inc. 401(k) Plan.

- B. **Plan administration** – The Plan was administered by the Company’s Retirement Committee (the Committee). The Committee had the power to carry out the provisions of the Plan including the administration of the Plan, to determine the appropriateness of the Plan’s investment offerings and monitor performance. 1st Source Bank was the directed trustee, had custody of the Plan’s investments, and served as the recordkeeper.
- C. **Contributions** – Each year, participants could contribute a percentage of their pretax annual compensation up to the maximum amount allowed by law, as defined in the Plan. Contributions were subject to certain IRC limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan allowed participants to designate contributions as after-tax contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan Sponsor could also make discretionary matching contributions or other discretionary employer contributions to the Plan. Employees meeting the eligibility requirements above were eligible for the discretionary employer contributions, while employees must work 1,000 hours during the Plan year and be employed on the final day of the year to be eligible for the discretionary employer matching contribution. For 2024, the Company did not make any discretionary matching contributions to the Plan.

The Plan included an auto-enrollment provision, whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in an age-weighted fund until changed by the participant.

- D. **Participant accounts** – Each participant’s account was credited with the participant’s contributions, the Plan sponsor’s matching contributions, and allocations of (a) the Plan sponsor’s discretionary employer contribution and (b) Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s account.

### (1) Description of the Plan (continued)

- E. **Investments** – Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change their investment options daily.
- F. **Vesting** – Participants were immediately vested in their contributions plus actual earnings thereon. The participant's vesting in the Plan sponsor's matching and discretionary employer contributions, plus actual earnings thereon, was based on years of credited service. The vesting percentage was based on the following years of credited service:

- G. **Distributions** – Participants could elect to receive a lump-sum amount equal to the value of their vested interest as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 could be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 could still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions could be made at the participant's election prior to termination upon attainment of age 59 and a half or hardship as defined in the Plan document.
- H. **Unallocated accounts** – Unallocated accounts included forfeited non-vested Plan sponsor contributions. At December 31, 2023, unallocated accounts totaled \$0. The unallocated accounts could be used to reduce future Plan sponsor matching contributions or to pay certain Plan administrative expenses. During 2024, no unallocated non-vested accounts were used to reduce Plan sponsor matching contributions or to pay Plan administrative expenses.
- I. **Notes receivable from participants** – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, unless the loan was used for the purchase of a primary residence in which case the term could be extended to fifteen years. Loans were secured by the balance in the participant's account and bear interest at 2% above the prime rate at the date the loan is made. Principal and interest were paid ratably through payroll deductions.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The Plan follows accounting principles generally accepted in the United States of America using the accrual basis of accounting in preparing its financial statements.

**Management's use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### (2) Significant accounting policies (continued)

**Investment valuation and income recognition** – The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determined the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements. The common / collective trust was valued based upon the quoted redemption value of units, or the equivalent of net asset value, which is a practical expedient for estimating fair value. This investment had no unfunded commitments as of December 31, 2023, and could be redeemed daily with no redemption notice period or other redemption restrictions.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation of fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative expenses** – The Plan permitted the payment of administrative expenses to be made from Plan assets. These expenses could be paid using the Plan's assets in the following methods: (1) allocated among the accounts of all participants, (2) from unallocated accounts (see Note 1), or (3) from a specific participant account if the Plan incurs costs directly attributable to a particular participant in the Plan.

**Risks and uncertainties** – The Plan provided for investments in various fund options, which in turn invested in any combination of stocks, bonds and other investment securities. Investment securities were exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Benefits paid to participants** – Benefits were recorded when paid.

**Notes receivable from participants** – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent notes receivable were recorded as distributions based on the terms of the Plan document.

**Subsequent events** – The Plan's management has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued.

### (3) Party-in-interest transactions

Administrative fees paid to 1<sup>st</sup> Source Bank by the Plan amounted to approximately \$41,000 for the period ended October 31, 2024. These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

### (4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common / collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. This investment has no unfunded commitments as of December 31, 2023. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**(5) Federal income tax status**

The Prototype Plan obtained a favorable opinion letter from Internal Revenue Service dated June 30, 2020 stating that the Prototype Plan was designed in accordance with the applicable regulations of the Internal Revenue Code. The Plan administrator has not obtained an individual determination letter for the Plan. The Plan sponsors and the Plan administrator believe that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan and related trust were tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**(6) Information certified by the trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, 1<sup>st</sup> Source Bank has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments
- Net appreciation in fair value of investments
- Interest and dividends

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**(7) Non-exempt transactions**

The DOL's regulations require defined contribution plans to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but not later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2023, the Company failed to remit certain participant contributions to the Plan in a timely manner constituting a lending of such monies to the Company. As such, these transactions represented non-exempt transactions between the Company and the Plan as identified in Schedule H, Line 4(a), Schedule of Delinquent Participant Contributions. These participant contributions during the year ended December 31, 2023 totaling approximately \$7,800 were remitted to the Plan during the year ended December 31, 2023. During the period ended October 31, 2024 management made a correction for lost earnings on these contributions.
