### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Mathis Brothers 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan consisting of a 401(k) compensation deferral arrangement. It covers all employees (participants) of Mathis Bros. Oklahoma City LLC and affiliated companies (collectively, the Employer). Employees who have reached 19 years of age and have completed two months of service are eligible to participate in the Plan. The Plan is administered by the Plan's Fiduciary Committee (the Committee) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### ***Contributions***

Participants contribute an elected amount of their eligible compensation to the Plan, not to exceed limitations established by law. The maximum employee contribution was \$23,000 and \$22,500 for 2024 and 2023, respectively. The Plan agreement provides for an automatic 6% deferral of eligible compensation, unless a different percentage is chosen, for new participants entering the Plan. The amount of the automatic enrollment will increase by 1% each year up to a maximum of 10%, unless changed by the participant. Participants may make catch-up contributions if the participant is at least age 50 by the end of the year. The maximum catch-up contribution was \$7,500 for 2024 and 2023.

The employer matches 20% of the first 25% of the participant's contribution, not to exceed 25% of the employee's eligible compensation each payroll period.

Rollovers from other plans to this Plan may come from other qualified plans, tax sheltered annuity plans, governmental 457 plans or IRA's.

The Employer may make additional contributions to the Plan each year as determined at its discretion. The Employer may choose not to make such discretionary contributions to the Plan for a particular year. For 2024 and 2023, the Employer chose not to make a discretionary contribution.

##### ***Participant Accounts***

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, Employer's contributions, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their elective deferral contributions, plus the earnings (losses) thereon. Employer contributions and the earnings (losses) thereon, become 100% vested at retirement age, as defined in the Plan, or in the event of death or disability.

***Forfeited Accounts***

Upon termination of a participant's employment with the Employer, the non-vested portion of the Employer's matching and discretionary contributions may be used to pay the Plan's administrative expenses or to reduce future Employer contributions. Forfeitures were used to reduce Employer contributions by approximately \$35,000 and \$34,000 for 2024 and 2023, respectively, and pay Plan administrative expenses of approximately \$51,000 and \$90,000 for 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts were \$199,355 and \$109,202, respectively.

***Payment of Benefits***

On termination of employment, including retirement, death, or total and permanent disability, a participant may elect to receive a lump-sum payment, part lump-sum and part installments, or installment payments over a specified period of time not exceeding the applicable life expectancy of the participant, or the joint life expectancy of the participant and designated beneficiary.

***Notes Receivable from Participants***

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000, less any previous outstanding notes, or 50% of their vested account balance. The minimum amount of any note shall be \$1,000. Note repayment terms are specified in the promissory note, and participants are limited to two outstanding notes. The notes are secured by the balance in the participant's account. The notes bear interest at rates that are commensurate with local prevailing rates at the date of issuance. Participants may only have two loans outstanding at any given time. Principal and interest is paid ratably through payroll deductions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements is as follows.

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (UG GAAP).

***Use of Estimates***

The preparation of financial statements UG GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures; accordingly, actual results may differ from those estimates.

***Benefits***

Benefits are recorded when paid.

***Investments Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Expenses***

Administrative expenses of the Plan are paid by the Plan unless otherwise paid by the Employer at the Employer's discretion. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreement.

**NOTE C - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by affiliates of Empower Trust Company, LLC, the custodian of the Plan (Custodian). Empower Retirement, LLC, an affiliate of the Custodian, is the record keeper as defined by the Plan. Investment transactions and fees associated with these transactions between the Plan and Custodian, or affiliates thereof, qualify as exempt party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**NOTE D - FAIR VALUE MEASUREMENTS**

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Investment Trust:** Valued at NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE F - TAX STATUS**

The Plan is based on a prototype plan which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating the Plan is a qualified plan under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - FINANCIAL DATA CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Trust Company, LLC has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.
