INDEPENDENT AUDITOR’S REPORT

To the Trustees,
Monteleone Interests Profit Sharing and 401(k) Plan and Trust,
New Orleans, Louisiana.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Monteleone Interests Profit Sharing and 401(k) Plan and Trust, (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (and of changes in accumulated plan benefits) for the year ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 31, 2024 and 2023 and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The following description of the Monteleone Interests Profit Sharing and 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of New Hotel Monteleone, L.L.C. and Monteleone Management, L.L.C. (the “Employers”) who have one year of service and are 21 years of age or older. The Employers are a controlled group as defined in section 414(b) of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Each year, participants may contribute, by salary reduction pursuant to Section 401(k) of the Code, up to 75% of annual compensation, as defined in the Plan, subject to statutory limits. Participants may also contribute amounts representing eligible rollover distributions from other qualified pension plans.

In any plan year, the Employers may make discretionary matching contributions based on a percentage of each eligible participant’s deferred compensation. The Employers may also make discretionary profit-sharing contributions based on a percentage of each eligible participant’s compensation. These percentages will be determined each year by the Employers and will be limited to the amount deductible under applicable provisions of the Code.

For the year ended October 31, 2024, the Employers contributed \$118,822 to match 25% of deferrals up to 6% of each participant’s compensation and \$175,606 to make a profit sharing contribution of 1.5% of compensation for each eligible participant.

Note 1 - PLAN DESCRIPTION (Continued)

c. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employers' matching contributions, as well as allocations of employer profit sharing contributions and plan earnings. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations of the Employers' matching contributions are based on salary deferrals, as defined in the Plan document. Allocations of plan earnings or losses and expenses are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their 401(k) deferral and rollover contributions plus actual earnings thereon. The Employers' matching contribution portion of a participant's account plus actual earnings thereon is fully vested after three years of credited service. The Employers' profit-sharing contributions portion of a participant's account plus actual earnings thereon is fully vested after six years of credited service.

e. Investment Options

The Plan provides a participant-directed investment program whereby participants select the investments for their accounts. The Plan currently offers several mutual funds and a money market fund as investment options to the participants. The funds represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable terms shall be no greater than five years unless the note receivable is used to purchase a participant's principal residence in which case the note receivable term will be determined at the time the note receivable is executed. Notes receivables are secured by the balance in the participant's account and bear interest at a rate equivalent to the current interest rate for similar loans from commercial sources. Interest rates on notes receivable from participants ranged from 5.25% to 10.5% as of October 31, 2024. Principal and interest is paid ratably through payroll deductions.

Note 1 - PLAN DESCRIPTION (Continued)

g. Payment of Benefits

On termination of service, a participant whose vested account balance exceeds \$1,000 can elect to receive benefits in the form of a lump sum amount, as defined in the Plan. Participants with balances of \$1,000 or less are subject to the mandatory cash out provisions of the Plan and will receive a lump sum equal to the fair value of the participant's vested interest in his or her account.

h. Forfeited and Other Unallocated Accounts

Forfeitures of nonvested profit sharing and matching accounts may be used to pay administrative expenses, restore forfeitures, or to reduce the Employers' contributions. Other unallocated accounts may only be used to pay administrative expenses of the Plan. Forfeited and other unallocated accounts totaled \$15,791 and \$10,220 as of October 31, 2024 and 2023, respectively. Forfeited nonvested accounts of \$5,900 and \$4,221 were used to reduce the Employers' contributions for the years ended October 31, 2024 and 2023, respectively.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

a. Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be required to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

c. Investment Valuation and Income Recognition (Continued)

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains (losses) on sales of investments and unrealized appreciation (depreciation) in fair value of investments are reported as net appreciation (depreciation) in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

d. Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments on the note receivable and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced, and the benefit payment is recorded.

e. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed 2024 and 2023 excess contributions of \$15,147 and \$2,525, respectively, to the applicable participants prior to January 15, 2025 and 2024, respectively.

f. Payment of Benefits

Benefits are recorded when paid.

g. Expenses

Certain Plan administrative expenses are paid directly by New Hotel Monteleone, L.L.C. and are excluded from these financial statements. Fees related to account administration and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

h. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the custodian of the Plan, in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, as follows:

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, as such:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of October 31, 2024 and 2023.

Money Market Fund: Valued at daily closing price as reported by the fund from an actively traded exchange.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of October 31, 2024 and 2023, there were no assets measured at fair value on a non-recurring basis.

Note 5 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

Note 6 - TAX STATUS

The sponsor of the non-standardized prototype plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the prototype plan qualifies under the provisions of Section 401(a) of the Code. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and ERISA. Therefore, the plan administrator believes the Plan was exempt from Federal income taxes as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - RISK AND UNCERTAINTIES

The Plan provides for various investments in mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 8 - SUBSEQUENT EVENT – SECURE ACT 2.0

Subsequent to October 31, 2024, plan management elected to implement certain provisions of SECURE Act 2.0 as follows:

- Catch-up contributions were expanded to the lesser of \$10,000 (indexed for inflation) or 150% of the standard age 50 catch-up limit for participants age 60-63.
- The maximum benefit for automatic distributions without consent, was increased to \$7,000.
- Roth contributions were allowed under the Plan in anticipation of the 2026 requirement for high income earners to make catch-up contributions to Roth accounts.

Plan management intends to formally amend the Plan for these provisions within timeframes required under the regulations.


