Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF PLAN

MetroNational Corporation Retirement Savings Plan (the Plan) is a qualified defined contribution plan established by MetroNational Corporation (the Company) effective April 1, 1985. The Plan is designed to provide employees an opportunity to save for retirement through a combination of employee and employer contributions. The Plan is intended to comply with the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

The Plan is administered by a Fiduciary Committee appointed by the Company's Board of Directors. Memorial City Mall and MetroNational Maintenance Company are also participating employers in the Plan.

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All employees of an employer who has adopted the Plan can generally join the Plan, except as noted in the plan document. Effective January 1, 2024, employees become eligible to participate in the Plan for elective deferrals and employer matching contributions after attaining age 21 and completing 3 months of service. Eligibility for nonelective employer contributions continues to require 12 months of service. Employees enter the Plan on the first day of the month coinciding with or following the date these requirements are met, provided they are still employed on that date.

Contributions: Eligible employees may contribute up to 90% of eligible compensation on a pre-tax and/or Roth after-tax basis, subject to IRS annual limits. Additionally, employees age 50 or older may make catch-up contributions. Participants may also make voluntary after-tax contributions of up to 25% of compensation. Contributions can be changed or suspended at any time. Participants may change their pre-tax elective deferral rate and investment funds election at any time.

Eligible employees can make rollover contributions to the Plan any time after they start working for the Company, regardless of their age and years of service.

The Plan features an automatic enrollment provision, under which eligible employees who do not make an affirmative election will be automatically enrolled at a 3% deferral rate, with automatic annual increases of 1% per year up to 12%, unless the participant opts out. All highly compensated employees are excluded from the Plan's automatic deferral program, and any automatic increases thereof.

The Plan provides for the following employer contributions:

Discretionary Matching Contributions: The Company makes a matching contribution equal to 50% of employee elective deferrals up to 6% of compensation. For some divisions, this match is 33% of deferrals up to 6% of compensation.

Nonelective Contributions: The Company may make a discretionary nonelective (profit-sharing) contribution. For 2024, the Company contributed \$526,684, allocated on a pro-rata basis among eligible employees within specific business divisions.

Qualified Nonelective Contributions (QNECs) may also be made to satisfy nondiscrimination testing requirements.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are always 100% vested in their elective deferral accounts, qualified nonelective contributions account, and matching contributions account. Participants are also 100% vested in any rollover account they may have in the Plan.

Employer profit sharing contributions are subject to a graduated vesting schedule. A participant receives a 20% vesting after one year of vesting service and an additional 20% vesting for each additional year of service. Participants become 100% vested after five years of service.

Employer nonelective contributions are also subject to a graduated vesting schedule. A participant receives a 20% vesting of their nonelective account after two years of vesting service and an additional 20% vesting for each additional year of service. Participants become 100% vested after six years of service.

Payment of Benefits: A distribution can be made to a participant if they request one due to disability, retirement, or termination of employment from the Company or any related employer. A participant's beneficiary or beneficiaries may request a distribution of their vested account balance in the event of death.

Participants may defer receipt of their distribution until a later date. However, a participant cannot postpone it if their vested account balance is \$5,000 or less in which case the Plan will direct Fidelity Management Trust Company (Fidelity), that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA) for the participant's benefit. If a participant's vested account balance is \$1,000 or less, the Plan will direct the trustee to distribute it to the participant as a lump sum distribution without consent. Prior to such distribution participants have the right to request that the amount be distributed directly to them as a lump sum payment or to request that it be rolled-over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

Participants can request an in-service distribution from certain deferrals and their earnings for any reason once they attain age 59½. The Plan also allows hardship distributions in the event of an immediate and heavy financial need.

Notes Receivable From Participants: Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their total vested account balance, reduced by their highest combined outstanding loan balance at any time during the prior 12-month period. Loans are adequately secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid ratably through regular payroll deductions over a period not to exceed five years, unless the loan is obtained to purchase a principal residence, for which the Company may permit a longer repayment period not to exceed 15 years.

Forfeitures: If a participant terminates employment with the Company and is less than 100% vested in their employer account, the participant may forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. During 2024, approximately \$33,043 of forfeitures were used to offset Company matching contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$47,164 and \$1,864, respectively.

Plan Termination: The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate, with the approval of the Board of Directors. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Plan administrator will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the trustee.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 31, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: Valued by the trustee using the NAV of the collective trust times the number of units held by the Plan. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets held by the fund less its liabilities. There are no unfunded commitments related to its investments, or significant restrictions on redemptions. The Plan may redeem its investment on a daily and immediate basis.

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds investments managed by Fidelity. Fidelity is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Fidelity qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
