1. Description of Plan

The following description of the Butler Weihmuller Katz Craig LLP Employee Benefits and Cafeteria Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Butler Weihmuller Katz Craig LLP (collectively referred to as the “Company, “Employer”, or “Plan Sponsor”) established the Plan on December 1, 1991 through an employee benefit trust. The Plan was amended and restated as of January 1, 2019. The purpose of the Plan is to provide health and welfare benefits to covered participants administered by the Plan Sponsor. The Plan covers all partners, attorneys under contract, and regular active employees (employed on a regular basis consisting of at least 30 hours weekly) following 30 consecutive days of employment. Additionally, the employee’s spouse and dependent children are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Benefits

The Plan covers health expenses incurred by participants. It provides for a network of preferred provider physicians and hospitals, a network of retail pharmacies to provide prescription drugs, additional preventative care benefits, and a co-payment provision for office visits to network physicians. Health benefit claims of active participants, dependents and beneficiaries are processed by a third party claims administrator, UMR, but the responsibility for payments to participants and providers is retained by the Plan. The Plan has purchased excess loss insurance coverage from a commercial insurance company to reduce the risk of unexpected, catastrophic claims losses.

The Plan also covers dental procedures, services and supplies, including preventative and diagnostic services, as well as basic and major services such as certain procedures for restorations, crowns and dentures subject to annual maximums and deductibles.

The Plan covers vision care, including an annual exam as well as prescription glasses or contact lenses subject to annual maximums.

Short-term disability benefit claims are processed by the Plan Sponsor and the responsibility for payments to participants are retained by the Plan.

The Plan also provides long-term disability, basic and supplemental life insurance, and accidental death and dismemberment insurance. Life insurance and disability benefits are provided by Unum.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

Funding Policy

The Plan is funded by both participants’ and the Plan Sponsor’s contributions. A determination of the amount of the contributions required from the participants and the timing of the contributions from the Plan Sponsor is within the sole discretion of the plan administrator. Required contribution levels are communicated to covered employees on an annual basis, or more frequently if changes in the contribution levels occur.

Contributions

The participants’ and the Plan Sponsor’s contributions to the Plan are used for the reimbursement of health and welfare expenses as defined by the Plan.

Stop-loss Coverage

The Plan includes certain “stop loss” insurance policies to provide reimbursement to the Plan of claim payments made over and above specified limits for both specific and aggregate claims. The stop loss limit for 2024 was \$135,000 per participant on an annual basis. The Plan paid \$656,216 in stop loss premiums for the year ended December 31, 2024, which is reported on the statement of changes in net assets available for benefits and benefit obligations as part of insurance premium expense. Premiums for long-term disability, basic and supplemental life, and accidental death and dismemberment benefits are paid through the Plan Sponsor’s contributions.

Administration of the Plan and Administrative Expenses

The Plan is administered by the Plan Sponsor's payroll and benefits department. Administrative expenses are paid by the Plan Sponsor from the trust in accordance with the Plan and are generally for claims processing fees and insurance broker fees. Administrative expenses paid by the Plan Sponsor on behalf of the Plan are not reimbursed by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor.

Insurance Premium Expenses

Premiums paid by either the Plan Sponsor or the trust are recorded as insurance premium expenses in the accompanying statement of changes in net assets available for benefits and benefit obligations.

Reserves For Claims Incurred But Not Reported

The reserve for claims incurred but not reported at December 31, 2024 and 2023, is an estimate calculated by UMR. The reserve is estimated based on applying historical lag analysis percentages of historical claims data to estimated future claims paid. The Plan has recorded a Plan Sponsor contribution receivable of \$857,669 and \$824,433 at December 31, 2024 and 2023, respectively, to cover the reserve for claims incurred but not reported.

Subsequent Events

Subsequent events were evaluated through July 31, 2025, the date the financial statements were available to be issued. There were no subsequent events identified that required recognition or disclosure in these financial statements.

3. Benefit Obligations

Health and welfare costs incurred by participants and their beneficiaries and dependents are covered by contributions maintained by the Plan. It is the present intention of the Plan Sponsor to continue providing benefits and for the Plan Sponsor to fund any benefit obligation in excess of net assets available for benefits, if applicable. However, circumstances may arise in the general course of business which could impact the Plan Sponsor's ability to provide these benefits.

4. Income Tax Status

As a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded at December 31, 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the Internal Revenue Code ("IRC") to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable sections of the IRC and, therefore, believes that the Plan is qualified and related trust is tax-exempt.

4. Income Tax Status (Continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.

5. Related-Party and Party-In-Interest Transactions

The Plan's cash is held in a checking account through Bank of America, the custodian of the Plan. Such deposit and withdrawal transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Furthermore, the Plan compensates UMR, its actuary and the claims administrator for its services from Plan assets. The Plan has also engaged with the following providers which are paid from Plan assets: OptumRx (prescription coverage), Voya Life Insurance Company (stop loss insurance), Unum (life insurance and disability benefits) and Superior Vision Services, Inc. (vision benefits administrator). These transactions are also exempt from the prohibition of party-in-interest transactions under ERISA.

6. Risks and Uncertainties

The estimate for claims incurred but not reported was based on certain assumptions pertaining to claims lag and historical claims data. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
