### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of AIAC International Pharma Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all employees of AIAC International Pharma LLC. ("the Company"). The Plan was organized effective May 18, 2015, and is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

As of December 31, 2024 and 2023 there were 252 and 243 active participants in the Plan, respectively.

##### Contributions

For 2024 and 2023, participants' could contribute up to a maximum of \$15,000, respectively, of pre-tax annual compensation, as defined in the Plan. In addition to the maximum amount of pre-tax contributions allowed under the Plan, participants' who have attained age 50 or over could make catch-up contributions of up to \$1,500 each plan year. Voluntary after-tax contributions are permitted up to 10% of the participant's compensation. Participants' directed all or a portion of the investment of their contributions into various investment options offered by the Plan. The Company matched participants' contributions at the rate of \$0.75 for each dollar of participant's pre-tax contribution, up to a maximum of 6% of participant's compensation. Additionally, the Company could have made additional contributions out of its net profit in such amounts as the Company determined, if any. No additional discretionary contributions were made for the years ended December 31, 2024 and 2023. Participants were also allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

##### Participants' accounts and forfeitures

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contributions and allocations of Company discretionary contributions, and Plan earnings. Company discretionary contributions are allocated based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' accounts and forfeitures (cont'd)

The portion of a participant's account not vested at the date of his termination of employment, is forfeited immediately. Forfeitures accrued during a plan year are used to reduce the employer's contribution to the Plan for the plan year immediately after the year in which forfeitures were made or distributed between the participants in proportion to its actual contribution to the plan in relation to total contributed to the Plan in that year or to reduce or pay the administrative expenses of the Plan, whichever is decided by the Plan Sponsors annually. At December 31, 2024 and 2023 there were no forfeitures on participants accounts.

Vesting period

Participants vesting period on the Company's discretionary contributions to their accounts plus actual earnings thereon are based on years of continuous service. Participants are 100% vested on all contributions on the first day of eligibility.

Payment of benefits

On termination of services due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period normally not exceeding five years. Upon termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50% of their vested balance not to exceed \$50,000. The loans are secured by the balance in the participant's account and bears interest at the rate between 4.75% and 10.50% for 2024 and 2023, respectively, and should not exceed (5) five years. Principal and interest is paid ratably through monthly payroll deductions.

Eligibility

To become a participant in 2024 and 2023, an employee will be eligible at first day of employment and no minimum age requirement.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Administrative expenses

Significant costs of plan administration are being absorbed by the Company.

Basis of accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition

The Plan's investments consist mainly of "units of participations" maintained in various investment funds held by the Trustee. Such investments are stated at fair value. Quoted market price are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Participant's loans are valued at the outstanding loan balances.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

During 2024 and 2023, the Plan's mutual fund investments and fixed income securities (including gain and losses on investments bought and sold, as well as held during the years) appreciated in value by \$1,121,612 and \$1,145,074, respectively.

**NOTE D - FAIR VALUE MEASUREMENT**

FASB ASC 820-10, “Fair Value Measurements and Disclosures” establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Basis of fair value measurement:

Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed income:* Valued at the closing price reported in the active market in which the individual security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PLAN TERMINATION**

Although it has not been expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE F - TAX STATUS**

The Plan is qualified under Section 1081.01 (d) of Internal Revenue Code for a New Puerto Rico of 2011, and therefore the trust is exempt from taxation. In the normal course of business, the Plan is potentially subject to income tax audits in the Commonwealth of Puerto Rico for its taxable years 2020 to 2024, until the applicable statute of limitations expire. Tax audits by their nature are often complex and can require several years to complete.

In general, contributions to a qualified plan are deductible by the Company when made, earnings of the trust are tax exempt and participants are not taxed on their benefits until withdrawn from the plan.

Management is unaware of any variations in the operation of the Plan from the terms of the Plan documents.

**NOTE G - RISKS AND UNCERTAINTIES**

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE H - PARTY-IN-INTEREST AND PROHIBITED TRANSACTIONS**

For the year ended December 31, 2023, the Plan remitted several participant contributions totaling \$199,049, to the trustee later than required by Department of Labor ("DOL") Regulation 2510.3-102. Participant accounts will be credited with earnings in accordance with DOL guidelines. There were no late remittances for the year ended December 31, 2024.

**NOTE I - ELIGIBLE DISTRIBUTIONS BY PUERTO RICO TREASURY DEPARTMENT**

On October 24, 2023, the Sponsor for the Plan authorized an amendment to allow withdrawals/distributions of up to \$10,000 for all participants in active employment, as well as to allow for up to the first \$100,000 of total lump-sum distributions to cover eligible expenses incurred due to the recent legislation under the Puerto Rico Internal Revenue Code ("PR Code") Section 1081.01 (b)(1)(D) and Circular Letter of Internal Revenue No. 22-13 issued on September 27, 2023 by the Secretary of the Puerto Rico Treasury Department, respectively, effective as of October 24, 2023 for distributions made until December 31, 2023, as this may be amended, extended or superseded.

**NOTE J - SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2024 have been evaluated is July 30, 2025, which is the date the financial statements were available to be issued.
