### Notes to Financial Statements

#### NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Performance Automotive 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan, established on January 1, 1984, is a defined contribution plan covering substantially all employees of Devco Holdings, Inc. and its subsidiaries thereafter collectively referred to as the "Company". Employees become eligible upon reaching age 18 and completing two months of continuous service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was amended and restated on November 5, 2021.

##### ***Contributions***

A participant may contribute up to 100% of eligible compensation on either a pre-tax or Roth after-tax basis. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for employees aged 50 and over. The Company may, in its discretion, match participants' 401(k) contributions, up to the limit determined by the Company. During 2024, the Company contributed 25% of employee contributions up to 8% of their eligible salary. The Plan allows for automatic enrollment of eligible employees at a 5% deferral rate.

The participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds on a pre-tax basis or Roth after-tax basis. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. A participant may change the amount of his or her elective deferral contributions anytime.

##### ***Rollover Contributions***

Participants may rollover to the Plan a distribution they receive from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service.

##### ***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is calculated daily based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## PERFORMANCE AUTOMOTIVE 401(K) PLAN

### Notes to Financial Statements (Continued)

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Vesting*

Participants are vested immediately in their rollover contributions, pre-tax contributions, Roth after-tax contributions and qualified non-elective contributions made on their behalf, plus actual earnings thereon. Participants vest in Company matching contributions in accordance with the terms of the Plan. The matching contributions are fully vested after 3 years of service. Forfeited matching contributions are used to reduce future matching contributions, or to pay the Plan's administrative expenses. During 2024, the Company used \$246,156 of forfeited matching contributions toward the employer match. Forfeited balances remaining in the Plan totaled \$7,563 and \$66,129 at December 31, 2024 and 2023, respectively.

##### *Payment of Benefits*

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is eligible for distribution in a lump sum or periodic installment payments. If a participant's vested interest is \$5,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible.

In-service distributions are permissible from all vested account balances for participants that have attained the age 59 ½, except to the extent a loan is secured thereby. Rollovers are eligible for distribution at any time.

In conditions of financial hardship, a participant may apply to the Plan administrator for approval to withdraw the portion of their elective deferrals and the vested portion of their match or profit sharing accounts necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

##### *Administrative Expenses*

The Plan's record keeping, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. All other expenses of the Plan are paid by the Company.

##### *Related-Party Transactions*

Empower Trust Company is the trustee and custodian, as defined by the Plan and, therefore, some transactions qualify as party-in-interest.

Certain administrative functions are performed by the officers or employees of the Company. The Plan is not charged by the Company for these services.

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions or other reasonable means acceptable by the Plan administrator.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value except for the fully benefit responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Benefit Payments*

Benefit payments are recorded when paid.

##### *Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

##### *Subsequent Events*

The Company has evaluated subsequent events through July 31, 2025 which is the date these financial statements were available to be issued.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Empower Annuity Insurance Company of America and Empower Trust Company, the trustee of the Plan, for the years ended December 31, 2024 and 2023 was certified by them to be accurate and complete with respect to the following:

- (a) The assets held by Empower Annuity Insurance Company and Empower Trust Company at December 31, 2024 and 2023 as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

#### NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

#### NOTE 6 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (the "Issuer"). The Issuer maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contracts. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. At December 31, 2024 management did not believe that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value was probable.

The crediting interest rate of the contract is based on an agreed-upon formula with the Issuer, as defined in the contract agreement, but cannot be less than 0%. Such interest rates are reviewed on a semi-annual basis for resetting. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contract; and the duration of the underlying investments backing the contract.

#### NOTE 7 TAX STATUS

The Plan has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. The letter states the providers' prototype, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
