### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Drew Marine Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the period from January 1, 2024 through November 13, 2024 and for the period from November 14, 2024 through December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Plan description

The following description of the Drew Marine Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all full-time employees of Drew Marine USA, Inc. (the "Company") who have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2019, the Plan was established due to the former plan sponsor, ACR Electronics Corporation ("ACR"), electing to transfer, or "spin off", the account balances attributable to the employees of the Company to the Plan. The effective date of the transfer was December 1, 2019. The Plan Administrator is responsible for oversight of the Plan. The 3(16) Investment Manager and Plan Administrator determine the appropriateness of the Plan's investment offerings, monitors investment performance and monitors investment performance. The Plan was most recently amended on December 15, 2020, with an effective date of January 1, 2021, to clarify language related to allowed contribution types, allow employees of Drew Marine International LLC to participate in the Plan, and to allow in-plan Roth rollover contributions. The Plan was also amended on November 19, 2020, to allow for escalation of the automatic deferral amount by 1% of compensation annually, up to a maximum of 8%, only for those participants that were automatically enrolled, effective April 1, 2021. Effective January 1, 2021, the Plan was amended to allow for employees to be eligible to participate in the Plan on the first day of the month following their hire date.

##### **Eligibility**

All employees except (a) union employees; (b) non-resident alien employees; (c) leased employees; (d) part-time employees (unless such part-time employee works at least 1,000 hours of service in an eligibility computation period); (e) temporary employees (unless such temporary employee works at least 1,000 hours of service in an eligibility computation period); and (f) residents of Puerto Rico and U.S. citizens employed exclusively by a foreign subsidiary are eligible to participate in the Plan.

##### **Contributions**

Each year, participants may contribute a portion of their compensation to the Plan on a pre-tax and/or after tax (Roth) basis per the Plan document subject to limits required by the Internal Revenue Code (the "IRC") of 1986. The IRC imposes limits on the amount of compensation that may be taken into account for any Plan year, and on the portion of such compensation that may be contributed into the Plan. The maximum amount that may be contributed into the Plan by participants on a combined pre-tax and/or after tax (Roth) basis in 2024 was \$23,000. A special rule for participants who are at least 50 years old before December 31 of a plan year allows these participants to make an additional "catch-up" contribution into the Plan if they have contributed the maximum permitted amount. For 2024, the maximum "catch-up" contribution was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. As noted above, an amendment was executed on November 19, 2020, with an effective date of April 1, 2021, for the automatic deferral increasing 1% annually up to a maximum of 8%, only for those participants that were automatically enrolled.

For eligible employees the Company contributes 100% of the first 5% of eligible compensation that a participant contributes to the Plan, subject to certain Internal Revenue Service ("IRS") limitations. The Company may also make discretionary profit sharing contributions, as determined by the Company. The Company did not make any discretionary profit sharing contributions during the years ended December 31, 2024 and 2023. Participants also direct the investment of the Company's contributions.

#### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's match and profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested if employed on or before December 6, 2019. If a participant is hired after December 6, 2019, they are vested after three years of credited service.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined, fixed for the duration of the loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### **Payment of benefits**

On termination of service due to death, disability, retirement or other reasons, a participant with a vested account balance greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a direct rollover distribution. A participant with a vested account balance of less than \$5,000 who does not elect a form of distribution will receive a lump-sum distribution.

#### **Forfeited accounts**

Forfeitures result from contributions remaining in the Plan from terminated employees who had nonvested employer contribution amounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,996 and \$6,669, respectively. These accounts will be used to reduce future employer contributions or reallocated to participant accounts. For the year ended December 31, 2024, forfeited amounts totaling \$34,274 were used to reduce employer contributions.

#### **Note 2 - Summary of accounting policies**

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Ascensus and Newport Trust Company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year ended December 31, 2024.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **Subsequent events**

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### **Note 4 - Related party transactions and party-in-interest transactions**

Certain Plan investments were invested in funds managed by Ascensus and Newport Trust Company, the trustee, or its affiliates as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions under ERISA. Loan fees paid by the Plan to Ascensus Newport Trust Company or its affiliates totaled \$4,025 for the year ended December 31, 2024. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan. Fees incurred by the Plan for investment management services are included in net appreciation as they are paid through revenue sharing versus a direct payment. Notes receivable from participants are also party-in-interest transactions.

#### **Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 6 - Tax status**

The prototype plan document, which the Plan has adopted in a non-standardized adoption agreement, obtained its latest opinion letter dated November 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan's adoption agreement has been amended and restated since receiving the opinion letter on the prototype plan, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held as of December 31, 2024, and investment income and interest income on notes receivable from participants for the period from November 14, 2024 through December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan. Investments and notes receivable from participants held as of December 31, 2023, and investment income and interest income on notes receivable from participants for the period from
