Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Kaiser Aluminum Bellwood SUB Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

(1) Description of plan

The following description of the Kaiser Aluminum Bellwood SUB Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan provides supplemental unemployment benefits ("SUB") to certain hourly employees employed at the Bellwood Extrusion Plant in Richmond, Virginia pursuant to labor agreements with the United Steelworkers and International Association of Machinists and Aerospace Workers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Contributions to the Plan are made by Kaiser Aluminum Fabricated Products, LLC (the "Company"), a subsidiary of Kaiser Aluminum Corporation, based on hours worked by covered employees subject to limitations. The Company generally funds the Plan's cash requirements.

(c) Payment of benefits

Participants are eligible for one week of SUB benefits for each credit unit they have earned. Generally, a participant earns a half credit for each week he or she works for the Company. The maximum number of weeks a participant may have is 104 weeks if he or she has 20 or more years of continuous service. The maximum for participants with 10 years, but less than 20 years of continuous service is 78 weeks. The maximum for participants with 2 years, but less than 10 years of continuous service is 52 weeks. Weekly benefits for participants with less than 10 years of service are limited when the financial position of the Plan does not exceed a certain threshold as defined by the Plan. As of December 31, 2024 and 2023, weekly benefits for participants with less than 10 years were not limited. Guaranteed benefits are funded by advances from the Company ("guaranteed payments") in the event of insufficient Plan assets. The Company may recover guaranteed payments from future Company contributions as defined by the Plan. The unrecovered amount advanced by the Company for guaranteed payments as of December 31, 2024 and 2023, was approximately \$87,000 and \$104,000, respectively.

(d) Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

(e) Plan termination

Under certain circumstances, the Plan may be terminated. Upon termination of the Plan, the assets remaining would be subject to the applicable provisions of the Plan then in effect. Benefits would continue to be paid until the assets of the Plan were exhausted.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are held in the Kaiser Aluminum SUB Plans Master Trust ("Master Trust"). Plan investments in the Master Trust are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and Principal Bank ("Principal").

Purchases and sales of securities within the Master Trust are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) of the Master Trust includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligations and changes therein, eligibility credits, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Company has evaluated events and transactions that occurred between December 31, 2024, and July 28, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Summary of information certified

Certain information related to Master Trust investments disclosed in the accompanying financial statements, including the fair value of investments held at December 31, 2024 and 2023, and plan interest in the Master Trust investment income for the years ending December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value held by the Master Trust. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Interest-bearing cash*: Valued at cost, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Interest in Master Trust

The Plan's investments are held in the Master Trust which was established for the investment of assets of the Plan and the Kaiser Aluminum SUB Plan, another Company-sponsored SUB plan. Each participating plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by Principal. Investment income is allocated on a daily basis through a valuation performed by Principal. Administrative expenses relating to the Master Trust are allocated to the individual plans based upon each plan's pro rata share, per share calculation, or specific transaction. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 0.0% and 0.5%, respectively.

Investment income for the Master Trust for the years ended December 31, 2024 and 2023, is \$40 and \$28, respectively.

(6) Benefit obligations

The Plan's benefit obligations (which are funded by the Company to the extent of available contingent liability, as defined in the plan document) represent potential amounts payable to participants currently on layoff, both claimed and unclaimed, taking into consideration anticipated forfeitures and integration with other related programs such as state unemployment benefits. The amount of benefit obligations attributable to potential future layoffs is not included in the Plan's benefit obligations. Based upon discussion with plan management, it was determined such amount could not be reasonably estimated due to the unpredictable nature of factors that enter into such valuations, such as future economic conditions. In 2024 and 2023, there were no benefit payments to participants. The benefit obligation was zero as of December 31, 2024 and 2023. Estimated contributions due from the Company at December 31, 2024 and 2023 total \$78,631 for each year.

(7) Income tax status

The Master Trust is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code ("IRC"), and, accordingly, the Master Trust is exempt from income tax. The Plan received a determination letter from the Internal Revenue Service ("IRS") in 1999, exempting it from income taxation. Plan management believes that the Plan continues to qualify and operate in accordance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and uncertainties

The Plan provides for investments in various securities through the Master Trust. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and plan benefit obligations.

(9) Related party transactions

Plan investments are held by Principal and, therefore, the purchase and sale transactions qualify as party-in-interest transactions. Administrative fees of \$3,740 in 2024 and \$3,255 in 2023 were paid by the Plan to Principal.
