## INDEPENDENT AUDITOR'S REPORT

The Plan Administrator  
Bush Industries, Inc. 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bush Industries, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Basis for Opinion

### NOTES TO THE FINANCIAL STATEMENTS

#### NOTE 1. DESCRIPTION OF PLAN

The following is a brief description of Bush Industries, Inc. 401(k) Retirement Plan (the Plan). Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established as of December 28, 1985 by Bush Industries, Inc. (the Company and the Plan Sponsor). The Plan has been subsequently amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company sponsors and administers the Plan through an Administrative Committee appointed by the Board of Directors of the Company.

**Eligibility:** The Plan covers all employees of the Company's North American operations who will be eligible to participate in the Plan upon their date of hire. The following employees are not covered under the Plan: employees covered by a collective bargaining agreement, employees classified as reclassified employees (an employee who was previously not treated as an employee of the employer but reclassified as an employee) by the Company, employees classified as leased employees by the Company, employees temporarily assigned to United States locations, and employees who are residents of Puerto Rico or who are performing services in Puerto Rico.

**Contributions:** Unless an election not to defer has been made, employees are automatically enrolled in the Plan at a contribution rate of 3% after 60 days of employment. Employees are automatically enrolled at a contribution rate of 5% with an auto-escalation to increase the deferral percentage 1% annually up to a maximum of 15%, unless otherwise elected by the participant. Participants may elect to contribute up to 75% of their eligible compensation limited to \$23,000 for the year ended December 31, 2024 (\$22,500 - 2023). Participants may go online at any time to increase or decrease their contribution percentages or to elect to no longer defer under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of eligible compensation, to be determined each year. The Company may also make a discretionary non-elective contribution to the Plan based on a percentage of each employee's compensation to the total compensation of all participants eligible to receive the contribution. The Company did not make a discretionary matching or discretionary non-elective contribution for the years ended December 31, 2024 and 2023.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and Company discretionary matching contributions as well as allocations of the Company's discretionary non-elective contribution and Plan earnings. Participant accounts are charged with any expenses directly arising from the participant's own activity. General administrative expenses incurred by the Plan are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately fully vested in their contributions plus earnings thereon. Participants are immediately fully vested in all the Company's discretionary contributions made to the Plan.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and must bear a reasonable rate of interest as determined at the time the loan is made, based on the quarterly prime rate plus 2%. Principal and interest are paid through payroll deductions made each pay period.

#### NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

**Payment of Benefits:** On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows in-service distributions for employees who have reached age 59 ½, and hardship distributions under certain circumstances.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The Plan prepares its financial statements on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. The Plan presents administrative expenses net of revenue credits received from the Plan Trustee.

#### NOTE 3. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a Guaranteed Investment Contract with an insurance company. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

#### NOTE 3. INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The guaranteed interest rate is announced semi-annually and is guaranteed against change for a six-month period. For the years ended December 31, 2024 and 2023, the guaranteed interest rate approximated the yield on 5-year treasury notes at the respective year end date. Interest income earned on the contract is included in interest and dividend income.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, or that would limit the ability of the Plan to transact at contract value with the participants.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, established a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is the closing price reported on the active market on which the securities are traded. Shares of registered investment companies are classified as Level 1 investments.

**Pooled separate accounts:** The separate accounts are stated at fair value based on the quoted market prices of the underlying mutual funds. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the NAV, or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

Empower Annuity Insurance Company certified the pooled separate accounts and the investment contract with insurance company. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent accountants.

#### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower during the years ended December 31, 2024 and 2023. Therefore, transactions with these parties qualify as party-in-interest. Administrative expenses paid by the Plan to the custodians amounted to \$990 during the year ended December 31, 2024 (\$5,360 - 2023).

Under Empower, the Plan earned revenue under a Revenue Credit Program. The total revenue earned under the Revenue Credit Program (revenue sharing), included in administrative expenses, was \$49,062 for the year ended December 31, 2024 (\$45,420 - 2023).

#### NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Participants are always 100% vested in their accounts.

#### NOTE 8. TAX STATUS

The Plan adopted a prototype plan and trust agreement sponsored by Empower Retirement LLC. Empower Retirement LLC received an advisory letter from the IRS dated September 16, 2022, which stated that the prototype plan satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS, however the Plan's management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
