## **Jazz Pharmaceuticals, Inc. 401(k) Plan Notes to Financial Statements**

### 1. Description of the Plan

Jazz Pharmaceuticals, Inc. (the Company) established the Jazz Pharmaceuticals, Inc. 401(k) Plan (the Plan), effective August 15, 2003, to provide benefits and tax-deferred savings opportunities to eligible Company employees. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a Plan Administrative Committee, composed of Company employees, responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests and reinvests Plan assets in the interest and direction of the participants and their beneficiaries.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, who have reached age 21 are immediately eligible to participate in and make contributions to the Plan.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax, after-tax Roth and after-tax salary deferral contributions of up to 80% of eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 are eligible to make an additional catch-up contribution under the Code. In addition, participants may contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

The Plan has an automatic enrollment feature under which all eligible employees are automatically enrolled in the Plan and have 3% of their compensation deferred and contributed to the Plan, unless they request a different amount to be contributed or formally decline participation. Participants may adjust their deferral rate or discontinue their contributions at any time.

#### 1. Description of the Plan (continued)

##### *Contributions:* (continued)

The Plan agreement requires the Company to make matching contributions equal to 100% of a participant's first 5% of their elected pre-tax and Roth salary contributions. The Plan requires an annual true-up for matching contributions, so the aggregate matching contributions during any given Plan year reflects an amount equal to the matching contributions had they been computed based on participant's year-to-date eligible compensation contributed to the Plan. The Company made matching contributions of \$16,460,563 in 2024, of which \$2,264,662 related to the true-up calculation and was recorded as an employer contribution receivable as of December 31, 2024.

The Company may also make discretionary matching and nonelective contributions to the Plan. No discretionary matching or nonelective contributions have been made to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

##### *In-Plan Roth Conversions:*

The Plan allows participants who are active employees of the Company to convert any portion of their after-tax contributions to Roth contributions. In 2024, \$663,525 of after-tax deferral contributions were converted to Roth accounts.

##### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, rollovers and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

##### *Vesting:*

Participants are fully vested in their account balances.

#### *Notes Receivable from Participants:*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, a minimum of \$1,000 and maximum of \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 10 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear interest at the prime rate plus 2.00% on the day the note is granted. Participants may only have one note outstanding. Interest rates on notes outstanding as of December 31, 2024 range from 5.25% to 10.50%. Repayment of principal and interest is generally made through payroll deductions.

#### *Payment of Benefits:*

On termination of service, participants may elect to leave their account balance in the Plan or receive benefits. Benefits are paid in a lump-sum cash distribution equal to the value of the participant account balance. Upon termination, the Plan may immediately elect to distribute participant account balances if the balance is less than \$7,000 without participant consent. Benefits are recorded when paid.

#### *Plan Expenses:*

The investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. Participant accounts are also assessed a separate fee for the administration of notes receivable. All other administrative expenses related to the Plan are paid by the Company, and not reflected in these financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

Investments reported at fair value consist of mutual funds and common/collective trusts. These investments are accounted for as follows:

*Mutual Funds:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

#### *Investments:* (continued)

*Common/Collective Trusts (CCTs):* The CCTs are composed primarily of fully benefit-responsive investment contracts units held in the CCTs are valued using the NAV practical expedient of the CCTs, as determined by the CCT issuers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of the CCTs is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCTs and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with these funds.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

#### *Fair Value Measurement:* (continued)

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The CCTs valued based on the NAV practical expedient are excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold or held during the year.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Party-In-Interest Transactions

Certain Plan investments include investment options managed by Fidelity. As Fidelity is the Plan trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### 5. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan has been amended since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 6. Subsequent Events

In April 2025, the Company acquired Chimerix, Inc. and intends to merge the assets of the Chimerix, Inc. 401(k) Profit Sharing Plan & Trust into the Plan by December 31, 2025.

Subsequent events have been evaluated through July 28, 2025, which is the date the financial statements were approved by the Plan and available to be issued.
