Opinion

We have audited the accompanying financial statements of Granite Group Insurance Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits and plan benefit obligations as of October 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits and plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for plan benefits and plan benefit obligations of the Plan as of October 31, 2024 and 2023, and the changes in net assets available for plan benefits and plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Opinion

1. Description of Plan

The following description of Granite Group Insurance Trust (the “Plan” or the “Trust”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined benefit plan providing health and other insured benefits to granite workshops. The Plan and related Trust were established November 1, 1947, pursuant to collective bargaining agreements between Granite Manufacturers and United Steelworkers AFL-CIO-CLC on behalf of Amalgamated Local #4 and the Granite Manufacturers and Granite Cutters Association. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees oversees governance of the Plan.

(b) Benefits

The Plan provides health benefits, (medical, vision, prescription drug and dental), life, short and long term disability insurances, and accidental death and disability coverage to employees and their covered dependents of participating employers. Retired employees are entitled to continue similar health coverage at their own expense and receive a paid up life insurance policy at retirement. Employees become eligible on the first of the month following 30 days of work.

The Plan fully insures the vision benefits, dental benefits and life insurance benefits. The Trust purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the general assets of the Trust.

All other Plan benefits are self-insured. The claims for self-insured benefits (other than short-term disability) are processed by the Plan’s third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Trust. Despite the Plan’s utilization of third-party claim’s processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan is self-insured for all medical costs up to \$200,000 per person per calendar year for active employees and their dependents. The Plan has purchased stop-loss insurance for claims per person in excess of \$200,000. Stop-loss recoveries totaled \$1,027,825 and \$1,887,655 for the years ended October 31, 2024 and 2023, respectively and are netted with claims paid in the statements of changes in net assets available for plan benefits.

(c) Contributions

Participating employers contribute premium payments for their covered employees based on rates established by the Plan's trustees. These rates are intended to cover all costs of premiums for active employees and all Trust expenses. Pursuant to the current collective bargaining agreements, participating employees contribute through payroll deductions a stated percentage of the cost of the medical insurance premium for the plan they participate in (family, single, or 2 person). Effective January 1, 2024, the Plan increased premiums by a range of 2% - 30%, due to increased claim rates.

(d) Other

The Trust may only be terminated by the collective bargaining agreement of the unanimous vote of the trustees, which include union representation, subject to the provisions set forth in ERISA.

2. Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for plan benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for plan benefits. Short-term disability payments are processed through the Trust's payroll system and paid from the general assets of the Trust.

(c) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates.

Summary of Significant Accounting Policies (continued)

(d) Accounts Receivable and Allowance for Uncollectible Accounts

Accounts receivable are recorded at the invoiced amount and do not bear interest on current accounts. They consist of balances due from companies and individuals for premiums. The balances for accounts receivable was \$8,488, \$21,640, and \$1,161 as of October 31, 2024, October 31, 2023, and November 1, 2022, respectively.

On November 1, 2023, the Plan adopted FASB ASU 2016-13, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which modifies the measurement of expected credit losses on certain financial instruments. The Plan adopted this new guidance utilizing the modified retrospective transition method. The adoption of this standard did not have a material impact on the Plan's financial statements but did change how the allowance for credit losses is determined.

The Plan's primary allowance for credit losses is the allowance for uncollectible accounts. The measurement of expected credit losses is based on relevant information about past events, including historical experience, current conditions, and reasonable and supportable forecasts that affect the collectability of the reported amount. Management uses judgment in determining the relevant information and estimation methods that are appropriate in its circumstances. Accounts receivable balances are written off against the allowance if a determination of collectability is made. At October 31, 2024 and 2023, the allowance for credit losses was \$0.

(e) Equipment

Equipment is recorded at cost. The Trust capitalizes equipment over \$2,500. Depreciation is provided using the straight-line method for financial reporting purposes at rates based on the estimated useful lives of the assets, which are 5-7 years for office furniture and equipment. As of October 31, 2024 and 2023, the Plan has fully depreciated office equipment with an original cost of \$17,322.

(f) Investment Valuation and Income Recognition

Investments are reported at fair value determined by the value listed on actively traded stock exchanges at year-end. Unrealized gains and losses are recognized as net change in fair value of investments in the statements of changes in net assets available for plan benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

(g) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Organization has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(h) Leases

In February 2016, the FASB issued ASU 2016-02, *Leases (Topic 842)*, which requires lessees to recognize leases on-balance sheet and disclose key information about leasing arrangements. The new standard establishes a right of use (ROU) model that requires a lessee to recognize a ROU asset and lease liability on the balance sheet for all leases with a term longer than 12 months. Leases will be classified as finance or operating, with classification affecting the pattern and classification of expense recognition in the statement of income.

Management has determined that adoption of ASU 842 is insignificant to the operations of the Trust at October 31, 2024. The Trust has recognized the lease disclosed in Note 7 under *Topic 840*. Under *Topic 840*, leases are expensed on a straight-line basis over the lease term.

(i) Premium Stabilization Reserve

The premium stabilization reserve is held at the Trust and is funded by monthly experience-rating credits (premiums paid minus claims paid, reserve adjustments and expenses). CIGNA and the Plan have agreed to use this as a reserve against which they can apply future losses in excess of current premiums. CIGNA operates on a calendar year and the Trustees determine the exact amount of reserve available for refund after the run-out of claims. The Plan provides employers with a premium holiday in January of the subsequent year based in part on this reserve. The premium holiday was calculated in the amount of \$(3,617,549) and \$(3,224,193) at October 31, 2024 and 2023, respectively. Premium holiday paid totaled \$0 for 2024 and 2023.

(j) Postretirement Benefits

The Plan has no postretirement benefit obligation.

(k) Other Benefits

Plan obligations at October 31, 2024 for claims incurred but not reported at that date have been estimated by management using current and historical data.

The Plan also offers a retiree payout benefit of \$4,000 each to all eligible retirees.

(l) Subsequent Events

The Plan has evaluated subsequent events through July 28, 2025, which is the date that the financial statements were available to be issued.

3. Tax Status

The Trust established under the Plan to hold the Plan's assets intended to qualify, pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, no provision for income tax is provided as Trust income is exempt from income taxes. The administrator has obtained a favorable tax determination letter from the Internal Revenue Service. The Trust has been amended since receiving the determination letter. However, the plan administrator believes that the Trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon the examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

The benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

5. Cash and Cash Equivalents / Concentration of Credit Risk

The Plan considers all highly liquid investments with original maturities of three months or less when purchased to be cash equivalents, except for those included in the investment portfolio.

Financial instruments that potentially subject the Plan to concentrations of credit risks consist principally of temporary cash investments. The Plan places its temporary cash investments with several financial institutions. At times, the balances in some of these accounts may be in excess of Federal Deposit Insurance Corporation (FDIC) limits of up to \$250,000 at any one financial institution. Management believes that no significant credit risks exists as a result of these balances.

6. Fair Value Measurements

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Cash and cash equivalents: Valued at cost.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.
