NOTE 1 - DESCRIPTION OF THE PLAN

Gainwell, Technologies, LLC (the “Company” or “Employer” or “Plan Sponsor”) sponsors the Gainwell Technologies 401(k) Plan (the “Plan”). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution Plan established to provide retirement benefits to the Company’s employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was incepted effective as of October 1, 2020, in connection with the sale of the Company to Milano Acquisition Corp. (“Milano”) from DXC Technology Company (“DXC”).

The Plan is administered by the 401(k) Plan Committee (the “Committee”), which is a committee appointed by the Company’s board of directors and is responsible for the operation and administration of the Plan and the management of the Plan’s assets. Fidelity Management Trust Company (the “Trustee”) serves as the trustee of the Plan and holds the Plan assets. Fidelity Workplace Services LLC (the “Recordkeeper”) serves as the recordkeeper of the Plan.

Participation

All full-time, part-time, casual or temporary eligible employees of the Company are eligible to participate upon the date they attain the age of 21. Any employee covered by a collective bargaining agreement, independent contractor, nonresident alien, employees who are actively participating in another qualified defined contribution Plan that is sponsored by a participating employer, and employees working on a visa are not eligible to participate in the Plan. An eligible employee who ceases to be an eligible employee and then later requalifies as an eligible employee will be immediately eligible to participate in the Plan upon requalifying as an eligible employee.

Contributions

Employees may make elective salary deferral contributions to the Plan in the amount of 1% to 50%, in whole number increments, of their compensation, as defined in the Plan document, not to exceed the maximum amount allowable under the Internal Revenue Code (“IRC”). Participants are automatically enrolled in the Plan at a deferral percentage rate of 3% of compensation unless they affirmatively elect to not participate in the automatic contribution arrangement. This percentage is automatically increased by 1% on the one-year anniversary of the automatic enrollment date up to 10% which continues at this rate until changed by the employee.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of rollover funds from another qualified Plan. After tax contributions are not permitted.

The Company makes matching contributions of 50% of the first 6% of the employee’s deferral contribution. The matching contributions are paid in the year following the end of the Plan year and eligible participants must be employed as of December 31 to receive a matching contribution.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Employer's matching contribution (as defined in the Plan document), rollovers, and applicable earnings or losses on investments. Participant accounts are charged with an allocation of administrative expenses as determined by the Committee, if any as defined in the Plan document.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are vested in the Employer matching contribution after completion of one year of service.

Forfeitures

Forfeitures arising during the Plan year may be used to reduce Employer matching contributions, to restore amounts previously forfeited, used for corrective allocations, or used to pay administrative expenses. Forfeitures of terminated non-vested participant accounts in the amount of \$67,775 for the year ended December 31, 2024 were used to offset expenses. For the year ended December 31, 2023, \$90,017 was used to reduce Employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,001 and \$111,232, respectively.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12-month period, or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Participants may have only one loan outstanding at any given time. Terms range from one to five years or up to 15 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of death, may elect to receive a single lump-sum amount or a series of installment payments equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances that do not exceed \$1,000. Distributions above \$1,000 but that do not exceed \$7,000 are rolled into an individual retirement account designated by the Committee. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Administrative Expenses

Administrative costs of the Plan may be paid by the Company at its discretion or, alternatively, may be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses of the Plan include investment management fees and operating expenses. Administrative expenses charged to the Plan for investments are reflected as a reduction of investment return for such investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Loans are deemed distributions once they are in default and recorded as distributions.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification 820, *Fair Value Measurement* (“ASC 820”), establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts - The fair values for non-publicly traded funds are determined using the NAV provided by the administrator of the fund, as a practical expedient to estimate fair value. The collective trusts provide for daily redemptions by the Plan at reported NAV per share, with no advance notice requirement. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan are paid by the Plan or by the Company. The Plan also has notes receivable from certain of its participants. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated December 9, 2021, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. No such positions were noted at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported on the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan administrator has evaluated for disclosure subsequent events through July 31, 2025, the date the financial statements were available to be issued.

The Plan administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
