Note 1. Description of the Plan

General

The following brief description of the Kreg Enterprises, Inc., d/b/a Kreg Tool Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Kreg Enterprises, Inc., d/b/a Kreg Tool Company (the Company and the Plan Administrator). Employees are eligible to make salary deferral contributions to the Plan once they have reached 21 years of age and have completed 30 days of service. Plan entry is available the first day of each month after the employee becomes eligible. To be eligible for employer discretionary matching or other non-elective contributions, employees must complete one year of service as defined by the Agreement, reached 21 years of age, and be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee of the Plan.

Contributions

Each year, participants may contribute up to 100% of compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan contains an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 6% of eligible compensation and the deferral rate will annually increase by 1% of eligible compensation up to a maximum of 10% unless the participant designates otherwise. Automatically-enrolled participants will have their contributions invested in a designated balanced fund until changed by the participant.

The Company may make a discretionary contribution and discretionary other non-elective contributions as determined by the Company. For the years ended December 31, 2024 and 2023, discretionary contributions of 3% and 0% of eligible compensation were made, respectively. Contributions are subject to certain IRS limitations.

Participant Investment Account Options

Participants can direct the investment of their contributions and any employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and common collective trust funds. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, allocations of the Company's discretionary non-elective contributions, Plan earnings (losses), and an allocation of administrative expenses. Allocations are based on participant earnings account balances or specific participant transactions as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus any earnings (losses) thereon. Vesting in the Company's discretionary matching contributions, discretionary other non-elective contributions, and Plan earnings (losses), thereon, is based on years of continuous service. A participant is 20% vested after two years of service, as defined, and continues to vest 20% each consecutive year until 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the prior twelve-month period ending on the day before the loan is made or 50% of their vested account balance reduced by any outstanding loan balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan account. Loan terms may vary based on the reason for the loan. The loans are secured by the participant's account and bear a reasonable rate of interest based on prevailing interest rates, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Loans outstanding at December 31, 2024 bear interest at rates ranging from 5.25% to 10.50% and are due through June 2029.

Payment of Benefits

On termination of service, death, disability, or election to receive benefits upon reaching retirement age, participants with vested balances greater than \$5,000 may elect to receive a lump sum amount equal to the value of his or her account or may choose from optional forms of payment available under the Plan. Participants with a vested balance of \$5,000 or less will receive a lump sum distribution.

Forfeited Accounts

Forfeitures of non-vested accounts may be used to pay Plan administrative expenses or to reduce employer contributions to the Plan. During the years ended December 31, 2024 and 2023, approximately \$0 and \$17, respectively, of forfeitures were used to pay Plan administrative expenses. As of December 31, 2024 and 2023, the Plan had \$0 of forfeited non-vested account balances.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on net earnings.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

Mutual funds and pooled separate accounts (PSAs) are valued at net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in common collective trusts is valued at the NAV of shares held by the Plan at year end based on share value using the audited financial statements of the collective trust at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative functions are performed by the Company. Certain other administrative expenses are paid directly by the Plan.

Note 3. Certification of Plan Trustee

The Retirement Plan Committee has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5. Plan Amendments

Effective August 12, 2024, the Plan was amended to change the Plan to a safe harbor plan for the 2024 plan year.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Principal Financial Group. The prototype plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Trustee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. As such, the Plan Trustee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Related-Party and Party-in-Interest Transactions

At December 31, 2024, certain Plan investments are shares of pooled separate accounts and collective investment trusts managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Principal Trust Company is the record keeper and administrator as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, a participant who acquires a participant loan is a party-in-interest. However, these transactions are exempt from the prohibited transaction rules of ERISA.

Note 10. Subsequent Events

Effective January 1, 2025, the Plan was amended to raise the maximum auto increase of employee contributions from 10% to 15%.

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.
